1.1 Correctional Services contributes to the development of law, promotes the rule of law, and ensures public affairs are administered in accordance with the law. Policy and procedures are enabled by legislation. Staff, when performing their duties, are governed by legislation.

#### 3. Personnel Regulations and the Code of Professional Conduct

- 3.1 The regulations for the Personnel and *Code of Professional Conduct* are established in sections 5 through 20 of the *Correctional Services Regulations*.
- 3.2 These regulations are consistent with the Government of Nova Scotia Code of Conduct for Civil Servants, whish was approved by Executive Council and implemented September 1, 2000.
- 3.3 The Personnel regulations and the Code of Professional Conduct are reproduced in a booklet and issued to employees upon commencing employment with Correctional Services, and whenever it is updated. The current booklet is also available on the Correctional Services website.
