1. Policy

1.1 It is the policy of Correctional Services to recover costs for eligible expenditures in accordance with the Agreement respecting Federal Contributions to the Intensive Rehabilitative Custody and Supervision Program (IRCS).

2. Procedures

- 2.1 Expenditures for IRCS treatment, assessment, rehabilitative and other services are recoverable through a Federal/Provincial cost-sharing agreement.
- 2.2 The Manager, Correctional Services will ensure detailed records are retained for all expenditures.
- 2.3 Programs and services eligible for IRCS funding include
 - 2.3.1 reports and assessments
 - 2.3.2 clinical treatment programs designed for particular types of young persons (YP), such as sexual or violent offenders
 - 2.3.3 psychological and psychiatric services
 - 2.3.4 specialized education programs
 - 2.3.5 social skills programs
 - 2.3.6 intensive support and supervision programs
 - 2.3.7 substance abuse counselling and assessments
 - 2.3.8 cognitive and behavioural programs
 - 2.3.9 anger management therapy
 - 2.3.10 culturally or gender specific programming or counselling
 - 2.3.11 pastoral counselling
 - 2.3.12 vocational and employment training and programs
 - 2.3.13 residential treatment
 - 2.3.14 reintegration services, non-custodial residential services that involve supervision and the provision of rehabilitative services
 - 2.3.15 independent residential and living allowances, to a maximum of \$35.00 per eligible day
 - 2.3.16 travel and living expenses to facilitate reintegration, to a maximum of \$35.00 per eligible day

- 2.3.18 programs and supports that are designed to provide appropriate levels of support and supervision in the community
- 2.3.19 attendance programs
- 2.3.20 conferencing
- 2.3.21 any additional program or service agreed upon by the Province and the Federal Government
- 2.4 The Manager, Correctional Services will ensure all requested documentation and reports are submitted annually to Justice Canada for the purpose of obtaining eligible cost recovery.
