

## HIDE DEALER LICENCE: APPLICATION/RENEWAL FORM

A Hide Dealer Licence is valid for one year (April 1 – March 31 of following year).

Persons applying for a Hide Dealer Licence must possess a valid Nova Scotia Wildlife Resources Card (WRC). Information on how to obtain a WRC is available online at: <a href="http://novascotia.ca/natr/hunt/">http://novascotia.ca/natr/hunt/</a> or by contacting your local Department of Natural Resources & Renewables office.

The fee for a Hide Dealer Licence is \$14.35 (includes HST) which may be paid by credit card or by cheque or money order, made payable to the **Minister of Finance**. The licence fee is subject to change, without notice, after March 31 each year.
