Week 5 (January 31 to February 6, 2016)*

IN SUMMARY...

Activity levels**

Northern (Zone 2) is reporting sporadic activity. Central (Zone 4) is reporting localized activity.

Laboratory-confirmed cases***

- There were 9 influenza cases reported this week. There have been 24 lab confirmed cases of influenza this season (1 influenza A H3 and 23 influenza A not subtyped).
- Positive test results were received for adenovirus, parainfluenza, pertussis and RSV.

Severity


 There has been 1 ICU admission of laboratory confirmed influenza and 2 influenza death**** for the 2015-2016 influenza season.

Syndromic surveillance

- The ILI rate for Nova Scotia this reporting period was 1.0.
- 100% of emergency departments reported ILI data for this period.






Figure 3: RSV cases by age group, cumulative 2015-2016 season, Nova Scotia.

Figure 4: Percentage of emergency room visits due to ILI by week, 2015-2016 season, with trend-line comparison to 2014-2015, Nova Scotia.



ILI CASE DEFINITION

Acute onset of respiratory illness with fever and cough and with one or more of the following – sore throat, arthralgia, myalgia or prostration which is likely due to influenza. In children under 5, gastrointestinal symptoms may also be present. In patients under 5 or 65 and older, fever may not be prominent.

OUTBREAK DEFINITIONS

Schools and daycares	Greater than 10% absenteeism (or absenteeism that is higher (e.g. >5-10%) than
	expected level as determined by the school or public health authority) which is likely
	due to ILI.
Hospitals and	Two or more cases of ILI within a seven-day period, including at least one laboratory
residential institutions	confirmed case. Institutional outbreaks should be reported within 24 hours of
	identification. Residential institutions include, but are not limited to, long-term care
	facilities (LTCF) and prisons.
Other settings	Two or more cases of ILI within a seven-day period, including at least one laboratory
	confirmed case (i.e. closed communities).
