AND WE, being desirous and resolved as soon as may be to meet Our People of Our Province of Nova Scotia, and to have their advice in General Assembly, do hereby make known Our Royal Will and Pleasure to call a General Assembly, and do hereby further declare that by and with the advice of Our said Executive Council, We have this day given orders for the issuing of Our Writs in due form for the election of Members to serve in the House of Assembly for several Electoral Districts of the Province, which Writs are to bear date the 30<sup>th</sup> day of April 2017, and the date of election day to be Tuesday, the 30<sup>th</sup> of May, 2017.
