ORDER IN COUNCIL 2022-96
Dated March 29, 2022

The Governor in Council on the report and recommendation of the Premier and Minister of Intergovernmental Affairs dated March 18, 2022, and pursuant to Section 2 of Chapter 256 of the Revised Statutes of Nova Scotia, 1989, the *Lieutenant Governor and Great Seal Act*, Section 65 of Chapter 376 of the Revised Statutes of Nova Scotia, 1989, the *Public Service Act*, and the prerogative authority of the Governor in Council to use a legal instrument, such as a letters patent issued under the Great Seal of Nova Scotia, to grant an honorary distinction to a person, is pleased, effective March 29, 2022, to request the concurrence of the Lieutenant Governor on behalf of Her Majesty the Queen to be indicated by the affixing of his signature to the letters patent, and to order that the letters patent in Schedule "A" attached to and forming part of this Report and Recommendation be issued under the Great Seal of the Province of Nova Scotia, to:

- (a) create a medal designated as The Queen Elizabeth II's Platinum Jubilee Medal (Nova Scotia) in the form and style set out in the letters patent;
- (b) make new rules respecting the administration of, eligibility for, and allocation of The Queen Elizabeth II's Platinum Jubilee Medal (Nova Scotia) in the manner set forth in the letters patent;
- (c) specify that the rules made in clause (b) are subject to any amendments or repeal by future letters patent; and
- (d) apply to the Government of Canada to have The Queen Elizabeth II's Platinum Jubilee Medal (Nova Scotia) recognized and included in the (Canadian) *Order of Precedence for Wearing Canadian Orders, Decorations and Medals*.

To All to Whom this may concern,

Greeting :

WHEREAS the Government of Nova Scotia desires that a medal be created to mark the seventieth (70th) anniversary of Her Majesty Queen Elizabeth II's accession to the throne as Queen of Canada;

We, with the advice and concurrence of Executive Council for the Province of Nova Scotia by Order in Council, do create a medal to be designated The Queen Elizabeth II's Platinum Jubilee Medal (Nova Scotia) and made in the form and style set out in these letters patent.

And further We direct that this medal shall be governed by The Queen Elizabeth II's Platinum Jubilee Medal (Nova Scotia) Rules in the manner set forth in these letters patent, and as may be amended or repealed by future letters patent issued on the advice of the Governor-in-Council.

IN TESTIMONY WHEREOF We have caused these our Letters to be made Patent, the Great Seal of Nova Scotia to be affixed, and signed by the Lieutenant Governor on behalf of Her Majesty.

WITNESS, Our Trusty and Well Beloved, Arthur J. LeBlanc, Chancellor of Our Order of Nova Scotia, one of Our Counsel Learned in the Law, Lieutenant Governor in and of Our Province of Nova Scotia.

At Our Government House in the Halifax Regional Municipality this 29th day of March in the year of our Lord Two Thousand and Twenty-Two in the seventy-first year of Her Majesty's Reign.

The Queen Elizabeth II's Platinum Jubilee Medal (Nova Scotia) Rules**1 Citation**

These rules may be referred to as *The Queen Elizabeth II's Platinum Jubilee Medal (Nova Scotia) Rules*.

2 Definitions

In these rules,

"medal" means the Queen Elizabeth II's Platinum Jubilee Medal (Nova Scotia);

"members of the Table of Precedence for Nova Scotia" means all of the following:

- (i) the Lieutenant Governor of Nova Scotia,
- (ii) the Premier of Nova Scotia,
- (iii) the Chief Justice of Nova Scotia,
- (iv) former Lieutenant Governors,
- (v) former Premiers,
- (vi) the Speaker of the Nova Scotia House of Assembly,
- (vii) the Members of the Executive Council of Nova Scotia,
- (viii) the Leader of the Opposition,
- (ix) the Members of the Queen's Privy Council for Canada who are resident in Nova Scotia,
- (x) the Members of the Federal Cabinet who represents the Province of Nova Scotia,
- (xi) the Chief Justice of the Supreme Court of Nova Scotia,
- (xii) the Associate Chief Justice of the Supreme Court of Nova Scotia,
- (xiii) the Associate Chief Justice of the Supreme Court of Nova Scotia (Family Division),
- (xiv) the Justices of the Nova Scotia Court of Appeal,
- (xvi) the Justices of the Supreme Court of Nova Scotia,
- (xvii) a Chief Judge of the Provincial or Family Courts of Nova Scotia,
- (xviii) the Associate Chief Judge of the Provincial Court of Nova Scotia,
- (xix) the Judges of the Provincial Court of Nova Scotia,
- (xx) an Associate Chief Judge of the Family Court of Nova Scotia,
- (xxi) the Judges of the Family Court of Nova Scotia,
- (xxii) the Leader of the Third Party,
- (xxiii) the Members of the Legislative Assembly of Nova Scotia,

- (xxix) the Members of the Senate who represent the Province of Nova Scotia,
- (xxx) the Members of the House of Commons who represent the Province of Nova Scotia,
- (xxxix) the Bishop of the Anglican Diocese of Nova Scotia and Prince Edward Island,
- (xxxixii) the Archbishop of the Catholic Archdiocese of Halifax-Yarmouth,
- (xxxixiii) the Leaders of the Faith Communities in Nova Scotia,
- (xxxixiv) the Mayor of the Halifax Regional Municipality,
- (xxxixv) the Commander of the Maritime Forces Atlantic and the Joint Task Force Atlantic,
- (xxxixvi) the Commander, 5th Canadian Division,
- (xxxixvii) the Assistant Commissioner, "H" Division, Royal Canadian Mounted Police.

3 Description

- (1) The medal will
 - (a) be circular in form, silver-coloured and 32 mm in diameter, with a claw footed suspender and suspension ring;
 - (b) bear
 - (i) on the obverse, the contemporary crowned effigy of Her Majesty the Queen of Canada, facing to the sinister, and circumscribed with the inscriptions "ELIZABETH II DEI GRATIA REGINA" and "CANADA", separated by two maple leaves, and
 - (ii) on the reverse, the shield of arms of the Province of Nova Scotia, surmounted by the Royal Cypher, with a single mayflower on each side of the shield of arms, the upper portion circumscribed by the dates "1952" and "2022", and in the base the phrase "VIVAT REGINA"; and
 - (c) be suspended from a ribbon 32 mm in width with a white stripe in the centre, 2 mm in width, on each side of which are red stripes, 3 mm in width, followed by white stripes, 10 mm in width and garter blue edge stripes, 2 mm in width.

4 Eligibility

- (1) A person is eligible to be awarded the medal if the person meets all of the following criteria:
 - (a) is a resident of Nova Scotia or has a tangible link to Nova Scotia, at the time of the grant of the medal;
 - (b) has made a significant contribution to Canada, Nova Scotia or to a particular Nova Scotian region or community;
 - (c) was alive on February 6, 2022, the seventieth anniversary of Her Majesty's accession to the throne.
- (2) Despite subsection (1), a person in a category of persons set out in column 1 of items 1 or 10 of the Appendix "A", attached to and forming part of the rules, and who was alive on February 6, 2022 is eligible to be awarded the medal.

5 Nomination Procedure

- (1) A nomination of an eligible person for a category of persons listed as an item under column 1 in Appendix "A" may be submitted by the identified person or allocating office for that item as provided in column 3.
- (2) A nomination of an eligible person may also be submitted by a member of the public.
- (3) A nomination in subsections (1) or (2) must be submitted to the Department of Intergovernmental Affairs, Protocol and Honours Secretariat, for consideration.

6 The Lieutenant Governor will sign an instrument of award to a nominated person who is selected for the medal.

7 Exceptional Award

Despite Sections 4 and 5, the Lieutenant Governor may also authorize the award of a medal to a person if the Lieutenant Governor is satisfied that is supported by the exceptional circumstances that apply.

8 Presentation

Unless the Lieutenant Governor directs otherwise, the medal to be awarded to a person selected for a category of persons set out in column 1 of Appendix "A" will be forwarded to the identified person or allocating office, for that item as set out in column 3, for presentation to the person selected.

9 Wearing of Medal

A person to whom the medal has been awarded may wear a miniature version of the medal on all occasions when the wearing of miniatures is customary.

10 Administration

The Executive Director for the Protocol and Honours Secretariat of the Department of Intergovernmental Affairs, will

- (a) prepare the instruments of award for the signature of the Lieutenant Governor;
- (b) acquire the medals;
- (c) maintain a register containing the names of the persons to whom a medal is awarded;
- (d) within one calendar year of the programs conclusion, ensure that a complete online version of the register of the names of the person who the medal was awarded is available to the public; and
- (e) perform such other functions in respect of awards of the medal as the Governor-in-Council may direct.

11 Cancellation and Reinstatement

- (1) The Lieutenant Governor may, on the recommendation of the Executive Director for the Protocol and Honours Secretariat with the reason provided:
 - (a) cancel the award of the medal to any person; or
 - (b) restore the award of a medal that has been cancelled under clause (a).

12 General

Nothing in these rules limits the right of the Governor-in-Council or the Lieutenant Governor to exercise all existing powers and authorities of Her Majesty the Queen in Right of the Province in respect of awarding of a medal.

Summary of Application: The purpose of the project is to determine the technical feasibility, growth rates, survivability percentages and the habitat suitability to grow American oysters in the Minas Basin. To conduct this experiment, the applicant has proposed to use Vexar oyster bags in a cage directly on the bottom of the ocean floor. The area is identified by the Canadian Shellfish Sanitization Program (CSSP) as “unclassified” so no product will be sold from the site or consumed without the required authorizations.
