Farm Investment Fund - Program Review - Survey

The Department of Agriculture has engaged the Internal Audit and Risk Management Centre of the Nova Scotia Department of Finance and KPMG, a business advisory firm, to conduct a review of the Agriculture Farm Investment Fund (FIF) program.

As a part of this review, we would like producers' to tell us what is working well, what is not working well with the current program, the concerns they may have, and opportunities for improvement. The review includes a survey, two focus group sessions with farmers, interviews with commodity associations and the Federation's Council of Leaders.

In the latter part of February, a survey will be mailed to registered Nova Scotia farm operations, both users and non-users of FIF. The survey will include questions regarding the program objectives, guidelines, eligibility, access to funding, funding percentages, overall perceived value, and the user friendliness of the process. We ask you to complete the survey and welcome your input and assistance.

Canada's New Government Takes New Steps to Protect the Environment with Biofuels

On December 20, 2006, Canada's New Government announced it would regulate the use of renewable fuels in Canada and deliver \$345 million to assist farmers and rural communities seize new market opportunities in the agricultural bioproducts sector.

The government announced it would regulate an annual average renewable content of five per cent in gasoline by 2010. The government intends to regulate a two per cent requirement for renewable content in diesel fuel and heating oil by 2012.

Honourable Rona Ambrose, former Minister of the Environment stated "Our Government understands Canadians' concerns around the quality of the air we breathe. We know that cleaner fuel means less pollution. Requiring the use of

renewable fuels fulfills a commitment by our government. Through these regulations, we are keeping with our approach toward meaningful action, and we will ensure that our objectives are met."

The Honourable Chuck Strahl, Minister of Agriculture and Agri-Food and Minister for the Canadian Wheat Board, announced two agriculture programs that will help bolster the development of biofuels and other bioproducts. The Agricultural Bioproducts Innovation Program and the Capital Formation Assistance Program for Renewable Fuels Production are designed to create new market opportunities for Canada's agricultural producers.

Of the \$345 million:
- \$200 million through the Capital Formation Assistance Program for Renewable Fuels Production will provide producers with incentives for participation in new renewable fuels production capacity; and

- \$145 million through the Agricultural Bioproducts Innovation Program will provide support for cross-sector research networks conducting scientific research and development related to the advancement of a Canadian bio-based economy.

Biofuels are a renewable energy source produced from organic materials. Bioproducts are manufactured from renewable resources such as agricultural crops and organic residual matter. They include products such as biofuels, biofibres and biopharmaceuticals.

Carrot Production in Silico

The Nova Scotia Agricultural College (NSAC) is pleased to announce the creation of a new project in Agroinformatics. The project, being led by Dr. Raj Lada with the Department of Plant and Animal Sciences, intends to develop a computer modeling system for the carrot industry. This is a four-year initiative that is supported by Agriculture and Agri-Food Canada through Advancing Canadian Agriculture and Agri-Food (ACAAF) councils and sponsored by Oxford Frozen Foods Limited. Alberta, New Brunswick, Newfoundland and Labrador, Nova Scotia, Prince Edward Island and ACAAf councils, are funding this initiative.

The project proposes to develop a computer-based modeling and decision making tool that can project the greatest economic return for carrot production, optimizing production and processing systems while delivering high quality carrots on an environmentally sustainable basis. The model will take into account the economic, production, environmental and food safety variables that can influence the value of a carrot crop, both pre-harvest and post-harvest.

"This program is the first of its kind to integrate crop production, processing, physiological biology, computational biology and software engineering," said Dr. Lada, Project Director. "Both ACAAf and Oxford Frozen Foods Limited recognize the benefits of this research as being vital to the future growth of the processing carrot industry."

Oxford Frozen Foods Limited is a major supplier of processed carrot products to the North American food industry. The company indicates that the results of the research promise to provide improved management capabilities, such as field planning, auditing, budgeting, production management, on-farm food safety and market planning.

"This research represents another example of how NSAC's state-of-the-art research pushes the limits of innovation and practicality to benefit the agricultural industry," said NSAC President Dr. T. Philip Hicks. "I am proud of all of our cutting-edge faculty members who compete successfully with the best in the world for the means to advance knowledge."

Canadian Agricultural Income Stabilization (CAIS) Program Payments and Processing

The 2005 processing is 77 per cent complete and 2006 processing is underway. Files are processed on a first in-first out basis. By submitting your 2006 CAIS Harmonized Statement of Farming Activities now, you will be at the front of the line for the 2006 program year. Please remember it is EXTREMELY important to look over your Calculation of Benefits (COB) for errors when you receive it. You have 90 days from the date on the COB to make adjustments and appeals to the CAIS Administration. If you require assistance, please call the Programs and Business Risk Management number below.

CAIS FEE Deadline - APRIL 30, 2007

The deadline to pay the fee amount was December 31, 2006 for the 2006 CAIS program year. If you have not yet paid the fee, you may still participate. Participants have until April 30, 2007 to pay with penalty (FEE + 20 per cent). The fee is now owing if you did not officially opt out of the 2006 CAIS program year by September 30, 2006.

Programs Update:

The Nova Scotia Margin Enhancement (NSME)

program is one element of a three-point funding initiative announced by Agriculture Minister Brooke Taylor in December 2006. It will assist the agricultural industry impacted by declining incomes and rising debt loads.

Payments are based on a 10 per cent increase of the reference margin used to calculate the 2003 Canadian Agricultural Income Stabilization program payments. Eligibility is restricted to non-supply managed sectors.

If you are a producer of a non-supply managed commodity, are currently actively farming and received a CAIS payment in 2003 you should have been contacted by the Programs and Business Risk Management office regarding your NSME payment eligibility. 2007 CAIS Sign up Deadline Is Rapidly Approaching

The 2007 CAIS program year is unique in that sign up will occur before the crop year begins. Those who previously participated will be enrolled automatically. The deadline to sign-up and pay the fee for participating in the 2007 year is April 30, 2007. Those who do not wish to participate in the 2007 program year must let the CAIS Administration know by April 30, 2007, or it will be assumed you wish to participate and the fee will be charged.

Note: The deadline to pay the fee for both the 2006 and 2007 program year is April 30, 2007.

Research at NSAC

It's a good thing that Andy Vanderzaag has a sense of humour, because his research tends to get a bit messy. Working with waste water is not always pleasant, but for Andy's research it's all part of a day's work. Andy collects waste water (liquid manure) from farms and runoff from fields. High levels of nutrients and pathogens found in agricultural waste water has the potential to cause water quality issues. For example, excess nutrients can lead to algal blooms that can make the water unsuitable for drinking or recreational activities.

Andy and his supervisor are looking at the possibility of using wetlands as filters for farm waste water and runoff. They have built test wetlands that will help the plants, soil plus energy from the sun work together to trap and kill the pathogens and filter out nutrients. Andy describes the two types of wetlands they have created, to act as giant filters: one has soil and cattails

as a base, while the other has a gravel base. These two standard types of wetlands are used in any treatment experiment. These small-scale wetlands are built in greenhouses to control and monitor air flow. With specialized equipment, Andy is able to analyze the concentration of greenhouse gases more frequently than in previous studies. Greenhouse gases are being monitored for six wetlands (three soil-based and three gravel-based) as often as every four seconds for an entire year. This gives him the advantage of closely monitoring the two types of wetlands and looking at the variability within each. Andy is hoping to see which type of wetland is more efficient at treating waste water and if the two systems produce different amounts of greenhouse gases. With the answers to both of these questions, it will be clear as to which system has a better 'overall' environmental effect.

The benefits of Andy's research could potentially reach a very large audience. Ideally, he wants to remove contaminants from the water while releasing as few greenhouse gases as possible. The agricultural benefits of treating waste water could help to eventually mitigate greenhouse gases and help reduce the impact of climate change.

Equipment Calibration Services Provided Through EFP

The goal of the Nova Scotia Environmental Farm Plan (EFP) Program is to assist farmers in identifying potential areas of environmental risk and provide practical solutions to minimize these risks. The utilization of farm chemicals and manure in production systems can increase on-farm environmental risk. Therefore, part of the EFP Program over the past few years has been to provide assistance to farmers in calibrating application equipment (i.e. pesticide sprayer, fertilizer and manure spreaders).

A few important issues regarding the calibration of farm equipment include:

Pesticide Sprayer Calibration

1. Pesticide application equipment should be calibrated annually. Growers using large quantities of wettable powders should re-calibrate sprayers more frequently as these products can cause extreme wear to the sprayer nozzles.

2. It is essential to know the size of fields being sprayed to prevent excess chemical mixture remaining in the sprayer. This may pose a problem with disposal of the chemical.

Manure Spreader Calibration

1. Manure spreader calibration takes only a couple of hours and is an essential component of completing a Nutrient Management Plan (NMP).

2. An accurate NMP requires collecting a manure sample for analysis. It is important that liquid storages are completely agitated in order to get a representative manure sample. With solid manure storages, samples should be taken from various areas of the storage and then mixed together. A sample of this composite mixture should be analyzed.

3. Manure samples should be taken and analyzed at least once every three years or more frequently if a change occurs in: i) feed ration, ii) method of storing the manure, or iii) type of bedding and/or waste feed added to the manure.

4. Analyzing manure and having the spreader accurately calibrated will result in better nutrient utilization and may reduce chemical fertilizer requirements.

Fertilizer Spreader Calibration

1. When spreading fertilizer, it is very important to operate the tractor at the correct PTO speed and operate the spreader at the correct height above the crop as suggested by the manufacture.

2. Spreader components must be kept in good condition. Worn or damaged parts can result in the fracture of the fertilizer particles and an uneven spread pattern. This will result in heavy and light areas of application from each pass.

Again this year the EFP Program will be providing assistance with calibrating application equipment. With spring approaching, farmers should consider accessing this service by contacting Rick Hoeg at (902) 893-6577 (office) or (902) 890-1894 (cell).

Pesticide Vendor Certification

The Nova Scotia Department of Environment and Labour requires that all businesses that sell commercial or restricted class pesticides, or sell the service of applying these pesticides require a Business Operator Certification. All employees of the business who use or sell commercial or restricted class pesticides must also be certified.

This new course will cover the

basic principles and practices of safe use, handling and storage of pesticides. Course content ranges from integrated pest management principles to calibrations and calculations. Aerial spraying techniques are not covered. Course material will prepare participants to write the pesticide applicator exam, which is scheduled on the last day of the course.

Scholarships Available For 4-H Members

Young people can gain more than confidence, technical skills and friendship from the 4-H program. 4-H members who are 16 years of age and have been a 4-H member for at least two years may apply to win six university entrance scholarships.

Presently 4-H members may apply for scholarships from the Nova Scotia Department of Agriculture, the Nova Scotia 4-H Council and the TD Bank. Each scholarship has specific requirements and the two Nova Scotia scholarships require an essay to be submitted with their completed application form. The essays are judged for style, subject knowledge, originality, quality and interpretation of research, as well as spelling and

grammar. Scholarships range from \$1000 to \$2000.

Members are encouraged to speak to their General 4-H Leader or their 4-H Specialist to make sure they get a copy of the application forms. Canadian Nutrition Labeling Workshops

The Canadian Food Inspection Agency, Agriculture and Agri-Food Canada, Nova Scotia Department of Agriculture, Nova Scotia Fish Packers Association and Taste of Nova Scotia Quality Food Program are delivering two different workshops on Canadian Nutrition Labelling.

The introductory workshop to Canadian Nutrition Labelling is intended for those food producers, importers, and retailers that sell products within Canada. Persons involved in creating labels are also invited to attend. It will cover the following topics: Transition period for compliance, exemptions to nutrition facts labelling, components of a nutrition facts table (core information and nutrients), nutrient claims, diet related health claims, biological role claims, available display surface, and how to select an appropriate nutrition facts table using the hierarchy of tables.

The Canadian Nutrition Labelling Claims workshop is intended to provide information on claims that are now permitted on foods, and will build on the information

covered in the Introductory Nutrition Labelling workshop (nutrient content claims, quantitative claims, biological role claims and diet related health claims). Requirements for making these claims, including the conditions that the food has to meet, the conditions that need to be met in order to make written claims in advertising, will be discussed.

All food manufacturers, importers, retailers and others that are involved in selling food products or creating labels for foods in Canada are invited to attend any session.

Pesticide Recertification Training, ProAgri Consulting Ltd.

This course is eligible for five points under the Nova Scotia Department of Environment and Labour pesticide re-certification program.

Pesticide recertification is a great opportunity for license holders to improve on their pesticide safety knowledge, keep current with changes to legislation and avoid having to write another pesticide exam. This course is designed for those individuals who have a current license and would like to accumulate recertification points towards their license. Individuals complete five hours of pesticide safety course topics and are issued recertification points, one point for each hour of training. These recertification points (maximum five per year) are accumulated over a number of years through training courses and this process takes three to five years to complete. Please check the expiry date on your NSDEL Pesticide Certification card before making a final decision to earn recertification points. Example: if your license expires in 2009 and

you have not collected any points to date then you would be unable to collect all the points needed by the expiry date)

The cost for the course is \$75 including HST (pay on the day). Participants are asked to bring a calculator, pencil/pen and their current pesticide license. Pre-registration is required by calling Sarah or Traci at ProAgri Consulting 902-798-2114. This is going to be a great course, hope to see you there.

First Aid for Farm Families

Farming is a hazardous occupation. Dealing with heavy equipment and unpredictable animals while situated in a remote location increases the likelihood of injury and can present unique challenges to a rescuer who is first on the scene.

ActiveLife Adventure and Training, in conjunction with the Canadian Red Cross, is offering Emergency First Aid training customized for farm families.

The course provides excellent training for individuals who reside/ work in farming or rural communities. Offered in one day (approx. 8 hrs), it covers basic first aid skills and addresses hazards unique to farming.
