Atlantic Agricultural Hall of Fame Inducts New Members

Frank Berkelaar of Harmony, Colchester Co., was inducted into the Atlantic Agricultural Hall of Fame on October 23, at the Nova Scotia Agricultural College in Bible Hill, NS.

Mr. Berkelaar immigrated to Canada from Holland in 1953. At age 19, he started working at the Truro Livestock Auction at the Truro Exhibition Grounds, which later became the Maritime Cattle Market.

In 1974, Mr. Berkelaar purchased the Maritime Cattle Market. He expanded services to include sales of all farm animals, machinery, hay and milk quota.

"Mr. Berkelaar is known and respected throughout North America as a businessman who built a successful market," said Brooke Taylor, Minister of Agriculture. "He believes that everyone involved in a sale must have a fair return, and worked hard to ensure this objective."

Mr. Berkelaar was also involved in other businesses, including operating a farm with his brother that produced cattle and crops. He provided auctioneer services to a number of organizations, such as the 4-H program. In April 2001, he became

an honorary member of the Nova Scotia Institute of Agrologist's for his commitment to the agriculture industry.

"Mr. Berkelaar is a well-respected voice for the livestock industry and has readily shared his knowledge with others," said Mr. Taylor. "He also served on the ministerial task force for the beef industry in the mid-1990's and helped with policy development."

Through the Maritime Cattle Market, Mr. Berkelaar provided credit to buyers during the BSE (also known as mad cow disease) situation, so markets and prices were maintained for local farmers selling cattle.

The Nova Scotia Federation of Agriculture nominated Mr. Berkelaar for his lifelong commitment to the agricultural industry.

Other Atlantic provinces' inductees are Ronald Piper of New Brunswick; Eugene Legge of Newfoundland and Labrador; and Donald MacKenzie of Prince Edward Island.

The Atlantic Agricultural Hall of Fame honours members of the agricultural community for outstanding contributions to the industry, community and farm organizations.

Province Invests in Bringing Local Foods to Consumers

New funding will make it easier and more convenient to buy local foods in Nova Scotia.

Agriculture Minister Brooke Taylor announced on December 5, that \$2.3 million over three years will support the development of the local food systems, which includes everything from farmers to consumers, and improve access to local foods for consumers throughout the province.

The investment will target strategic infrastructure and development initiatives that will enhance industry competitiveness, market access and direct marketing methods.

"Local food systems are an exciting and rapidly evolving sector," said Mr. Taylor, "This funding will develop the roots between rural and urban food systems, and support marketing initiatives."

This investment will complement the province's food marketing programs, Select Nova Scotia and Taste of Nova Scotia, in promoting the variety and quality of food Nova Scotia has to offer.

Nova Scotia's agri-food sector contributed an estimated \$904 million to the provincial gross domestic product in 2007, according to Agriculture and Agri-Food Canada.

The Department of Agriculture is making the investment in partnership with the Department of Economic Development. The funding comes from the Community Development Trust Fund, a \$34.9 million fund that was established by the federal government to help communities and sectors experiencing economic challenges.

"Creating new local food networks will help sustain and expand our rural economy," said Economic Development Minister Angus MacIsaac. "They encourage farmers and other food producers to become involved in innovative new business ventures to bring their foods more directly to consumers."

The priorities of the trust fund are to enhance sustainable prosperity, diversify economic and trade opportunities, improve productivity, innovation and training, assist communities with transition planning, and help workers facing adjustment challenges. Pesticide Use and Pest Management Practices of Canadian Apple Growers

The report, Pesticide Use and Pest Management Practices of Canadian Apple Growers, is now available online. This paper is based on data collected in the Canadian Crop Protection Survey, a survey conducted on behalf of the AAFC Pesticide Risk Reduction Program. The survey was designed to collect baseline data on quantities and types of pesticides used and the integrated

pest management practices employed. The document describes survey methods used, and reports on pest management practices for all Canadian apple production areas during the 2005 growing season.

You've got grand plans, but is your heart in it?

One of the great strengths of farmers is they love what they do. No one goes into farming to get rich, and it is the passion for farming that sustains them in the all-too-frequent hard times.

Like almost all other sectors, agriculture is being subjected to tremendous change, and if you're not willing to change, your odds of staying on the farm for the long term are not good.

But change is not easy – and if you're refashioning, expanding or adding onto your farm business only because you have to, you are headed for trouble. That old and simple saying – if your heart's not in it, you're not likely to succeed – is as true today as it ever was.

Successful change requires more than a business plan and spreadsheets. You have to be able to envision what you want, and you have to truly believe in that vision. OK, fine enough, you might say. I like the field work and being in the shop, but now I have to expand and spend much of my time in the office

(or managing employees or running the on-farm market or jumping through the protocol hoops that come with identity preservation). How am I supposed to find a passion for that?

You might want to learn from the example of Ruth Goldbloom.

Ruth is the driving force behind Halifax's Pier 21 national historic site, which has twice been honoured as the country's top tourist attraction. Prior to her success at Pier 21, Ruth was asked to chair the local United Way campaign. She did not want the job because she felt she would not be very good at it. She had no experience working with a large organization. She was not a businesswoman with a large network of corporate contacts, and had no desire to badger people for money – even for a good cause.

But before saying no, Ruth decided to visit each and every one of the 52 agencies supported by the United Way in Halifax. It took her two and a half weeks. She saw firsthand the

kids in the day care being served a hot lunch that, for many of them, was their only decent meal of the day. Those and other moving stories not only prompted Ruth to say 'yes' to the United Way but fueled her drive as she met with corporate leaders and challenged them to do more and give more.

In a business, you can do something similar.

Before expanding, going into direct marketing or value-added, or some other new enterprise, go out, take a look at businesses that are already doing what you're planning to do, and see if they ignite any sparks within you.

You'll learn lots of useful information from your scouting, but what is critical is what you will learn from your heart. Can you see yourself in the shoes of the person running the business you are scouting? Does that person have a passion for what he or she is doing, or is it just about the money? Could you be passionate about that enterprise?

If you're looking at changing your operation, business plans and spreadsheets will only take you part of the way. There are lots of good businesses out there. The question is: Are they good for you?

AgriStability and AgriInvest Update

AgriInvest and AgriStability Deadline Reminder For 2007

The September 30, 2008 deadline to submit 2007 AgriInvest and/or AgriStability application (s) has passed. If you missed this deadline, you can still submit the form until December 31, 2008, but a penalty for late filing will be applied. For AgriInvest, the allowable net sales used to calculate your matchable deposit will be reduced by five percent for each month (or each part of the month) your form is submitted late. For AgriStability, your payment will be reduced \$500 for each month (or each part of the month) your form is submitted late.

The 2008 AgriStability Enrolment Fee Deadline

Most producers would have already received their enrolment notice for 2008 AgriStability. The deadline to pay the fee amount was April 30, 2008 or 30 days after the enrolment notice was dated. If you have missed the deadline you may still pay the fee but a late penalty charge of 20 percent will be added to your fee. Participants have until December 31, 2008 to pay the fee with penalty. If you have not received an enrolment notice for 2008 AgriStability and believe you should have, contact the federal administration by calling 1-866-367-8506.

AgriStability 2009 Enrolment

Producers who did not participate in 2008 AgriStability must request a New Participant package before April 30, 2009. To request an AgriStability new participants package or for more information, visit the AgriStability website at www.agr.gc.ca/AgriStability or call AgriStability toll free at 1-866-367-8506.

AgriStability 2008 Interim Applications Are Available

The Interim Application is available for producers who would like to apply for the 2008 program year assistance earlier than normally available. As a program participant, you cannot receive your full 2008 AgriStability payment until your 2008 program year is complete. By using the Interim Application, you can estimate your 2008 income and expenses and receive a portion of this payment early. The deadline to apply for the interim is March 31, 2009.

AgriInvest 2007

Details regarding the AgriInvest program for 2007 will be communicated to producers late this fall. If you selected to deposit your AgriInvest Kickstart payment into the federal account you have the option to withdraw this money at anytime by calling the AgriInvest Administration at 1-866-367-4276.

The Farm Investment Fund closed December 5, 2008. Now it is time to send in your claims for work that was completed. If all your projects are not yet completed, you can still send a claim in now for those that are complete. The earlier you send in your claim, the sooner you can receive the funding. February and March see a high volume of claims which results in a longer processing time. Why not send claims in early to avoid the rush? Final deadline for Programs and Business Risk Management to receive FIF claims is March 1, 2009.

The Agri-Food Industry Development Fund closed November 28, 2008. Applications received totaled 92. Final deadline for Programs and Business Risk Management to receive claims is March 1, 2009.

The Orchard and Vineyard Transition

Program (OVTP) has had high uptake thus far. The 2007-08 program year has had 48 applications, while the 2008-09 program year has had 67 applications. For 2007-08 projects, work must be completed and claims must be submitted to the Programs and Business Risk Management office by December 31, 2008. For 2008-09 projects, the work must be completed and claims submitted by the date that is one year from your first pre-inspection. If you are not sure what program year your project falls, or what date your claim is due, please check your Letter of Agreement. You will find this information on page two under condition #11. As with all our programs, you may submit multiple claims as individual projects are completed.

Nova Scotia Crop and Livestock Insurance Commission

Production Insurance

Wildlife Compensation

The Nova Scotia Crop and Livestock Insurance Commission administers a Wildlife Compensation Program in Nova Scotia. This program is currently available for wildlife damage to 24 types of crops and/or predation by wildlife on 14 types of livestock. A complete list of eligible crops and livestock is available at www.gov.ns.ca/agri/ci/

Producers who apply for compensation should be aware of the following requirements of this program:

- Farmers must notify the Commission as soon as possible and not later than 72 hours after

the damage has occurred.

- The cause or probable cause of any loss must be confirmed by the Commission.
- You must follow industry production and protection standards to be eligible for a claim, eg: fencing, deterrents, etc.
- For crop damage, you must incur a loss of at least \$250 on two acres.
- For livestock damage, only losses as a result of black bear, fox, coyote, raven or crow, or birds of prey are eligible.

More information including the compensation policy are available on our website or by calling the Commission offices.

Advanced Payments Program

Any producers thinking about participating in the Advance Payments Program (APP), formerly known as the Spring Credit Advance Program (SCAP), in 2009, are reminded that many of the organizations administering this credit program may require you to have crop insurance as a condition of securing the loan. Any producer who is considering taking advantage of this interest free loan should contact the appropriate agency that is administering the loan for details on their requirements.

If crop insurance is one of the conditions for obtaining a loan, we advise all producers to take note of the deadlines for applying for crop

insurance. In order to obtain coverage for 2009, new applicants must apply before the application deadline.

In previous years, crops covered under the APP included most spring grains, corn, soybeans, a wide variety of vegetables and small fruits, apples and potatoes.

Crop Insurance Application Deadlines for 2009

Spring Grain - March 14
Vegetable - March 14
Potato - April 19
Corn, Soybean - April 30
Weather Plan - April 30

All producers who hold an active contract of insurance in one or more of the above plans will receive a Coverage Quote form(s) before the beginning of the crop year. This will give them an opportunity to choose their price option and coverage level for the upcoming growing season. Anyone considering applying for crop insurance for the first time must make their application on or before the dates noted above.

Attention All Potato Growers!

The Nova Scotia Potato Marketing Board reminds you that potatoes are a product regulated by law under the *Natural Products Act of Nova Scotia*.

As a potato producer, whether of fresh market, processing or seed potatoes, you must register with the Potato Marketing Board annually to legally grow more than two acres of potatoes in this province.

If you grade, pack and/or process potatoes in Nova Scotia, you must hold a valid Packer's Licence. Any

current licence expired on June 30, 2008. The cost of the licence is \$50 + HST annually.

Also, every producer of more than 500 hundred weights (cwt) of potatoes in Nova Scotia, whether fresh market, processing or seed potatoes, must remit a levy of 3¢ per cwt to the Nova Scotia Potato Marketing Board.

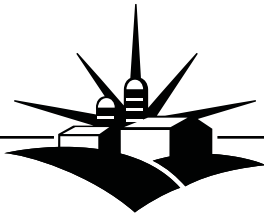

Irrigation, drainage system research at NSAC

A low-energy system for combined irrigation and drainage is being developed by the Department of Engineering at the Nova Scotia Agricultural College (NSAC). This system, funded by the Water Supply and Expansion Program of Agriculture and Agri-Food Canada, is installed on campus in the Boulden pasture. This location easily facilitates class visits so that teaching can occur on the research site.

Engineering professor Dr. Peter Havard leads a team of researchers who partner with the NS Cattle and Sheep Producers Associations. "The exciting thing is the multi-disciplinary approach to improving crops and animal pastures systems," says Dr. Havard.

The combination of irrigation and drainage into one system makes this NSAC project unique. Pipes are placed two to three feet underground throughout the pasture. Excess water in the field is drained through these

pipes to a small hut in the middle of the research field. Computer technology located in the hut measures flow rates and water levels. Low power pumps are used to collect the water into a reservoir so that it can be stored for use in dry periods. To irrigate the field, the process is reversed and water is pumped back through the same pipe system. This allows the irrigation to occur at the root level, not at the surface.

Chris Nelson, an Engineering technician at NSAC, states that the system is now operational and testing is being done to fine-tune the system.

Dr. Havard hopes to develop a complete sensor network so that the drainage, irrigation cycle will be computer regulated and able to run remotely.

The research team, consisting of Drs. Havard, Alan Fredeen, Ali Madani, Alex Martynenko of NSAC, Dr.

Yousef Papadopoulos and John Duynisveld of AAFC, hope to encourage livestock farmers to grow more forages to decrease reliance on grain. This system is expected to extend the forage growing season by a month in late summer.

Red clover and bluegrass will be grown to test the use of the system. Researchers will be able to evaluate nutrients and water flow from the site to relate to the growth of the animals grazed on the pasture.

Update - Veterinary Services, Legislation and Compliance Branch

We are pleased to announce the appointment of Dr. Leighann Hartnett to the new Animal Care Veterinary Position with the Legislation and Compliance Branch of the Department of Agriculture. Dr. Hartnett will be working out of the Hancock Building in Bible Hill. Dr. Hartnett will provide leadership in animal welfare, animal management issues as well as assisting the Program Veterinarian in preparing for, preventing and responding to foreign animal disease incursions. She will provide consultative service to food-animal veterinarians in the private sector, to the livestock industry and to other divisions of the department. Dr. Hartnett will be involved with peers in investigations of animal welfare issues and will coordinate those investigations. In consultation with stakeholders she will develop and promote guidelines for animal welfare to address those issues deemed important and to take appropriate actions when necessary to provide adequate care of farm animals.

The Program Veterinarian position, vacated by Dr. Gord Finley on his retirement, will be filled by Dr. Robert Kerr beginning in the new year. Dr. Kerr will provide leadership in disease surveillance and management of preventative medicine programs for livestock sectors. If necessary, Dr. Kerr would develop vaccination or bio-security programs for specific livestock groups or enterprises. The Program Veterinarian provides consultative service to food-animal veterinarians in the private sector, their livestock clientele, to the livestock industry and to other divisions of the department. He will interact with commodity groups to identify industry needs. Dr. Kerr will be involved with peers in the clinical investigations of unusual disease occurrences on a herd/flock basis. In consultation with industry and the veterinary staff within the department, he will develop and institute a program of disease surveillance to address those issues deemed important to trade and to industry. Dr. Kerr will network with

counterparts in other jurisdictions to ensure that the department is kept abreast of disease developments elsewhere.

The department also has two veterinary pathologists on staff at the Pathology Laboratory: Dr. Lyn Ferns and Dr. Grant Spearman. The primary function of the pathologists is to provide necropsy service on the various animal species in the province. The laboratory also provides services such as milk cultures for mastitis, parasitology, Aleutian disease testing (new entrants), and viral serology tests for poultry.

Information generated from the necropsies can provide direction to the client on disease or parasite management and control, mineral profile status of the animal and herd, and potential zoonotic disease information (ie- salmonellosis, coxiella (Q-fever), chlamydia, toxoplasmosis or rabies). Foreign animal disease diagnosis is one of the mandates of the laboratory.

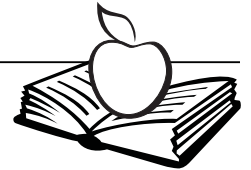
The Future of AgCot: An exit survey conducted by the Maritime Fall Fair indicates that their customer base may be changing. Preliminary results suggest that more

Farmers Honoured with Harvest Highway Designation

Highway 101, was designated Harvest Highway on December 7, to recognize the important contributions of the farming community in Nova Scotia for centuries. The highway runs from Halifax, through the Annapolis Valley, to Yarmouth.

“Nova Scotia farmers are an important part of our rural communities,” said Natural Resources Minister David Morse, on behalf of Transportation and Infrastructure Renewal Minister Murray Scott. “The naming of this highway calls special and deserved attention to the many farmers throughout the province and their many contributions to the landscape of the province.”

Agriculture production and food processing contribute more than \$900 million annually to Nova Scotia's economy. The most recent figures show, that agriculture in Nova Scotia employed 2,300 people full time and 700 part time, with food processing employing more than 13,000.

“The naming of Harvest Highway serves as a reminder of the province's efforts to encourage people to support local farmers and purchase locally grown products,” said Mark Parent, Minister of Environment, on behalf of Brooke Taylor, Minister of Agriculture.

Richard Melvin, president of the Nova Scotia Federation of Agriculture and area farmer is pleased with the designation.

“Nova Scotia farmers are an important element of our rural infrastructure and having signs and recognition reminds travellers to think local first.”

Harvest Highway joins other highway designations including Miners Memorial Highway, Peacekeepers Way, and Veterans Memorial Highway. In the interest of safety, the highway will continue be referred to as Highway 101 by emergency personnel.

Fall and Winter AAFC Advanced Payment Program

Fall and winter AAFC Advanced Payment Program loans are still available on storage crops for vegetable growers, potato growers, and new season plantings for greenhouse vegetable growers through Horticulture Nova Scotia. The vegetable crops covered for the storage season are onions, parsnips, carrots, rhubarb, strawberry plants, winter squash, rutabaga, cabbage, brussels sprouts, dry beans, beets, sweet potatoes and potatoes. At present only greenhouse tomatoes are covered, but amendments may be made to cover other greenhouse crops.

The purpose of this program is to provide a cash flow to allow for orderly marketing. Loans are based on the amount of crop you have in storage, or for greenhouse growers the amount you are planting. Loans of up to \$100,000 are interest free. Loans over \$100,000 and under \$400,000 are at 3/4 of a percent under prime. There is an additional administration fee. The cost of this course is \$185 (includes manual and tax).

Recertification is a great opportunity for license holders to improve their pesticide safety knowledge, keep current with changes to legislation and avoid having to write another pesticide exam. This course is designed for those individuals who have a current license and would like

to accumulate recertification points towards their license. The cost for this course is \$75 (tax included).

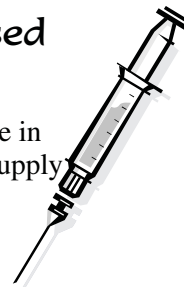

Disposal of Used Farm Sharps

The Agriculture office in Kentville still has a supply of sharps containers available at no cost for producers.

Remember, sharps must not be discarded in regular household garbage. Sharps should be collected in rigid, puncture resistant containers with tightly secured lids.



Be Sure to Farm Safely this Holiday Season

As we approach the holiday season, farmers and their families are reminded to think about farm safety. This will help ensure you and your family have a safe and happy holiday season.

Here are a few things to consider:

- Snow is here. Use extra care and be prepared for slippery surfaces, whether they are in barns, around the farm yard, or on the highways.
- Now is a good time to make sure equipment used during the winter months is given a maintenance check to ensure it is working properly and safely. Be sure that all safety guards are in place.
- If you have not already done so, make sure your chimney flue is cleaned.
- At home, use extra care with extension cords and lights, as well as candles to avoid electrical or fire hazards.
- Check your generator and perform any necessary maintenance.

- A lot of livestock will be coming in, or have recently come back in the barn. Use extra caution when working with animals. Use safe handling practices while both you and the animals adjust to this change.

If you are applying for a pesticide licence for the first time or your current licence is due to expire and you have not collected any recertification points, then you should take a certification course or alternately arrange to write the pesticide application exam at a NS Environment office.

Recertification sessions provide five points of the 15 required before your licence expires to recertify without writing an exam.

Wildlife Flushing Bars

Nova Scotia boasts a large number of hayfields. While the fields are managed to produce an agricultural crop, they attract a variety of wildlife species, therefore becoming wildlife habitat. All of these wildlife species are vulnerable to being killed by mowing equipment. Farmers who feel they are frequently encountering wildlife during their mowing operations, are often concerned about the ability of this wildlife to escape. A wildlife flushing bar could be a viable solution.

The flushing bar is an aluminum bar attached to the front of a tractor with pull type hay cutting equipment (modifications available for self propelled). Chains are attached to the aluminum bar that drag through the hay. The movement and noise causes wildlife to flush away from the cutting surfaces of the mower. The bar is light enough to be

mounted by one person and can be pulled in against the tractor when moving from field to field or when mowing close to trees. While the flushing bar will not save nests from being destroyed, it will save the nesting birds, which can then re-nest. In the case of fawn deer and other wildlife, the bar is successful in flushing them out of the path of the mower.

In past years Ducks Unlimited and the Department of Agriculture have jointly funded this conservation tool through the Department of Agriculture's Farm Investment Fund. Interested farmers should review the 2009 - 2010 Farm Investment Fund information when it is released to see if funding is available and if they qualify.

Farm Safety

The new year gives us all an opportunity to reflect on the challenges and accomplishments we have experienced during 2008 and to look forward to the many opportunities that the coming year will bring. During the holidays, more than ever, it is important to consciously practice safe working practices on your farm. As farm routines change, remember to keep the safety of you and your family in mind. Do not let what should be a happy and joyful time of the year become a tragic one. Here are a few safety tips to keep in mind:

- Use caution around icy/slippery areas in farmyards and on machinery.
- Check and maintain any machinery guards and covers.

- Make sure covers are in place and secure around manure pits and tanks.
- Ensure there is adequate lighting in buildings and on machinery.
- If not already done, tidy up your pesticide storage area.
- Where necessary, mark lane ways for snow removal this winter.
- Check all first aid kits and replace any used or outdated supplies.
- Check fire extinguishers.
- Clean your chimney(s).

For some light reading, review the Farm Safety Standards of Practice and complete the checklist for your farm.

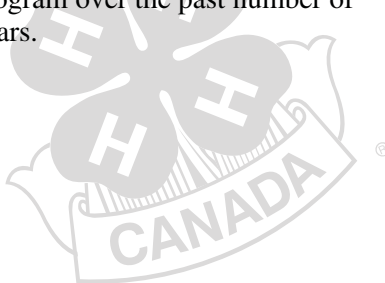
