Government Leads on Agricultural Land Use

Farming has been a good business for many generations, despite the ups and downs the sectors and farmers have had to endure along the way. Farmland is critical for our food system, so being able to access goods from a locally supplied industry is a privilege not to be taken for granted.

We are fortunate to have quality farmland so that we may grow food here to feed our families, as well as to export as market and free trade allows.

The question as to whether or not we should be doing more to protect agricultural land is an issue the government of Nova Scotia takes seriously as it strives to create good jobs and grow the economy especially in our resource sectors.

Agricultural land is a limited resource. Every year, we lose some agricultural land to housing and other forms of development, both urban and suburban.

As pressure to develop land for non-agricultural purposes increases, people continue to ask questions about the future of agricultural lands. What is government's role in protecting our agricultural resources?

Should we let this land be used for commercial development? Should preservation be the responsibility of our local governments or the provincial government? What will this mean for Nova Scotia's farmers?

The answers to those questions are not easy ones, as they have far reaching implications to just about everyone in the province. It is not hard to see how getting more involved in how agricultural land is to be used in the future is a complicated issue.

Government is not shying away from the questions. This government has been working to identify how to best move forward so that we can provide genuine leadership on this issue and continue to make life better for families in our communities.

Within months of becoming Minister of Agriculture I took action on this issue. Service Nova Scotia and Municipal Relations Minister

Ramona Jennex and I appointed an independent land review committee to advise this government on issues surrounding agricultural land preservation. The Nova Scotia Agricultural Land Review Committee was commissioned to conduct a review of agricultural land preservation issues in the fall of 2009.

Its mandate is to identify the steps to be taken and recommend processes to put in place regarding the preservation of agricultural land for the benefit of all Nova Scotians. A major part of the review process includes seeking public input and then to prepare a report so that the province is well informed in making decisions that would result in changes to existing legislation policies and programs, or that might affect the roles of municipalities and non-government organizations in the preservation of agricultural land.

An Act to Manage and Develop Fur Industry in Nova Scotia

An act to help the Department of Agriculture manage and develop Nova Scotia's fur industry received Royal Assent on May 11, 2010.

The *Fur Industry Act* was developed in consultation with members of the fur industry, including the Nova Scotia Mink Breeders Association, and interested community groups.

"The Nova Scotia fur industry is a significant contributor to our provincial economy," said John MacDonell, Minister of Agriculture. "This legislation puts in place measures to ensure the appropriate management and development of the industry for years to come."

The new legislation places more responsibility on ranchers to ensure operations take into account the effect on their neighbors and the environment. Specifically, the act requires that fur ranchers obtain a site approval permit before getting their operating licence.

Ranchers will also be required to have management plans that will cover environmental impacts such as waste, water management and disease prevention. The act also gives the Department of Agriculture inspection and enforcement authority.

“We feel confident that this legislation will help the mink industry in the long run,” said Earl Prime, president of the Nova Scotia Mink Breeders Association. “Mink farms offer valuable employment to rural communities through on-farm work, pelting plants, and feed kitchens.”

The Nova Scotia mink industry has seen a steady climb in profit in recent years with export sales exceeding \$65 million in 2008 and about \$80 million last year.

The provincial government has already taken a number of steps to help preserve agricultural land. Farmland for example, is exempt from municipal taxation - an incentive to keep land in production. The Department of Agriculture also has a number of programs in place to make farming more viable and help attract new farmers to the industry.

Public input obtained so far overwhelmingly supports the protection of farmland but emphasizes that costs associated with that protection cannot be borne by farmers alone. The Nova Scotia Agricultural Land Review

Committee public consultation process held this year drew 549 Nova Scotians to 12 meetings and 120 written submissions on preserving agricultural farmland, most of whom point to a desire for the province to take measures to further protect the land.

As is the case, with issues that involve many interested parties, there are no easy answers or quick solutions. We will continue to work with them to better understand the overall value of agricultural land to our communities, and to understand all the implications in which solutions might have on Nova Scotians.

A Resource for Farm Businesses: Q and A on Environmental Law (2010) – now available on line

Environmental law and land-use planning law are complicated areas that cover a myriad of requirements issued by the federal, provincial and municipal governments. As owner/operators of enterprises that use large tracts of land and interface with the environment on a daily basis, farmers find themselves in the throws of these complicated requirements. Although there are occasions where direct legal advice and communication with a lawyer is essential, there are situations where general information is all the farmer requires.

The Q and A on Environmental Law (formerly, A Resource for Farm Businesses: Concise Answers to Legal Questions on Environment and Land Use) was originally released in May 2002 to provide a resource to allow farm managers to make basic decisions with respect to regulatory issues prior to seeking legal advice. This resource of 30 questions and answers has been updated and is now available online. The funding support of Agri-Futures Nova Scotia through the ACAAF program made this resource possible. The application deadline is fast approaching for Winter Grain – August 31!

The deadline for planting is September 30 in Annapolis County, Kings County and Hants West and September 20 for all other areas.

The deadline to apply for Forage Establishment is October 31. Fields of legumes and legume-grass mixes seeded by July 1, as well as grass seeded by September 1, are eligible for coverage.

Cancelling Crop Insurance

Most Crop Insurance contracts are

continuous. This means they do not terminate at the end of the cropping season unless a producer requests cancellation in writing by the deadline date.

This approach ensures that a client does not risk the chance of not insuring the crop for the season if an application is not made by the required date. If you do not cancel by the cancellation deadline, you will be expected to insure your crop during the current crop year.

Advance Payment Program for Livestock Offered by Pork Nova Scotia Now Available

Pork Nova Scotia (PNS) is accepting applications for the 2010/2011 APP program year. The federal government guaranteed Advance Payment Program (APP) for Livestock offers, hog, beef, mink and sheep producers in Nova Scotia 50 per cent of the livestock value in advance of sale. This enables the producer to better market their livestock. The first \$100,000 advanced is interest free and up to \$400,000 at an interest rate of prime minus ¼ per cent. This program is administered by PNS and has helped many producers.

To qualify for funds under the Advance Payment Program.

- A producer MUST be enrolled in AgriStability. This program provides security for the APP.
- Be a Canadian citizen or permanent resident. A corporation, cooperative or partnership of which the majority interest is held by Canadian citizens or permanent residents. One individual must be the age of majority, be principally occupied in farming, own the agricultural product, and be responsible for its marketing.

What livestock qualifies for an advance?

- Beef, sheep, hogs, and mink, including post production.
- The production period of April 1, 2010 to March 31, 2011, qualifies to receive an advance provided the livestock will be sold before September 31, 2011.
- Once the livestock is sold, a producer will repay the advance amount on that quantity and will be required to submit 'proof of sale'.
- Mink producers can receive funds on their inventory, including the post production period.

How to determine your eligible advance amount?

- Advances for hogs are given for a six month period at a per head bases, at which time the advance repayment is made. A producer can obtain two six-month advance terms for the program year.
- Advances for beef are given at a rate of cwt for weight classification groups. For example if you have a cow calf production and bring your calf to 600 lbs you would be advanced about \$285 per head and repay the advance upon sale.
- Advances for sheep are given per head for each weight classification.
- Advances for mink are given for your spring production volume. Your advance will be repaid once your pelts are sold at auction.

When is your advance paid back?

- For hogs, you repay the advance amount every six months.
- For beef and sheep, you repay once the livestock is sold.
- For mink, you repay the advance amount after the auction sale.

- For all advance amounts you repay 50 per cent within 15 days of the due date and the remaining 50 per cent within 45 days of the due date. All payments require proof of sale receipts.
- Any advance amount exceeding the interest free portion of \$100,000 will be charged an interest rate of prime minus ¼ per cent compounded and becomes due on your closing date.
- As your repayments occur they are applied to the interest free portion first.

How can you apply for APP program funds?

- Applications can be found at www.porknovascotia.ca under the APP tab or by contacting the office at (902) 895-0581.
- You can apply any time between April 1, 2010 and March 31, 2011.
- The application fee is a minimum of \$350 or two per cent of the advance amount to a maximum of \$750 plus HST and is deducted from your advance amount.



Programs and Business Risk Management AgriInvest and AgriStability

AgriInvest and AgriStability are business risk management programs designed to help producers protect their income and manage risks, such as drought, flooding, low prices, and increased input costs.

AgriInvest provides farmers with flexible coverage for small income declines as well as support for investments to mitigate risks or improve market income. Farmers deposit money into an AgriInvest

account and receive matching government contributions. If you receive an AgriInvest deposit notice you have 90 days to respond by making your deposit.

2009 AgriInvest Deposit Notices

2009 AgriInvest Deposit Notices are starting to be mailed out with information on how to make your 2009 deposit.

For 2009 you can make your AgriInvest deposits at a participating bank of your choice. Once you receive your 2009 deposit notice, you can open an account at your financial institution and make the 2009 AgriInvest deposit by the deadline indicated on the Deposit Notice to receive a matching contribution from governments.

Existing funds currently held by the federal government will be transferred to your AgriInvest account with the financial institution. Producers can request a withdrawal from their AgriInvest account through their financial institution at any time throughout the year.

AgriStability is a margin-based program that provides support when a farmer experiences larger farm income losses. AgriStability covers declines of more than 15 per cent in a farmer's average income from previous years.

If you participated in AgriStability 2009 you will automatically be enrolled for 2010 and will receive a 2010 enrolment notice soon. If you have not received your 2010 enrollment notice and have not heard from AgriStability you should contact them at the number below.

New Participants or Farmers – AgriStability 2010 Enrolment

Producers who did not participate in 2010 AgriStability and wish to participate in 2011 must request a New Participant package before April 30, 2011. AgriStability 2010 Interim Applications Are Available

The Interim Application is available for producers who would like to apply for an advance for the 2010 program year. As a program participant, you cannot receive your full 2010 AgriStability payment until your 2010 program year is complete. By using the Interim Application, you can estimate your 2010 income and expenses and receive a portion of this payment early. The deadline to apply for the interim is March 31, 2011.

Are Nova Scotians eating local? Where is our food coming from?

The Nova Scotia Federation of Agriculture in collaboration with the Ecology Action Centre released the final report of a study on food miles on July 27, 2010. This report takes a closer look at the real cost of our food and what it might take to make a more locally based food system.

Jen Scott, co-author of Are Nova Scotians Eating Local says, "In 2008, we estimate that 13 per cent of the food dollar Nova Scotians spend is being earned by Nova Scotia farmers. Over the last 11 years, this proportion has gone down. In 1997 it was 17 per cent."

If we are eating less local products, then where are Nova Scotians spending their food dollars, we ask? Marla MacLeod, co-author of the report and Food Action Committee Chair indicated that, "The study examined over 60 products and found that, on average, the food products were traveling nearly 4000 km from farm to plate." "There is potential for reducing transport-related greenhouse gas emissions by switching to locally grown foods, provided that they are produced by methods of similar or increased energy efficiency compared with imports," she adds.

At the Nova Scotia Federation of Agriculture, Richard Melvin, President is pleased with the report, "We see a great opportunity to increase local food consumption by strategically working with producers and retailers on how to increase locally grown produce in a sustainable way."

The Federation of Agriculture has also put together a new website, being launched in conjunction with this report. The website; www.meetyourfarmer.ca is full of

farm personalities from across the province, telling their own stories about what they do and how they do it. Mr. Melvin says, "This online portal will create and improve the relationship with us, Nova Scotia farmers and our consumers. Strengthening the consumer - food connection through

www.meetyourfarmer.ca will be one more step in increasing local food consumption."



\$46 million Poultry Processing Plant Announced for Kentville, NS

The Nova Scotia Poultry Industry Strategic Planning Committee and Maple Lodge Farms Holding Corporation are pleased to announce plans to build a new chicken and turkey processing plant in Nova Scotia.

"This is very exciting news for the Nova Scotia poultry industry," said Ian Blenkarn, chair of the Industry Strategic Planning Committee. "We have been working with Maple Lodge and the chicken and turkey farmers in Nova Scotia and PEI to find a long term solution for a profitable poultry processing industry. Our announcement today also brings stability to both the farmers and the employees in the industry."

The new \$46 million plant will be built in the Kentville Industrial Park and is expected to be operational by the spring of 2012. It will process the chickens and turkeys from the farmers in Nova Scotia and Prince Edward Island. The need for a new, efficient plant resulted from the closure of the Maple Leaf Foods plant in Canard, Nova Scotia in the spring of 2007 leaving approximately 45 per cent of the provinces' chicken farmers without a processing plant. Recognizing a need to have Nova

Scotia chicken and turkey processed in a Nova Scotia plant provided an opportunity for the farmers and Maple Lodge Farms to create a partnership for a new plant.

"Maple Lodge Farms is proud to partner with the Nova Scotia and Prince Edward Island farmers in building a new, efficient and profitable processing plant in the Annapolis Valley," said Michael Burrows, CEO of Maple Lodge Farms. "This venture will ensure the long term viability of the poultry processing industry in Nova Scotia and will benefit the farmers of both Nova Scotia and Prince Edward Island through ownership in the plant."

The new plant will be owned 50/50 between Maple Lodge and the farmers. This partnership is unique in Canada. The farmers are making a commitment to ship their production to the new plant and Maple Lodge will provide much needed national marketing reach for the processed product. The new plant will have modern, efficient equipment and design. The end result will be a primary processing plant in the Annapolis Valley providing stability to the farmers and jobs in the community.



33rd Annual Nova Scotia 4-H Show

At this time of year 4-H members are busy attending exhibitions with their 4-H projects and making preparations for the 33rd Nova Scotia 4-H Show, October 1 - 3, 2010. Hosted at the Nova Scotia Provincial Exhibition Grounds in Bible Hill, this annual event is an excellent opportunity for 4-H families and the public to view the talents of 4-H members across the province.

Nova Scotia has the largest 4-H Show in Canada, with all the exhibitors being 4-H members from 9 - 21 years of age. Each year a county or region hosts the 4-H Show. For this year's show Central Region 4-H Leaders Councils have the responsibility of making site arrangements, providing security, fund raising and promotion.

"The Nova Scotia 4-H Show is an excellent opportunity for people to see what the 4-H program offers - public speaking with the Young Speakers for Agriculture competition, technical livestock and life skills training during competitions and a superior leadership development program for all youth," said Arthur Pick, Manager, Regional Services.

In a national survey by the Canadian 4-H Council and Ispos-Reid, 1097 4-H Alumni were polled for their attitudes towards the 4-H program and its impact on them. Seventy-four per cent of alumni said their experiences as a 4-H member was very beneficial in terms of contributing to personal or career experiences later in life. In particular, one thing they pinpointed was acquiring and building teamwork and interpersonal skills.

"Over the years one comes to realize just how important something like the 4-H program really is in shaping the

youth of our communities. 4-H has existed in Nova Scotia since 1922. The purpose of the program is to develop well rounded, responsible, and independent citizens," said Brenton Arnold, a 17 year old 4-H member from the Western Kings 4-H Club. "In my case I believe the program has succeeded. By affording me the opportunity to flourish in an environment that encourages community development with a focus on responsibility, accountability and

independence I can move forward with important knowledge and newfound abilities that are a vital component of everyday life and can successfully use them in any of my future endeavours. I would not be the individual that I am today had I not been involved in the 4-H program."

The Nova Scotia 4-H Show is open to the public and admission is free. Competitions run from Friday, October 1 to Sunday, October 3.

Young Speakers For Agriculture Competition

4-H members who are interested in challenging their public speaking abilities and want to discuss their enthusiasm for the agriculture industry are encouraged to enter the Nova Scotia Young Speakers for Agriculture Competition. All senior 4-H members and 4-H Alumni who are 16 - 24 years of age as of the competition date, Oct. 1, can enter. It will be held during the Nova Scotia 4-H Show at the Nova Scotia Provincial Exhibition Grounds in Bible Hill.

The Nova Scotia 4-H member that wins the provincial contest will be sponsored by the Nova Scotia 4-H Council to participate in the 26th annual Canadian Young Speakers of Agriculture National Senior Public Speaking Competition at the Royal Agricultural Winter Fair in Toronto, Ontario on Saturday, November 6, 2010.

Each contestant will give a five to seven minute prepared speech on one of following topics, as well as introduce and thank another speaker. Contestants may choose to use a flip chart, or appropriate posters to illustrate their talk. Slides, films, videos or overhead projectors will not be allowed. A complete set of rules, as

well as the score sheet, will be sent to all applicants prior to the Nova Scotia competition.

The competitors have five agricultural related topics to choose from:

1. Canadian Agricultural Hall of Fame - profile someone and share their impact.
2. Who will feed the world in 50 years?
3. What is the biggest challenge in agriculture today?
4. Exploring First Nations agriculture in Canada.
5. What are the biggest events in Canadian agricultural history?

4-H members are taught public speaking skills during the year along with project work. Each spring 4-H clubs, counties and regions hold communications competitions. Many young people often identify the communications training and confidence that it has given them as their most memorable experience in 4-H.

Nova Scotia's 4-H Camp Being Restored

It is often said that it takes a community to raise a child. For 38 years Camp Rankin, Nova Scotia's provincial 4-H camp, has had a proven reputation of providing Nova Scotia 4-H members with a positive educational program and lasting memories that keep them coming back each year. The camp was built by volunteers as a Centennial project of the Richmond County 4-H Leader's Council and was the first 4-H camp to be built in the Atlantic provinces.

Each year 200 4-H members from 9 - 15 years of age embark on a summer adventure at Camp Rankin where they experience healthy living, leadership and skills development in a scenic setting on 60 acres of land situated on the on Bras d'Or Lakes, near St. Peters on Cape Breton Island.

Camp Rankin's facilities include hiking trails, beach and a dining and recreation hall. Trained camp counselors with 4-H experience lead the youth through all traditional camp activities.

Although the original intention of the camp was to accommodate the 4-H clubs of Richmond County and surrounding area, it now hosts five,

five-day summer camps. Richmond County 4-H Leaders Council maintains the camp.

For the past year the Camp Rankin 4-H Association board of directors and volunteers have been raising money in an effort to fund a major two- year structural expansion costing \$135,000. The board believes very much in the 4-H movement, its ideals and the life skills that 4-H members learn during their time with the program.

"Camp Rankin has been the summer home for 1000's of Nova Scotia 4-H members since 1972. These 4-H members have become educators, business people, government officials and community leaders," said Doug Landry, Chairperson, Camp Rankin 4-H Association.

"The Camp Rankin 4-H Association board and volunteers have worked hard over the years to keep the camp in an acceptable condition. After reviewing the summer camp surveys, the board feels now is the time to bring the camp to the next level. We are very excited with the response from the public and three levels of government regarding this project and encourage anyone interested in

helping with the project to contact us."

With funding from Nova Scotia Health Promotion and Protection, FCC, the ECBC- RINC program, contributions from county 4-H Councils and \$20,000 donated in labour and materials, the project is well underway. The Camp Rankin 4-H Association still requires some money to fully fund the project and donations are gratefully accepted.

Work has begun on the camper's cabins and ground work for a large outdoor recreation area with upgrades to electrical work, showers, trails, the kitchen and several roofs of buildings in the work plan.

In the spirit of the 4-H community, Camp Rankin will host Raise the Roof on September 18 - 19 where 4-H leaders, parents, senior members and friends are asked to donate labour and time to help re-roof several buildings. Work days run from 9 a.m. - 6 p.m., lunch will be provided. If you would like to volunteer and can lift, carry or swing a hammer your help is needed! Please contact your 4-H office if you are able to help with this important camp renovation.

Cumberland County producers do not miss the opportunity to have your product(s) on the minds of all Cumberland County residents, restaurants and retailers. Whether you do direct sales or wholesale to grocery chains, all producers can benefit by promoting their operation. The Federation of Agriculture, the Cumberland Regional Economic Development Association, the Cumberland Health Authority and the Department of Agriculture are in the planning stages of creating a county level, local food directory.

This new guide will promote the benefits of buying local and direct from Cumberland producers (agriculture and seafood) - freshness,

quality, and meeting the increasing consumer demand for locally produced foods. The guide will also educate chefs and food buyers about the seasonal availability of Nova Scotia products and provide useful information about the producers who supply them.

We will be gathering information from all producers for the guide. A direct mailout to registered producers will contain information about the process, application form and a sample of another local county directory. Look for the opportunity to promote your operation.

Do You Have the Proper Drivers Licence?

If you have a farm tractor trailer combination over 14,000 kg you need a Condition 23 Endorsement. If you are hauling any trailer (with a truck or tractor) that has a weight over 4500 kg you need a Condition 15 Endorsement on your licence to legally drive on Nova Scotia roads. These regulations apply to a class 5 licence. If you are interested in obtaining these endorsements there is an opportunity for you on Tuesday, September 14, 2010 at the NSAC Farm.

Process For Condition 15:

1. Purchase a Road Test Receipt which costs \$47.68 (HST included) This can be purchased at an Access Nova Scotia Center or online at <http://www.gov.ns.ca/snsmr/rmv/licence/>

Process For Condition 23:

1. Complete a Condition 23 application prior to testing.
2. Have Driver's Medical Exam completed by your doctor.
3. Purchase a Road Test Receipt, which costs \$47.68 (HST included). This can be purchased at an Access Nova Scotia Center or online at <http://www.gov.ns.ca/snsmr/rmv/licence/>

You must register with the Central office first and have a valid drivers licence ("N" removed) to be eligible for testing. The Condition 23 application, the form for the Medical Exam and more information is available by calling (902) 893-3645 to speak to Michael or Marlene.

There is an information session on Tuesday, September 7, 2010 to become familiar with equipment being used on test day.

The Great Pumpkin Commonwealth is a collection of more than 70 official weigh-off sites, their supporting clubs, and growers worldwide. These sponsored sites are attended by hundreds of thousands to the ever popular, annually run festivals and weekend events. Established in 1993, the GPC is the major organizer and sanctioning body overseeing competitions in giant pumpkin and vegetable growing. The GPC works vigorously to improve weigh-off site standards in fairness of competition while promoting family values.

The Official GPC weigh-off date is Saturday, October 9, 2010, at the Millville Hall, Millville. All entrants must be REGISTERED before 11

a.m. on that day so the judges may inspect each pumpkin prior to weighing.

The GPC sets the recognized standard for all world records in the giant pumpkin family as used by Guinness for their World Record endeavors. GPC growers have set the World Records for the last 15 years. The GPC's mission cultivates the hobby of growing giant pumpkins throughout the world by establishing standards and regulations that ensure quality of fruit, fairness of competition, recognition of achievement, fellowship and education for all participating growers and weigh-off sites.

Cape Breton Biomass Project

Cape Breton University's Centre for Sustainability in Energy and the Environment (CSEE) recently began work on a hybrid-willow energy crop research and demonstration project. The project will evaluate the production performance and yield of various willow varieties as a possible dedicated energy crop and cash crop for the bio-energy sector in Cape Breton. Production performance of three varieties of willow on three, two-acre plots of marginal and underutilized lands in CBRM, plus an experimental one-acre plot with ten varieties will be tested. CSEE personnel joined with a network of willow growers in Canada, the United States, and the United Kingdom to transfer knowledge and develop a best practices handbook for those interested in growing willow locally. This four-year project is supported by Enterprise Cape Breton Corporation.

Cape Breton Regional 4-H Newsletter 2010

The Cape Breton 4-H program consists of 228 active members, 27 cloverbuds and 78 volunteer leaders from the four counties this year. Membership is enrolled in 37 different livestock and life skills projects across the region. Eighty-nine per cent of the our leaders come from rural or farm areas. Eleven per cent of our leaders reside in urban areas. Seventy-five per cent of our members come from rural or farm communities with 25 per cent coming from urban areas. This is showing an increase into urban communities and a trend to encourage a growing membership base. These are exciting times for regional youth as new clubs and project areas are explored. 4-H in Cape Breton represents club and community involvement that evolves into a unique 4-H 'family'. Being apart of a club allows 4-H members and leaders to lend a helping hand when it comes to project work, volunteer experiences, and social events. The 4-H program is full of experiences and excitement throughout the year. The 4-H Weekend, Provincial Show, and Camp Rankin are just a few opportunities offered to Cape Breton 4-Hers. Members learn to work as a team, as well as independently. With the 4-H motto, "Learn to do By Doing", members have the opportunity to grow into responsible, mature leaders with valuable life long skills.

The 4-H program is open to anyone between the ages of 9 and 21 years who would like to become a member. Children 7 and 8 years old can become clover buds. These members are given the opportunity to enjoy and learn about the 4-H program without having to participate in competition. For those 21 years of age and older, we encourage individuals to become 4-H leaders or club assistants.

Counties in the Cape Breton Region

Cape Breton County has the largest 4-H member enrolment in the region this year. It offers a variety of projects, especially homemaking projects. Additionally, many diverse livestock projects are offered. This county is home to the oldest continuous club in Canada, the Grand Mira 4-H club. Cape Breton County is a strong competitor in the speaking and demonstration competitions, both regionally and provincially. Each year the county hosts the "Junior Member Small Steps" workshop and provides craft co-op workshops to membership in the region. This county has also founded the "George MacNeil Scholarship" and are actively working towards making this endowment an educational funding source for 4-H youth to benefit from for years to come. Nova Scotia 4-H Show each fall and Nova Scotia 4-H members and leaders take part in the largest provincial 4-H Show in Canada. The month-long celebration provides an opportunity to showcase the many benefits of the 4-H program, which continues to help thousands of youth in Nova Scotia reach their full potential. 4-H has been bringing leadership and development programs to Nova Scotia's rural young people since 1922 when the first 4-H club began in Heatherton, Antigonish County. This 4-H club was an Ayrshire heifer and swine club comprised of fourteen members. Since its early beginnings, the 4-H program has evolved to offer leadership training, public speaking, technical and life skills to youth from 9-21 years of age.

4-H Annual Meeting - This takes place in November each year. Each county is able to send two delegates, one adult leader and one senior 4-H member. It is an excellent opportunity to be part of the rule-making process for the Nova Scotia 4-H program and to meet other people from across the province.

BSE Surveillance Program

One of the ways we highlight the safety and quality of Canadian beef is through the national bovine spongiform encephalopathy (BSE) surveillance program. The program plays a critical role as we work toward the elimination of the disease in the Canadian cattle population. CFIA's BSE Surveillance Program is still in effect. If an inspector samples an animal - farmers get \$75 for carcass

disposal. If a veterinarian samples an animal - \$75 for carcass disposal plus another \$100 is paid to the veterinarian and then credited to the farmer's account to offset call fees.
