## Minister Announces Beef Interest Pay-Down Program

Beef producers will be better able to stabilize the long-term viability of their industry with a \$2-million Nova Scotia Beef Interest Pay-Down Program, announced on January 18.

The program, delivered through the Nova Scotia Federation of Agriculture, provides assistance to Nova Scotia beef producers to pay down loan interest from 2009 to 2011. It will support the beef industry in the short term and provide funding to ensure producers remain viable.

“This program will address some of the current challenges facing beef producers, helping them move forward in their efforts to build a sustainable sector in Nova Scotia,” said Agriculture Minister John MacDonell.

“Working with the Nova Scotia Federation of Agriculture and the Nova Scotia Cattle Producers since early last summer, I am confident that beef farmers will competitively position themselves in today’s marketplace.”

Cattle producers have expressed a need to make changes in the industry. This program is a starting point to reposition it by investing in a profitable and sustainable plan. Producers will have the flexibility to focus on parts of the industry that strengthens partnerships, alliances and collaborations. Individuals will also have opportunity to invest in their needs.

“Beef producers in Nova Scotia face serious short- and long-term challenges,” said Dave Oulton, chair, Nova Scotia Cattle Producers. “Today’s announcement ensures that some of the hardships faced by our farms, due to extremely low market conditions, can be addressed, and our board members will continue to be available to help clarify producer eligibility requirements and look forward to the quickest possible delivery of this necessary support.”

“The federation recognizes this will be a significant investment in the Nova Scotia beef sector and will help


producers with their goal of providing more high-quality beef for Nova Scotia consumers,” said Richard Melvin, president, Nova Scotia Federation of Agriculture.

The deadline to submit the 2009 application is March 31. The deadline for the 2010 and 2011 claim forms will be March 31, 2011 and 2012, respectively.

## New Animal Protection Act



Nova Scotia has new animal protection legislation entitled *An Act to Protect Animals and to Aid Animals that are in Distress*, or the *Animal Protection Act*. This new act was proclaimed on January 19, 2010. There are some significant changes in the way animal cruelty complaints are handled, with the goal of improving animal welfare and professionalizing investigations in the province.

The Nova Scotia Department of Agriculture (NSDA) will now investigate farm animal cruelty complaints in Nova Scotia. The SPCA will remain responsible for cruelty

complaints of companion animals. Leighann Hartnett, DVM has been hired to implement this program. She has had significant training through courses on Animal Welfare, Investigations and Enforcement, and Administrative Justice. It is anticipated that by having a veterinarian in the field evaluating farm animals and husbandry practices, there will be improved professionalism and an increased knowledge of livestock production.

With the network of people in the NSDA, as well as other government departments, it is hoped that there will be more education and resources

available to producers and owners of farm animals for improvement of animal welfare.

The new act includes the obligation of veterinarians to report suspected cases of animal cruelty to the SPCA or the NSDA, the obligation of the SPCA to submit an annual report to the Minister of Agriculture and the creation of a Board of Appeal. In addition to these changes, the maximum allowable fines have been increased, giving the courts the opportunity to implement greater penalties for offenses.

The Appeal Board is not yet operational. Once board members have been hired and trained, it will provide an opportunity for animal owners and caretakers to file an appeal when they feel their animals have been unjustifiably taken from them on suspicion of animal cruelty. This Board will review all facts and evidence to determine whether correct procedures were followed in an animal seizure case.

The *Animal Protection Act* is a comprehensive piece of legislation and with its implementation, Nova Scotia will be among the leading provinces in terms of animal welfare. As regulations are developed, the act will be strengthened even further. ## Direct Marketing Vendors Receive Funding

Nova Scotians will be better able to connect with consumers and offer fresh, local products with provincial investment in four food direct-marketing initiatives.

Agriculture Minister John MacDonell announced \$430,984 in funding on December 22, 2009, to help strengthen local food direct marketers' infrastructure and sustainability.

"We are investing in farm and farmers' market businesses that promote the variety and quality of food Nova Scotia has to offer," said Mr. MacDonell. "I am pleased that farmers and other food producers are initiating new, innovative business ventures to bring their foods more directly to consumers."

The funding is provided through the Direct Marketing Community Development Trust Fund, which aims to increase consumer access to local products and help agriculture businesses sell more directly to consumers.

Funding will allow:

- Meadow Brook Meat Market, in Berwick, Kings Co., to increase opportunities to supply unique pork products to local consumers
- Farmers' Market of Nova Scotia Co-operative of Halifax to adopt a program to support business development and training for the farmers' market sector.
- Meadowbrook Farm in Tatamagouche, Colchester Co. to upgrade its meat shop to provide opportunities for consumers to experience local products.

- Wolfville Farmers' Market, in Wolfville, Kings Co., to develop a long-term, fixed location that will accommodate growing popularity and increase opportunities to access and market local food products.

"These businesses are an integral part of Nova Scotia's agriculture community," said Mr. MacDonell. "These projects were chosen for their strong business plans and benefits for the agri-food industry in Nova Scotia."

The funds are provided through the Community Development Trust Fund, a \$34.9-million program established in 2008 by the federal government to help communities and sectors experiencing economic challenges.

The priorities of the Community Development Trust Fund are to enhance sustainable prosperity, diversify economic and trade opportunities, improve productivity, innovation and training, assist communities with transition planning, and help workers facing adjustment challenges. Producers who did not participate in 2009 AgriStability and wish to participate in 2010 must request a New Participant package before April 30, 2010. ### **AgriStability 2009 Interim Applications Are Available**

The Interim Application is available for producers who would like to apply for an advance for the 2009 program year. As a program participant, you cannot receive your full 2009 AgriStability payment until your 2009 program year is complete. By using the Interim Application, you can estimate your 2009 income and expenses and receive a portion of this payment early. The deadline to apply for the interim is March 31, 2010.

Farm Investment Fund (FIF) has a final claiming deadline of March 1, 2010. Now is the time to send in your claims for work that has been completed. The earlier you send in your claim, the sooner you can receive the funding. February and March see a high volume of claims, resulting in a longer processing time. Why not send claims in early to avoid the rush?

The Agri-Food Industry Development Fund has received 115 applications in all categories. The final deadline for Programs and Business Risk Management to receive claims for Categories A-D is March 1, 2010.

The Innovation Fund has reporting and claiming requirements in March as well. If you were a successful applicant in Categories B: Supporting the Innovation Capacity of Farmers or Category C: Innovation and Commercialization of New Opportunities for Agri-Based Products please refer to the terms listed in your Letter of Agreement to ensure you comply with the deadlines for your project.

### **Orchard and Vineyard Transition Program (OVTP)**

Applications are being accepted for the 2009-10 program year. Currently the funding for the OVTP program is fully committed, however, applications are being held in sequence based on the date they were received. Letters of Agreement (LOA) for orchard/vineyard removal will be awarded as funding becomes available. For the 2009-10 program year, an application must be received

and an onsite pre-inspection must be conducted before work begins.

For project work approved for the 2008-09 program year, please note the deadline to claim your orchard/vineyard removal project may be approaching. The claim must be received by the Programs and Business Risk Management (PBRM) office by the date indicated in Condition 11 of your Letter of Agreement (LOA). This date stated in your LOA is one year from the date of your first pre-inspection.

**PLEASE NOTE:** For project work approved for the 2009-10 program year, the deadline to claim your orchard/vineyard removal project is March 1, 2010.

## Agricultural Companies Receive Strategic Infrastructure Funding

The province awarded funding to eight agricultural companies to help strengthen their infrastructure and sustainability, Agriculture Minister John MacDonell announced on December 23, 2009.

“We are working with producers and processors to assist them as they develop their economic potential and improve competitiveness,” said Mr. John MacDonell. “These businesses were chosen for their strong business plans and benefits for the agri-food industry as a whole.”

Funding has been approved for:

- Foxhill Cheese House, Port Williams, Kings Co., to expand their processing capacity so they can respond to opportunities to produce new, specialty dairy products
- 2M Farms Ltd., of Berwick, Kings Co. to expand the seed potato operation that will allow the Nova Scotia potato industry to expand into specialty, export markets
- Nova Agri. Inc., Centreville, Kings Co., to support the commercialization of an innovative greenhouse technology that will provide opportunities for the Nova Scotia agriculture industry to meet increasing consumer demand for fresh horticulture products
- Holmstead Cheese Sales Inc., of Aylesford, Kings Co., to meet growing demand for existing cheese products and to develop new product lines

- MacMaster Choice Meats, Antigonish, Antigonish Co., to develop production and processing systems that will result in increased opportunities for the Nova Scotia beef sector to respond to consumer demand for quality beef products
- Eyking Brothers, Millville, Cape Breton Regional Municipality, to develop a facility that will position them to respond to new opportunities in the growing market for value-added vegetable products
- Cogmagun Poultry Processing Co. Ltd., Centre Burlington, Hants Co., to provide enhanced, value-added processing opportunities for Nova Scotia's specialty poultry industry to capitalize on consumer demand for differentiated products
- Northumberland Cooperative Ltd./Brookside Abattoir, of Truro, Colchester Co., to enhance the Nova Scotia agriculture industry's ability to supply high-quality, provincially-inspected lamb and other meat products to existing and new markets.

The eight businesses applied for funding under the third year of the Strategic Infrastructure Investment Fund. To date, \$4.25 million has been committed from the \$6 million, four-year fund.

“The Strategic Infrastructure Investment Fund increases collaboration and partnerships in our industry,” said Mr. MacDonell.

### Crop Insurance

Application Deadlines 2010:

Vegetable - March 14

Potato - April 19

Corn, Soybean - April 30

Spring Grain - March 14

Weather Plan - April 30

All producers who hold an active contract of insurance in one or more of the above plans will receive a Coverage Quote form(s) before the beginning of the crop year. This will give them an opportunity to choose price and coverage level options for the upcoming growing season.

### Advanced Payments Program -

Reminder: If you are planning to apply for an advance through the Advance Payments Program (APP), please keep the above application deadlines in mind. In many cases, the APP requires participation in Crop Insurance as a security for the advance. Late applications for Crop Insurance cannot be accepted after the above dates.

**Dairy Producers** - The Commission is able to write new coverage for dairy livestock each month. If you are not currently enrolled but would like to be, please call our office. If you are interested in insuring your animals against disease, or loss of income from milk sales as a result of disease or fire and building collapse due to ice and snow, it is not too late to apply for Dairy Insurance (includes all reportable diseases except BSF and Foot and Mouth, along with shipping fever and IBR.) To find out more, give the Commission office a call.

**Poultry** - This plan was introduced in October 2007. It offers protection against ILT in broiler, layer and breeder flocks. All producers are encouraged to apply as soon as possible to ensure that they are protected against this risk.

**Weather Plan for Forage** - This plan targets crop losses related to weather events. It guarantees 80 per cent of the average long term rainfall (mm) at a designated local weather station over a period of time (May 1 - August 31). An optional Quality Rider is also available for excessive rainfall in the month of June during prime harvest time. Managed pastures and stored forage acreage can be insured.

**Wildlife Compensation** - The Nova Scotia Crop and Livestock Insurance Commission administers a Wildlife Compensation Program for Nova Scotia farmers who experience losses to animals or crops as a result of damage by wildlife. This program applies to specific livestock as a result of predation by specified wildlife. Similarly specified crops are covered for losses as a result of wildlife damage. There are a number of other requirements to be eligible for this compensation program. Grass-Legume Hay (mixed); Grass Hay – not more than 15 per cent legume; Legume Hay – not more than 15 per cent grass.

Grass Haylage/Silage – not more than 20 per cent legume; Legume Haylage/Silage; Corn Silage.

### Rules

1. All entrants must be bona fide farmers.
2. Only one entry per class per farm enterprise will be accepted.

  - a. Hay: Two 12 cm flakes or equivalent volume. Samples must be boxed. If placed in a plastic bag the sample will mold.

6. Entries will be judged on visual and laboratory analysis. Not all samples will be displayed.
7. All samples must be received by February 15, 2010.

### Judging Criteria

**Corn Silage:** analyses – dry matter, TDN, NDF; visual – odour, length of chop, grain content

**Hay:** analyses – crude protein, ADF, NDF; visual – stage of development, leafiness, colour, odour, softness

**Haylage/Silage:** analyses – dry matter, digestible protein, crude protein, ADF, NDF; visual – colour, odour

Prizes will be awarded for first, second and third place entries.

**Cost:** Chemical analysis will be performed by the provincial feed testing laboratory. Entrants will be charged the standard forage analysis fee for each entry.

Camp Rankin is located in Cape Breton, just outside of St. Peter's at Cape George on the Bras d'Or Lakes. The camp is open to Nova Scotia 4-H members between the ages of 9 and 15. It strives to uphold 4-H's values and traditions, which encourage care and responsibility for our resources as well as teaching positive life skills. Campers attend one of five, week-long sessions running Sunday until Friday. They begin on July 4 and end on August 6, 2010.

Under the supervision of the Camp Director, each camp counselor will follow all camp rules and set a good example for campers. The camp counselor will supervise a group of up to seven campers during the night in individual cabins. ## Tractor Safety Certification

If you have a Class 8 drivers licence and operate tractors on Nova Scotia roads, you must pass this course to be certified to legally haul trailed implements on the road with your tractor. This course is targeted to youth aged 14-16. Topics such as safety, highway regulations, pre-operation checks, safe starts, stops, connecting and hauling various implements will be covered. Any current tractor operator who holds a Class 8 license and has at least 10 hours tractor driving experience is welcome to attend.

At the end of the course, written and driving skills tests will be completed. Participants who obtain 70 per cent on both the written and skills will receive a certificate of achievement from NSAC. For more information or to register, contact Continuing and Distance Education Nova Scotia

NOTE: Dates for certification and recertification are also available in Kentville. For more information please call Sarah or Traci at (902) 798-2114. If you are applying for a pesticide licence for the first time, or your current licence is due to expire and you have not collected any recertification points, then you should take a certification course. Alternately, you may arrange to write the pesticide application exam at a Department of Environment office. Recertification sessions provide five of the 15 required points before your licence expires to recertify without writing an exam.

\* New in 2010, applicators can now accumulate 10 points per year but will need to acquire 15 points within 5 years to qualify for recertification.

## **Forklift Training - Safe Forklift Operation**

Thursday May 13, 2010 - Millville Community Hall - Cost is \$110 per person plus tax (Total \$124.30)

Course begins at 8:30 a.m. sharp.

Section 56 of the Occupational Safety General Regulations states: "An employer shall ensure that a hoist, industrial lift truck or powered mobile equipment (a) is operated by a designated competent person; (b) has gears and moving parts securely guarded by adequate means where necessary to prevent a hazard to a person in the workplace; (c) has any load on it adequately secured where necessary to prevent a hazard to a person in the workplace; and (d) is provided with safe means of access

and exit from the operator's position and any passenger's position."

If you are operating a forklift or other lift truck you must be adequately trained.

The Safe Forklift Operation Course is based on classroom instructional time and actual hands on training on a forklift. Students will be expected to perform basic maneuvers, as well as demonstrate their ability to inspect their lift truck.
