Funding for Energy Projects

There are a number of funding programs available for energy conservation and renewable technologies for Nova Scotia farmers, all with eligibility requirements and levels of funding. Farmers can access up to 80 per cent funding for energy saving opportunities.

The following are three examples:

- Programs and Business Risk Management Division, NS Department of Agriculture, administers federal and provincial funding under the Farm Investment Fund (FIF). Up to 50 per cent funding assistance (up to \$20,000/yr, \$40,000 maximum, depending on gross farm income) is available for various energy conservation and renewable energy technologies for the farm. Up to 75 per cent federal funding (up to \$2000) is available for energy reviews. Farms must have a completed Environmental Farm Plan (EFP) to receive funding for energy conservation items, but the EFP only needs to be initiated for most of the renewable technology items. Although the fund is now closed for 2010, it will reopen in the spring of 2011. Phone 1-866-844-4276 or visit <http://gov.ns.ca/agri/prm/programs/fifguide.shtml>
- Nova Scotia Power Inc. provides up to 50 per cent funding for measures that reduce electrical consumption under their Commercial and Industrial Custom Program. Funds available include up to \$1,000 for an audit, up to \$15,000 for a feasibility study and up to \$500,000 for implementation. The total project should save at least 20,000kwh/yr. Typically, this program is for medium and large industrial customers, but any farm operation not billed on residential rates may qualify. Contact: cicustom@nspower.ca Visit: www.nspower.ca.
- Nova Scotia Power Inc. provides up to 80 per cent funding for efficient lighting upgrades through the Small Business Lighting Solutions Program. A free lighting review is included in this program. This program is intended for businesses that use less than 300,000kwh/yr in electricity. Farms on residential meters also will be accepted into the program. Dead Stock Collection Fee Increase

The dead stock collection system in Nova Scotia has a long and successful history. As in the rest of Canada, the handling of dead stock has changed dramatically since the discovery of Bovine Spongiform Encephalopathy (BSE) in Alberta in 2003. One outcome of this discovery is that

certain portions of cattle carcasses must be kept out of the human food chain and the animal feed chain. These tissues, known as Specified Risk Materials or SRM's, have greatly added to the costs of dealing with cattle carcasses.

New Insurance Program for Maple Producers

Nova Scotia



Maple producers in the province will be better able to manage risks with maple syrup production as Nova Scotia becomes the second province to offer an insurance program.

“With sales of about \$1 million each year, Nova Scotia maple producers are creating jobs and growing the economy,” said Agriculture Minister John MacDonell. “We are showing genuine leadership by working with the maple industry to provide an insurance program that reflects the needs of the sector.”

The maple insurance plan, developed in consultation with industry, helps producers manage risks such as disease, weather, and wildlife.

“Extending insurance coverage to include maple production is a ‘sweet’ boost to Nova Scotia maple producers

Without the costs of dealing with SRM’s, the current dead stock collection system would be operating on a cost-recovery basis, with users of the system paying over \$0.065 per pound for the pick up and disposal of animal carcasses. In addition to the portion of the cost covered by service users, the Canadian Food Inspection Agency currently provides some funding for collection of cattle specimens for BSE testing. Even with this additional revenue going into the program, the Dead Stock Collection Services Committee has determined that the actual cost for disposal is between \$0.095 and \$0.10 per pound, a difference of at least three cents per pound.

Over the past few years, federal and provincial programs were in place to look for ways to properly dispose of SRM’s. This included research into composting methods and developing disposal sites capable of properly dealing with these materials. Now that this funding has ended, the full

cost of disposal must now be dealt with. As the program has accumulated a small surplus over the past few years, that money is currently being used to cover the shortfall.

Rather than wait for this money to run out, the Dead Stock Collection Services Committee has approved a fee increase to users of \$.01 per pound, bringing the cost to producers and other service users to \$0.075 per pound. For a 750 pound carcass that would mean an increase of \$7.50, for a total cost of \$56.25 for the pick-up and disposal of that carcass. This increase is scheduled to go into effect this November.

As outlined in this article, this is not a complete solution. The Dead Stock Collection Services Committee will continue to look for ways to address this shortfall, while continuing to ensure that animal waste in Nova Scotia is dealt with in a safe and environmentally sustainable manner.

having to deal with problems like ice storms, drought, insects or fire,” said federal Agriculture Minister Gerry Ritz. “This cost-shared program will add to the suite of stable, bankable and predictable tools to help manage the risks of farming.”

The plan falls under AgriInsurance, a business risk-management program supported through Growing Forward, a federal-provincial agriculture initiative. AgriInsurance provides protection to 35 commercially grown crops in Nova Scotia.

Maple syrup producers in the province will be eligible for coverage beginning with the 2010-11 production season.

“Maple producers have had to deal

with significant weather events and other conditions in recent years that have impacted their operations and production levels,” said Murray Johnson, president, Maple Producers Association of Nova Scotia. “We are pleased to have an insurance program for our producers which will help us manage some of the risks we face as an industry.”

The Nova Scotia maple industry includes 36,000 acres of maple trees and 300,000 taps. About 70 commercial maple producers make more than 100,000 litres of maple syrup each year.

The Nova Scotia Crop and Livestock Insurance Commission manages crop and livestock insurance programs in Nova Scotia.

The contribution of small-scale farmers to the province’s rural economy was celebrated on Sunday, September 12 at the Halifax County Exhibition Grounds in Middle Musquodoboit.

The Celebration of Small-Scale Farming event was organized by the department’s THINKFARM Working Group and Central Regional Office in partnership with AgraPoint. The event was co-sponsored by the Department of Economic and Rural Development.

Farmer-led workshops covered topics like small farm equipment, soap making, meat quality, seedling management, irrigation systems, buying used tractors and other farm equipment, livestock health, pastured

livestock, farming with horses, beekeeping and cheese making. There was also a women’s panel on farming and rural life. The keynote address was given by Ed Belzer, a farmer from Middle Musquodoboit who does all his field work with draft horses.

Programs and Business Risk Management

AgriInvest and AgriStability

AgriInvest and AgriStability are business risk management programs designed to help producers protect their income and manage risks such as drought, flooding, low prices, and increased input costs.

AgriInvest provides farmers with flexible coverage for small income declines as well as support for investments to mitigate risks or improve market income. Farmers deposit money into an AgriInvest account and receive matching government contributions. If you receive an AgriInvest deposit notice you have 90 days to respond by making your deposit.

2009 AgriInvest Deposit Notices

2009 AgriInvest Deposit Notices are starting to be mailed out with information on how to make your 2009 deposit.

For 2009 you can make your AgriInvest deposits at a participating bank of your choice. Once you have received your 2009 deposit notice you can open an account at your financial institution and make the 2009 AgriInvest deposit by the deadline indicated on their Deposit Notice to receive a matching contribution from governments.

Existing funds currently held by the federal government will be transferred to your AgriInvest account with the financial institution. Producers can request a withdrawal from their AgriInvest account through their financial institution at any time throughout the year.

AgriStability is a margin-based program that provides support when a farmer experiences larger farm income losses. AgriStability covers declines of more than 15 per cent in a

farmer's average income from previous years.

If you participated in AgriStability 2009 you will automatically be enrolled for 2010 and will receive a 2010 enrolment notice soon. If you have not received your 2010 enrollment notice and have not heard from AgriStability you should contact them at the number below.

New Participants or Farmers - AgriStability 2010 Enrolment

Producers who did not participate in 2010 AgriStability and wish to participate in 2011 must request a New Participant package before April 30, 2011. To request an AgriStability New Participant Package or for more information, visit the AgriStability website at www.agr.gc.ca/AgriStability or call AgriStability toll free at 1-866-367-8506.

AgriStability 2010 Interim Applications Are Available

The Interim Application is available for producers who would like to apply for an advance for the 2010 program year. As a program participant, you cannot receive your full 2010 AgriStability payment until your 2010 program year is complete. By using the Interim Application, you can estimate your 2010 income and expenses and receive a portion of this payment early. The deadline to apply for the interim is March 31, 2011.

AgriStability/AgriInvest 2009 harmonized form final deadline

If you missed the September 30, 2010 deadline, you can still submit your form until December 31, 2010 with a \$500/month reduction to your payment.

AgriStability 2010 final fee deadline

Fees paid after April 30, 2010 will have a 20 per cent penalty added. You must pay your fee by December 31, 2010 or you will be ineligible to

participate in AgriStability for the 2010 program year.

It is claiming time for the Farm Investment Fund (FIF). You are encouraged to claim projects as they are completed, which may help you cash manage for multiple approved projects. There is no limit to the amount of claims you may submit. The final claiming deadline is March 1, 2011.

The **Agri-Food Industry Development Fund (AFIDF)** program is currently open and applications are still being accepted for AFIDF program categories A through C.

The **Innovation Fund** Category A: Technology Development is currently open on the PBRM website with one remaining call date of December 1, 2010. Category B: Supporting the Innovation Capacity of Farmers and Category C: Innovation and Commercialization of New Opportunities for Agri-Based Products are closed.

Agriculture Services Branch Priorities: An Update

In December 2009, I highlighted the Agriculture Services Branch's strategic priorities for 2009-2010, which included: regional field services; industry transition initiatives and land stewardship. Since that time, I am pleased to report that we have made significant progress in these areas. I would like to highlight a few of our accomplishments in addition to providing an update on how the Agriculture Services Branch is exploring ways to improve our delivery of services.

Over the past year, we have seen some positive progress towards integrating and enhancing regional field services capacity. Our plan is to create regional field service clusters in five areas of the province designed to bring together expertise to work on regional development opportunities. Teams are comprised of agricultural resource coordinators, transition officers and rural leadership coordinators. Teams are supported by other department staff. They are working to collaborate and form networks with other government departments, stakeholders and partners.

So far we have restructured our office in Truro, which serves the Central Region and established a new office in Cornwallis which serves the South – West Region. Our staff in Cornwallis are co-located with the local Regional Development Authority. We feel this is a positive move in terms of providing better coordination and linkages between agriculture and other development partners.

In addition to our office restructuring, our regional service capacity has been enhanced with the addition of two new transition officers to serve the South – West Nova and

North - Eastern regions. We are currently in the process of filling a similar position for the Valley region, as well as a transition officer serving Central Nova Scotia. In addition to our office moves, Agriculture Services staff are involved in numerous initiatives designed to improve service delivery to our clients.

Our Service Delivery Improvement Committee has initiated a client satisfaction survey which will provide valuable feedback to the Department on priorities for improving service. The group is also partnering with Agriculture and Agri-Food Canada on the development of a 'single window' to federal and provincial programs, which includes a diagnostic tool that will make it easier to match programs and services to identified client needs.

Our ThinkFarm Working Group have been busy on a series of initiatives designed to attract and support new entrants to the agriculture sector. The ThinkFarm campaign and website www.thinkfarm.ca were officially announced by Minister MacDonell in August at the Provincial Exhibition and includes information for new entrants such as; credit opportunities; support for farm business development and innovation; educational resources and other topics.

Agriculture Services staff have also strengthened our partnerships within the department and with other government departments, as well as the private sector, to enhance the effectiveness of our programs and services. The continued development of partnerships with stakeholders in rural communities will also increase the branch's capacity to deliver

information, programs and services to clients as well as building new relationships to address critical issues.

Work in land stewardship continues to be a priority for the Agriculture Services Branch. One of the key challenges we face is to find ways to help Nova Scotians understand the value of dykelands, the service that we provide and development of new partnerships for maintaining the dykelands. Agriculture Services staff are in the process of compiling an analysis of our dykelands which will provide us with a better picture of the infrastructure that is being protected.

Review selection committees, established to review and assess applications to the Department's grant programs such as the Agri-Food Industry Development Fund and Innovation Fund programs, have been reorganized to include representation from the Nova Scotia Federation of Agriculture, Agriculture and Agri-Food Canada, Nova Scotia Business Inc., Atlantic Canada Opportunities Agency, Nova Scotia Agricultural College and other post-secondary institutions, etc. This new committee structure has improved administration of development funding and has had very positive results on engaging new partners in support of agriculture initiatives.

I joined the Agriculture Services Branch a couple of years ago and continue to be impressed with the quality of our programs and service. I am also extremely proud of the dedication of our Branch staff to developing Nova Scotia agriculture and the support of our partners.

I've learned skills that I will use everyday!"

Young people from nine to 21 years old can be a member in 4-H. 4-H encourages leadership development, care and responsibility for our resources and builds positive life skills to secure the future of rural communities. Do You Have the Proper Driver's Licence?

If you have a farm tractor trailer combination over 14,000 kg you need a Condition 23 Endorsement. If you are hauling any trailer (with a truck or tractor) that has a weight over 4500 kg you need a Condition 15 Endorsement on your licence to legally drive on Nova Scotia roads. These regulations apply to class 5 licence. If you are interested in obtaining these endorsements contact Michael Kittilsen at (902) 893-3645 or kittilma@gov.ns.ca.

Process for Cond 15:

1. Purchase a Road Test Receipt which costs \$47.68 (HST Incl.) This can be purchased at an Access Nova Scotia Center or online at <http://www.gov.ns.ca/snsmr/rmv/licence/>

Process for Cond 23:

- Complete a Condition 23 application prior to testing
- Have driver's medical exam completed by your doctor
- Purchase a Road Test Receipt which costs \$46.85 (HST Incl.). This can be purchased at an Access Nova Scotia Centre or online at <http://www.gov.ns.ca/snsmr/rmv/licence/>

You must register with the Central office first and have a valid drivers license ("N" removed) to be eligible for testing. The Condition 23 application, the form for the medical exam and more information is available by calling (902) 893-3645 and speaking to Michael.

Disposal of Used Farm Sharps



The Agriculture offices in Sydney and Mabou still have a supply of sharps containers available at no cost for producers. Remember, sharps must not be discarded in regular household garbage. Sharps should be collected on farms in rigid, puncture-resistant containers with tightly secured lids.

Drop in to pick up your containers during our regular office hours or for more information contact (902) 563-2000.

Attention: Recycling Used Pesticide Containers Here's What to Do:

1. Allow the formulation to drain from the container for at least 30 seconds.
2. Add at least 20 per cent of the contents of water to the container, replace lid, and rotate so that the interior of the container is rinsed.
3. Empty the rinse water into the spray tank and drain for 30 seconds.
4. Repeat the above procedure twice more.
5. Render containers unuseable by puncturing.
6. Leave label on the container.

Containers that have been handled in this way are technically suitable for disposal.

The United Farmers Co-op on Keltic Drive in Sydney River is now accepting properly cleaned pesticide containers for recycling. You can drop off containers at the Co-op Country Store for recycling. Please see staff prior to dropping off containers.

No five-gallon buckets or plastic bags accepted.

Organizing Agriculture in the Community

In partnership with the Antigonish Guysborough Federation a series of Call To Action meetings were held this past spring. To effectively move the agricultural agenda forward, producers need to be in the driver's seat in building effective partnerships between farmers, community members and government service providers. A plan was developed with five priorities:

- making farms profitable
- market opportunities
- culture change – opinions of farmers and consumers.
- leadership – getting producers in the drivers seat.
- loss of knowledge and experience with people exiting the industry

The group decided that the two areas of focus should be local food and biomass. Project teams were developed for both topics. Please contact the local office if you wish to get involved. The Pictou Regional Development Commission attended the workshops and the goal is to incorporate the same model into the Pictou strategy this fall.

Local Food Strategy

A group of producers, public, community organizations and key stakeholders are working on local food initiatives. The group is currently working on a quick success that all participants can see value and encourage further momentum. A meeting connecting with the community is being held Thursday, October 21, 2010, Assembly Hall, Bethany at 6:30 p.m., where the quick success will be pitched and the group asked to complete. Biomass

A group of interested producers will meet in November in Antigonish to review current information and begin to investigate the feasibility of growing grass to produce pellets as a form of biomass in this Region. AgraPoint, the Antigonish Regional Development Authority (ARDA), and the Pictou Regional Development Commission (PRDC) are resources for the committee. The committee is only in its infancy and we are expecting great progress this Fall. Anyone interested in attending this meeting please contact the local office.

Farm Safety Pilot

A pilot project in partnership with the Antigonish/Guysborough Federation was initiated to engage farmers in discussion of safety in their local communities and to create a sustainable model.

Project partners also included AgraPoint and two local fire departments: St. Andrews and Pomquet, Antigonish County. Meetings were held in each community inviting farmers and firefighters, a needs assessment was developed and a commitment to work towards the following list of safety topics was established:

- farm safety canisters – providing farm maps and hazards during fire
- tail gate meetings
- safety day
- first on the scene training
- farm safe work procedures

A summer student was hired to develop a plan, conduct farm visits and complete the information to be contained in the canister for each farm. A presentation on the pilot project is planned for the Federation AGM. We are currently working on setting up a followup meeting in the fall to move forward on the other topics.
