Sonic Devices Regulations in Effect

Nova Scotia farmers now have regulations to guide their use of devices that emit sounds to deter birds and animals from destroying crops or livestock.

The Sonic Devices Regulations under the *Farm Practices Act* set reasonable parameters for farmers, spelling out the volume and distance from property borders required to deter predators while not causing a disturbance for neighbours.

The regulations are designed to minimize the impact of sonic devices on neighbours and to maximize their effectiveness against crop predators. They reflect crops grown in Nova Scotia, and set the times when sonic devices may be used, the minimum intervals between firings, and minimum distances to other properties.

The regulations will affect mainly farmers who grow fruit, tree nuts, and grapes. There are about 475 farms in these categories in Nova Scotia. Most farmers will not have to make any changes to comply, and any changes that some farmers will need to make are minimal.



The regulations were recommended by the Farm Practices Board and are modeled on codes of practice in Ontario and British Columbia that are working well and have been generally supported by farmers. Nova Scotia has developed regulations because the *Farm Practices Act* only provides for regulations to be developed, rather than codes of practice.

To learn about sonic devices and best practices with them, the Department of Agriculture consulted subject matter experts at Perennia (formerly AgraPoint), the Nova Scotia Federation of Agriculture, the Nova Scotia Fruit Growers Association, Horticulture Nova Scotia, the Grape Growers Association of Nova Scotia, and the Wild Blueberry Producers Association of Nova Scotia.

The regulations are in effect as of August 31, 2012. They were published in the Royal Gazette on September 21 at www.gov.ns.ca/just/regulations/rg2/2012/se2112.pdf. They are posted under Agriculture, *Farm Practices Act* on the Registry of Regulations website at www.gov.ns.ca/just/regulations.

Better Protection for Agricultural Land

Farmers, municipalities and the province will be able to better protect agricultural land in Nova Scotia, thanks to new information and guidance available to them.

A new report on agricultural land use includes 28 recommendations to help protect agricultural land from development and preserve it for the future.

“Taking good care of our land is a priority for government, and we are committed to helping municipalities and the agriculture industry do the same,” said Agriculture Minister John MacDonell. “Farmers and others who rely on the land to help them earn a living know how important it is to protect and enhance it so it’s available now and for generations to come.”

The report identifies roles for the province, municipalities and the agriculture industry to protect and preserve land. It recommends a mix of regulations, bylaws, codes, policies, guidelines, incentives and education.

Recommendations include:

- setting clearly defined land-use planning criteria
- considering more effective policies and other tools that help make agriculture businesses profitable
- building on initiatives that raise Nova Scotians' awareness of and support for agriculture
- clarifying roles and evaluating guidelines for soil erosion and removing topsoil
- minimizing conflicts between agriculture landowners and neighbours through municipal planning and raising awareness of industry needs

Also, under the *Municipal Government Act*, there are five statements of provincial interest that must be considered in comprehensive municipal planning. Service Nova Scotia and Municipal Relations will soon be seeking input from municipalities to improve the statement for agriculture.

In Nova Scotia, there are about 3,900 farms employing about 5,200 people. In 2011, the industry generated \$539.7 million in farm cash receipts and \$229 million in international exports.

“The protection of quality agricultural land is important not only to promote local food production, but as an economic driver for rural Nova Scotia,” said Union of Nova Scotia Municipalities (UNSM) president Jim Smith. “The UNSM looks forward to working with the province and municipalities to develop a consistent policy framework to address the protection of agricultural lands. The report recommendations represent a good first step.”

The framework recommends the agriculture industry continue working to raise awareness of its economic and community contributions, and to educate members on best practices to keep soil productive.

“We are pleased with the recommendations presented in the report on protecting and preserving agricultural land,” said Beth Densmore, president of the Nova Scotia Federation of Agriculture. “We continue to support the idea of a provincial framework for land use and encourage the Nova Scotia government to move forward in consultation with the farm community.”

The report was developed by a working group with representatives from the departments of Agriculture, Service Nova Scotia and Municipal Relations and Natural Resources. The group's report, *Protecting and Preserving Agricultural Land in Nova Scotia*, is available at www.gov.ns.ca/agri.



Exploring the New Farm Dream

A four-session course called “Exploring the New Farm Dream” will be held this November in five locations around the province: Cornwallis, Bridgewater, Halifax, Tatamagouche, and Port Hawkesbury. It will help them decide whether or not this is the path they want or can take. Nova Scotia Crop and Livestock Insurance Commission

AgriInsurance

Wildlife Compensation

The Nova Scotia Crop and Livestock Insurance Commission administers a Wildlife Compensation Program in Nova Scotia. This program is currently available for wildlife damage to 24 types of crops and/or predation by wildlife on 14 types of livestock, at no cost to producers. A complete list of eligible crops and livestock are available on the commission website at www.gov.ns.ca/agri/ci.

Producers who apply for compensation should be aware of the following requirements of this program:

- Farmers must notify the commission as soon as possible and not later than 72 hours after the damage has occurred or has begun to occur.
- The cause of any loss must be confirmed by the commission.
- Industry production and protection standards must be followed to be eligible for a claim, (e.g., fencing, deterrents, etc., for honey or bumble bees - fencing or caging are required)
- For crop damage, you must incur a loss of at least \$250 or two acres.
- For livestock damage, only losses as a result of black bear, fox, coyote, raven or crow, or birds of prey are eligible.
- To be eligible for compensation payments, you must be a current Registered Farm under the *NS Farm Registration Act*.

To settle a wildlife compensation claim, the commission must be able to:

- (1) confirm that the damage was beyond the control of the producer
- (2) attribute the damage to wildlife
- (3) measure the damage.

Advanced Payments Program

Any producers thinking about participating in the Advance Payments Program in 2013 are reminded that many of the organizations administering this credit program may require you to have crop insurance as a condition of securing the loan. Any producer who is considering taking advantage of this interest free loan should contact the appropriate agency that is administering the loan for details on their requirements.

We will advise all producers to take note of the deadlines for applying for crop insurance if it is one of the conditions for obtaining a loan. In order to obtain coverage for 2013, new applicants must apply before the application deadline.

In previous years, crops covered under the Advance Payments Program included most spring grains, corn, soybeans, a wide variety of vegetables and small fruits, apples and potatoes.

Application Deadlines for 2013

Spring grain - March 14
Vegetable - March 14
Potato - April 19
Corn - April 30
Maple - April 30
Weather plan - April 30
Soybean, canola, sunflower - May 19

All producers who hold an active contract of insurance will receive a coverage quote form(s) before the beginning of the crop year, for most of the above plans. This will give them an opportunity to choose their price option and coverage level for the upcoming growing season. Anyone considering applying for crop insurance for the first time must make their application on or before the dates noted above.

Peaches Now Covered Under AgriInsurance

Nova Scotia peach growers can now insure their fresh fruit crop under the commission's existing Tree Fruit Plan for the 2013 year. Producers interested in participating must apply prior to November 30.

AgriInsurance Fall Harvest Season Reminders

- The crop year end for several fall harvested crops is quickly approaching. These include:
Corn - November 15
Potato - December 20
Soybean - November 1
Tree fruit - November 30
Vegetable - November 15

- Your AgriInsurance contract requires you to report your harvest within 30 days of the last day of harvest or the end of the crop year whichever is earlier.
- If you are in a potential claim (your actual yield is less than your crop insurance production guarantee) then you must apply for a claim on a Proof of Loss form, no later than 30 days after harvest or the end of the crop year whichever is earlier.
- If you are unable to harvest your crop by the crop year end date, you must file a notice of damage and report the reasons to our office.

Programs and Business Risk Management

AgriInvest and AgriStability

AgriInvest and AgriStability are business risk management programs designed to help producers protect their income and manage risks, such as drought, flooding, low prices, and increased input costs. AgriInvest provides farmers with flexible coverage for small income declines as well as support for investments to mitigate risks or improve market income. Farmers deposit money into an AgriInvest account and receive matching government contributions. If you receive an AgriInvest deposit notice you have 90 days to respond by making your deposit.

AgriInvest Deposit Notices

AgriInvest deposit notices are being mailed out with information on how to make your deposit and receive matching government contribution. Once you receive your notice, follow the instructions included to make your deposit. The deadline to make the deposit is indicated on the Deposit Notice.

Producers can request a withdrawal from their AgriInvest account through their financial institution at any time throughout the year. For more information, contact the AgriInvest administration 1-866-367-8506 or visit the website at www.agr.gc.ca/AgriInvest.

AgriStability

AgriStability is a margin-based program that provides support when a farmer experiences larger farm income losses. AgriStability covers declines of more than 15 per cent in a farmer's average income from previous years. If you are a participant in AgriStability, you will automatically be enrolled for each year and will be sent an enrollment notice and fee amount to be paid by a deadline.

New Participants or Farmers

AgriStability 2013 Enrolment Producers who did not enroll to participate in 2012 AgriStability and wish to participate in 2013 must request a new participant package before April 30, 2013. Nova Scotia 4-H Members to Attend the Royal Winter Fair

Nineteen 4-H livestock members with the highest caliber dairy and beef heifers were selected to be on the Nova Scotia teams participating in two prestigious cattle shows at the Royal Agricultural Winter Fair. The selections for the Royal Dairy Classic and the Royal Canadian Junior Beef Heifer Classic were made based on the quality of their calf on Saturday, September 29, at the Nova Scotia 4-H Show.

Ten Nova Scotia dairy members will compete against 4-H members from across Canada in the Royal Dairy Classic in November. Five members on the Nova Scotia dairy team are from Inverness County: Hayley, Robin and Darcie Wilson, Becky Lowe, and Sarah MacDonnell; Marshall Ellis and Andrew Eikelenboom are from Halifax East Hants; and Jacob Greenough from Hants County. The spare is Emma Thomson from Antigonish County.

Darcie Wilson won the Versteeg Memorial Award. This award is presented to a 4-H dairy member based on a 50/ 50 split for the conformation of the calf and their showmanship ability.

The dedicated work of the Royal Dairy Classic Committee and the Royal Canadian Junior Beef Heifer Classic Selections committee results in the 4-H members being able to attend the Royal Winter Fair and compete in the cattle classes. The Nova Scotia committee members obtain funding sponsorship and organize this event on a provincial and national level. Annual financial support from major sponsors, producers,

individuals and businesses, provide the 4-H delegates with this tremendous opportunity.

The nine members representing Nova Scotia with their beef heifers at the Canadian Junior Beef Heifer Classic are Connor Morse, Victor Horsenell and Breagh Ross from Kings County; Sarah Manthorne and Brady Baker, Cumberland County; Wyatt Oulton and Jacoba Ronduis, Hants County; Andrew Greene, Pictou County; and Leanne

While at the Royal, 4-H members will compete in the showmanship and conformation cattle classes, participate in a provincial display contest and spend a day seeing the rest of the events at the exhibition.



4-H Member Wins Young Speakers for Agriculture Competition

4-H members had the opportunity to speak about their enthusiasm for agriculture at the provincial Young Speakers for Agriculture competition at the Nova Scotia 4-H Show in Truro on September 28. Morgan MacNeil, Hants County won the provincial competition and will represent Nova Scotia 4-H at the 28th annual Canadian Young Speakers of Agriculture National Senior Public Speaking Competition at the Royal Agricultural Winter Fair in Toronto, Ontario on Saturday, November 3.

The winner of the provincial competition is sponsored by the Nova Scotia 4-H Council and must be 16 - 24 years of age, as of January 1 to enter the national contest. During the competition, each contestant will give a five to seven-minute prepared speech on one of five selected topics, as well

as introduce and thank another speaker. Morgan's speech was titled The Importance of Water for Agriculture and Globalization.

4-H members are encouraged to do public speaking and demonstrations along with their project work during the 4-H year. Each spring 4-H clubs, counties and regions hold communications competitions. In an Ipsos Reid survey commissioned by the Canadian 4-H Council, 74 per cent of alumni said their experiences as a member was very beneficial in terms of contributing to personal or career experiences later in life. “In 4-H, I’ve taken on various leadership roles including president of my club and the King’s County 4-H Leader’s Council president. I’ve also held office as the county and club vice-president, county secretary and treasurer,” said Meghan Chisholm, an 18-year-old from the Central Valley 4-H Club. “Through the Junior Leaders project, I’ve organized and lead events for the light horse and miniature horse project. I’m also involved with my county’s tug-of-war team and have met many life-long friends through this wonderful organization”.

Young people aged 9-21 can be a member in 4-H. 4-H encourages leadership development, care and responsibility for our resources and builds positive life skills to secure the future of rural communities. Originally, the 4-H clubs consisted mainly of farm youth and focused on livestock projects. Today, the 4-H program still has an agriculture base but prides itself with moving with the times, developing projects to meet the needs of modern youth.

Jessica Overmars’ experience with the St. Andrew’s 4-H Club in Antigonish County helped her build confidence and decide on a career as a pharmacist.

“4-H has prepared me for the future and has given me the skills to succeed. I have been accepted to a B.Sc. Program at St. F.X. University,” said 18-year-old Jessica. “I chose the program because science allows me to learn to do by doing, which is a skill I’ve acquired through years of practice as a 4-H member. Through 4-H, I’ve developed a good attitude towards learning, learned how to be a team player, participated in new experiences, developed responsibility, have acquired leadership skills and life-long skills to be successful in the competitive world of today.”

4-H members can choose from over 40 projects and still learn to do by doing. Projects help develop technical and record keeping skills in youth while teaching them responsibility. They take pride in doing their best, making decisions and seeing projects through to completion. Youth grow up with confidence in their own skills and talents, as well as the caring and sharing of community spirit. 4-H members also have the opportunity to travel on national and international exchange programs, participate in cutting-edge provincial and national conferences, as well as apply for more than \$100,000 in national scholarships.

We have so much to celebrate. A national survey of 4-H alumni conducted by Ispos Reid and commissioned by the Canadian 4-H Council found that 88 per cent said the key goals and objectives of 4-H are relevant to today’s youth. Also, 85 per cent of former 4-H members would recommend membership to young people.

4-H Member to Attend the International Judging Seminar

Andrew Greene, a 4-H member from Pictou County will represent Nova Scotia at the Canadian National 4-H and Youth Judging Seminar during the Canadian Western Agribition in Regina, Saskatchewan.

During the Grand Champion Judging Competition at the Nova Scotia 4-H Show in September, Andrew placed three livestock and three life skills classes and gave oral reasons on four of them to win the trip to Agribition.

From November 18 - 20, Andrew will attend the International 4-H Judging Seminar along with as many as 80 delegates from across Canada and the United States. This competition fosters the future development of young judges for the agricultural industry and provides a high profile and competitive judging experience.

Competitors must be 17 - 21 years of age to participate in this international judging competition.

They will compete in judging livestock classes and provide oral reasons to a judge in identified classes.

Aggregate scores will be based on total scores of the classes plus scores of the oral reasons. Cash prizes will be awarded to the Grand Aggregate and the highest placing Canadian competitor.

During the year, Nova Scotia 4-H members learn to judge the

projects in which they are enrolled. Each member compares four items or animals (related to their project topic), places them from best to worst and give reasons for their placing. Besides developing confidence in 4-H members, the judging exercise teaches them decision making, communication skills and how to deliver their opinions with conviction.
