Nova Scotia Crop and Livestock Insurance Commission

Why should I have AgriInsurance?

As a producer you are constantly faced with factors that are beyond your control. Things like adverse weather, disease, wildlife, and insect infestations can have a serious impact on your production and your income.

AgriInsurance, also referred to as Production Insurance or Crop Insurance, adds some predictability to your business. It protects you against the effects of yield reductions and crop losses caused by insured perils. Last year there were more than 26,000 acres; 21,500 dairy animals; and 21 million birds insured annually in Nova Scotia.

AgriInsurance helps you:

- Maintain your cash flow in poor crop years with claim payments that offset losses caused by crop damage or low yields.
- Manage your operation with a more predictable cash flow.
- Provide collateral required to secure loans.
- Stabilize your AgriStability program reference margin over time.
- Gain affordable peace-of-mind by paying tax-deductible premiums that are cost-shared with government.

Crop Insurance Application Deadlines 2014

- Vegetable - March 14
- Spring Grain - March 14
- Potato - April 19
- Corn - April 30
- Maple - April 30
- Weather Plan - April 30
- Soybean (includes Canola and Sunflower) - May 19

All producers who hold an active contract of insurance will receive a Coverage Quote form(s) before the beginning of the crop year, for most of the above plans, except for the Weather Derivative Plan, which must be applied for annually. This will give them an opportunity to choose their price and coverage level options for the upcoming growing season.

Advanced Payments Program

Reminder: If you are planning to apply for an advance through the Advance Payments Program (APP), keep the above application deadlines in mind. In many cases, the APP requires participation in Crop Insurance (or AgriStability) as a security for the advance. Late applications for Crop Insurance cannot be accepted after the above dates.

Dairy Producers

The Commission is able to write new coverage for dairy livestock at any time during the year. If you are interested in insuring your animals against disease, as well as loss of income from milk sales as a result of disease or fire, and building collapse due to ice and snow, it is not too late to apply for Dairy Insurance (includes all reportable diseases, as well as shipping fever and IBR, but does not include BSE and Foot and Mouth). Wildlife Compensation

The Nova Scotia Crop and Livestock Insurance Commission administers a Wildlife Compensation Program for Nova Scotia farmers who experience losses to animals or crops as a result of uncontrollable wildlife. This program applies to specific livestock as a result of predation by specified wildlife. Similarly specified crops are covered for losses as a result of wildlife damage. There are a number of other requirements to be eligible for this compensation program. Maple Producers

The Nova Scotia Crop and Livestock Insurance Commission offers crop insurance for maple syrup production. This plan is available to all commercial maple producers to help them manage the risk of reduced yields due to natural perils. Any producers not currently signed up in the program can apply now for coverage for the 2014-15 crop year (the February-March 2015 harvest season). **The deadline for applying is April 30, 2014.** Since this is a busy time in the maple woods, we encourage you to apply now to avoid missing the deadline.

Forage Producers

The Commission offers two plans for forage producers to help manage the risk in this crop from natural perils. These plans are a Forage Establishment Plan and a Weather Derivative Plan for Forage Production.

Forage Establishment Plan

The Forage Establishment Plan protects against establishment failure in the first year of growth for grasses, alfalfa and other legumes. This plan covers losses from such things as winter injury, drought, insects, diseases, floods, excess moisture, frost and wind. The plan covers your new forage crop from the time of seeding up until May 31 of the following year. Seeding must be completed by July 1 for legumes and legume/grass mixes and by September 1 for grasses. The deadline date to apply for this insurance is October 15, but you can apply as soon as your crop is seeded. When you apply for this insurance at seeding time, your coverage can begin immediately. If you apply at some point after your seeding date, an inspection is required before coverage will be offered. This plan offers two levels of coverage which are \$200/acre coverage (producer premium = \$4.00/acre) and \$100/acre coverage (producer premium = \$2.00/acre).

Weather Plan for Forage

This plan targets crop losses related to weather events. It guarantees 80 per cent of the average long term rainfall (mm) at a designated local weather station over a period of time (May 1 - August 31). An optional quality rider is also available for excessive rainfall in the month of June during prime harvest time. Managed pastures and stored forage acreage can be insured. The Weather Derivative Plan for Forage provides a guarantee of 80 per cent of the long term average rainfall (30 year averages). A producer can choose two, three or four months of drought coverage between May 1 - August 31. Any part or all of the managed forage and/or pasture on your farm can be insured for up to \$288 per acre.

An optional quality rider can also be purchased for the month of June. When three consecutive days of rainfall of at least 5 mm are recorded, a payment of 20 per cent of your guarantee is triggered. Producers can receive up to two payments under this quality rider during the month of June. For the weather plan, rainfall measurements are based on the recorded rainfall from sites around the province, primarily at Environment Canada weather stations. Producers select the site nearest their farm. This plan differs from other insurance plans since there are no yield measurements required. Once a drought or excess rainfall event occurs, based on Environment Canada weather statistics, a payment is triggered.

Both the Weather Derivative Plan for Forage and the Forage Establishment Plan require an annual application. For more information including the cost sharing with government for these programs contact one of our offices.

Have you reported your yield for 2013?

To provide accurate coverage to our clients, the Commission needs your harvested yield report for 2013. If clients do not report their actual yield, the Commission assumes you harvested at least the guaranteed production listed on your Certificate of Insurance. In years where you had very good production and where you do not report to the Commission, you are missing an opportunity to have this reflected in your yield history. What this means for you is that in a future claim year, your claim may not be as much as it could have been if the good experience was properly reported. To ensure you have the best coverage possible, be sure to accurately report your yields.

Young Canadian Awarded Scholarship to Live and Work in New Zealand

4-H Canada is pleased to announce the recipient of the 2014 AgriVenture Global Scholarship program. This opportunity allows the scholarship recipient, Bridget Wilson, to work in New Zealand for six-months.

Bridget Wilson, a fourth-year university student pursuing an agriculture degree in Animal Science, Genetics and Molecular Biology, will take part in a six-month program to rural New Zealand. Originally from Skye Glen, Nova Scotia, Wilson is currently enrolled at Dalhousie University. She will live and work on a dairy farm in New Zealand from October through April. The \$3,000 scholarship will be applied towards the AgriVenture program fee.

“Although I have gained a lot of knowledge about agriculture through my schooling, I am in need of more practical, hands-on learning experiences,” said Wilson.

“The AgriVenture scholarship recognizes a 4-H member who is a leader in their club and community” said Allison Sarauer, AgriVenture Program Co-ordinator for Canada. “AgriVenture trainees are ambassadors for Canadian agriculture, and we’re happy to support an outstanding 4-H member or alumni in gaining experience and exposure to the global agriculture scene”.

“4-H Canada is very fortunate that AgriVenture understands the importance of building young leaders,” added Shannon Benner, CEO of 4-H Canada. “This investment embodies the spirit of 4-H leadership because it cultivates self-esteem, responsibility, and self-motivation.”

AgriVenture provides cultural and work experiences to young adults aged 18-30. Wilson had a choice of dairy, beef, sheep or crop placement opportunities in a variety of host countries including New Zealand, Australia, United Kingdom, Denmark, Sweden and others.

Wilson was chosen by Nova Scotia 4-H as the provincial candidate for the scholarship and joined others from across Canada in the competition. Scholarship applicants between the ages of 18 and 30, with two years of 4-H experience, are welcome to apply to their 4-H provincial office by November 1.

The purpose of the three day tour is to give 4-H members, between the ages of 14 -17, opportunities to hear speakers and participate in tours with a business, agriculture and industry format. Visiting a new part of the province will give them a broader perspective on career opportunities, which will help them to confidently make decisions about where they choose to settle when they enter the workforce.

4-H members are selected from across the province for the tour through an application and interview process. During the tour, 4-H members learn about a specific region in the province; the community, community leaders, and the local area resource-based businesses and rural employers. During various social activities they will have many opportunities for networking with 4-H members from the specific region they are visiting.

Mr. Grant was a long time 4-H participant, government public servant, and avid supporter of the Nova Scotia 4-H program. His legacy lives on through a fund that provides a significant endowment to the Nova Scotia 4-H Foundation to assist with rural youth development. Summer Jobs at Camp Rankin

Students who have an interest in working with children and spending time in the outdoors can find a rewarding summer job at Camp Rankin, the provincial 4-H camp. Positions are available for Canoeing; Drama; Nature and Outdoors; Crafts; Recreation and Healthy Living and Exploring 4-H Counselors this summer.

Camp Rankin is located in Cape Breton just outside of St. Peter's at Cape George on the Bras d'Or Lakes. The camp is open to Nova Scotia's 4-H members between the ages of nine and fifteen and strives to uphold 4-H's values and traditions which encourages care and responsibility for our resources and teaches positive life skills to youth. Campers attend one of five camps running Sunday until Friday, beginning June 29 and ending August 1, 2014. A wide range of activities are offered to campers and include hiking, swimming, canoeing, drama, crafts and recreation.

Under the supervision of the Camp Director, each Camp Counsellor will follow all camp rules and set a good example for campers. The Camp Counsellor will supervise a group of up to seven campers during the night in individual cabins and will work with this group during camp activities such as campfires and chapel and during camp chores. Do You Have the Proper Driver's Licence?

If you have a farm tractor trailer combination over 14,000 kg, you need a Condition 23 Endorsement and if you are hauling any trailer (with a truck or tractor) that has a weight over 4500kg, you need a Condition 15 Endorsement on your licence to legally drive on Nova Scotia's roads. These regulations apply to class 5 licence.

ThinkFARM/KCFA Mentoring Workshop

Kings County Federation of Agriculture, with financial sponsorship from ThinkFARM, is organizing a workshop on developing a mentoring network for farmers in Kings County on Saturday, March 22, 9:00 am - 12:00 pm. at the Kentville Agricultural Centre. The workshop will explore the needs of beginning and transitioning farmers in various commodities and identify established farmers experienced in these commodities willing to act as mentors. New and experienced farmers are encouraged to attend in order to develop the best possible network.

A network of mentors is needed because beginning/transitioning farmers can easily get theoretical information on farming through courses offered by NSDA, NSFA, Perennia, and Dalhousie Faculty of Agriculture, but the next step to successful implementation is local information relevant to the region where the farmer is starting up. The best way to obtain this local information (such as micro-climate, local soil characteristics, nuisance wild-life, markets, feed and equipment suppliers, and farmers willing to rent/loan equipment and advice) is from other farmers in the locality. Although other mentoring programs exist (Step-up by FMC, WWOFF exchanges), these are apprenticeship programs where the new farmer has to move to another farm, which many farmers are unable or unwilling to do. Sharp Containers

Livestock producers generate medical waste on a regular basis. These wastes include sharps such as syringes, needles, broken glass tubes, lancets and scalpel blades. If not disposed of properly they can injure livestock and family members; increase risk of infection spread; pollute the environment; and put waste handlers at risk. Sharps must not be discarded in regular household garbage. Sharp containers have been specifically designed for disposing of sharps. When the container is full of sharps, the contents should still be considered potentially infectious to humans and animals but the risk is low. For disposal in any municipality, you must first check with your local disposal site to see what they have in place to accept sharps.

These containers can be picked up at the Department of Agriculture office in Cornwallis Park. Call 638-2395 for hours and information.
