Minister's Message

The Department of Agriculture is committed to helping Nova Scotia's agricultural communities develop, with a view to long-term sustainability.

Why should I have AgriInsurance?

As a producer, you are constantly faced with factors that are beyond your control. Things like adverse weather, disease, wildlife, and insect infestations can have a serious impact on your production and your income.

AgriInsurance, also referred to as Production Insurance or Crop Insurance adds some predictability to your business. It protects you against the effects of yield reductions and crop losses caused by insured perils. Last year there were more than 22,000 acres, 9,472 dairy animals, and 21 million birds insured annually in Nova Scotia.

AgriInsurance helps you:

- Maintain your cash flow in poor crop years with claim payments that offset losses caused by crop damage or low yields.
- Manage your operation with a more predictable cash flow.
- Provide collateral required to secure loans.
- Stabilize your AgriStability program reference margin over time.
- Gain affordable peace-of-mind by paying a tax-deductible premium that is cost-shared with government.

Crop Insurance Application Deadlines 2015

- Vegetable – March 14
- Spring Grain – March 14
- Potato – April 19
- Corn – April 30
- Maple – April 30
- Weather Plan – April 30
- Soybean (includes Canola and Sunflower) – May 19

All producers who hold an active contract of insurance will receive a Coverage Options letters(s) before the beginning of the crop year, for most of the above plans, except for Weather Derivative which must be applied for annually. This gives you an opportunity to choose your price and coverage level options for the upcoming growing season.

Advanced Payments Program

Reminder: If you are planning to apply for an advance through the Advance Payments Program (APP), keep the above application deadlines in mind. In many cases, the APP requires participation in Crop Insurance (or AgriStability) as a security for the advance. Late applications for Crop Insurance cannot be accepted after the above dates.

Dairy Producers

The Commission is able to write new coverage for Dairy Livestock at any time during the year. If you are interested in insuring your animals against disease, as well as loss of income from milk as a result of disease or fire, and building collapse due to ice and snow it is not too late to apply for Dairy Insurance (includes all reportable diseases, as well as shipping fever and IBR, but does not include BSE and Foot and Mouth). To find out more give the Commission office a call.

Wildlife Compensation

The Nova Scotia Crop and Livestock Insurance Commission administers a Wildlife Compensation Program for Nova Scotia farmers who experience losses to animals or crops as a result of uncontrollable wildlife. This program applies to specific livestock as a result of predation by specified wildlife. Similarly, specified crops are eligible for this compensation program. Maple Producers

The Nova Scotia Crop and Livestock Insurance Commission offers crop insurance for maple syrup production. This plan is available to all commercial maple producers to help them manage the risk of reduced yields due to natural perils. Any producers not currently signed up in the program can apply now for coverage for the 2015-16 crop year (the Feb-Mar 2016 harvest season). The deadline for application is April 30, 2015. Since this is a busy time in the maple woods, we encourage you to apply now to avoid missing the deadline.

Forage Producers

The Commission offers two plans for forage producers to help manage the risk in the crop from natural perils. These plans are a Forage Establishment Plan and a Weather Derivative Plan for forage production.

Forage Establishment Plan

The forage establishment plan protects against establishment failure in the first year of growth for grasses, alfalfa and other legumes. This plan covers losses from such things as winter injury, drought, insects, diseases, floods, excess moisture, frost and wind. The plan covers your new forage crop from the time of seeding up until May 31 of the following year. Seeding must be completed by July 1 for legumes and legume/grass mixes and by September 1 for grasses. The deadline to apply for this insurance is October 15, but you can apply as soon as your crop is seeded. When you apply after your seeding date, an inspection is required before coverage will be offered. This plan offers two levels of coverage which are \$200/acre coverage (producer premium - \$5.00/acre) and \$100/acre coverage (producer premium = \$2.50/acre).

Weather Plan for Forage

This plan targets crop losses related to weather events. It guarantees 80% of the average long term rainfall (mm) at a designated local weather station over a period of time (May 1 - August 31). An optional Quality Rider is also available for excessive rainfall in the month of June during prime harvest time. Managed pastures and stored forage acreage can be insured. The Weather Derivative Plan for Forage provides a guarantee of 80% of the long term average rainfall (30 year averages). A producer can choose 2, 3 or 4 months of drought coverage between May 1 and August 31. Any or all of the managed forage and/or pasture on your farm can be insured for up to \$288 per acre.

With the Quality Rider, when three consecutive days of rainfall of at least 5mm are recorded, a payment of 20% of your guarantee is triggered. Producers can receive up to two payments under this quality rider during the month of June. For the weather plan, rainfall measurements are based on the recorded rainfall from sites around the province, primarily at Environment Canada weather stations. Producers select the site nearest their farm. This plan differs from other insurance plans since there are no yield measurements required. Once a drought or excess rainfall even occurs, based on Environment Canada weather statistics, a payment is triggered. Both the Weather Derivative Plan for Forage and the Forage Establishment Plan require an annual application. Have you reported your yield for 2014?

To provide accurate coverage to our clients, the Commission needs your harvested yield report for 2014. If clients do not report their actual yield, the Commission assumes you have harvested at least the guaranteed production listed on your Certificate of Insurance. In years where you had very good production and where you do not report to the Commission, you are missing an opportunity to have this reflected in your yield history. What this means for you is that in a future claim year, your claim may not be as much as it could have been if the good experience was properly reported.

To ensure you have the best coverage possible, be sure to accurately report your yields.

Perennia Project Profiles

The extension, food safety and product development specialists at Perennia have been hard at work on research and client-based projects. Offering support in such a wide variety of areas - from the field to fork - means there are a lot of great stories to share. Here are just a few!

The food scientists and technicians at the Perennia Innovation Centre have been experiencing a high demand from industry for consultations and project work. A recent project with *All Sauced Up*, a Nova Scotia-based sauce, salad dressing and marinade company, saw owner Vicky Gourley working with the Centre to fine tune formulas for four of her best-selling products in preparation for increased production due to retail sales. Gourley also worked with another food scientist affiliated with Perennia, who has worked with clients like VH Sauces, to help perfect her recipes and ensure uniformity.

New packaging options were the key reason the owners of *Made with Local* started working with the team at the Centre. They wanted to improve the shelf-life and stability of their all natural snack bars. Perennia's food scientists offered them a new foil film option that tripled the ambient shelf life of their products. This opened up a whole host of new retail options and markets for the Halifax-based company.

The Centre has a variety of packaging equipment, such as a tube sealing machine which can be used for plastic laminated tube sealing of cosmetics, pharmaceuticals and foods; a vacuum bag sealer which can also be used for dry packaging applications on trays; a modified atmosphere tray sealer to optimize shelf life; and a skin pack machine creating a retail-ready vacuum skin package with film-to-tray, film-to-board and film-to-film options.

Our production specialists have also been working on some exciting projects with real impact for producers. In 2013 and 2014, a Pumpkin Seed Oil Production Project was undertaken to test varieties from Austria and New Zealand. Weed control options and other agronomic characteristics were also assessed. All varieties of oilseed pumpkin performed well in Nova Scotia, yielding 425 - 837kg of dry seeds per hectare.

A Perennia specialist travelled to Austria with Theo and Rosalie Hogeterp (two of the producer co-operators on the project and winners of the Annapolis Valley Chamber of Commerce 2014 Innovation Accelerator Award) to do research on value-added pumpkin seed products. This crop represents an interesting opportunity for the production of oil and snack foods. Ten acres of commercial production is scheduled in the province for 2015.

In the dairy sector, our specialist has been working with a number of dairy producers to determine if rehydrating a cow directly after calving, with a drink containing various nutrients and minerals, would have an effect on metabolic disease and, potentially, milk production. For the last two years, cows have consistently produced an average of four additional litres each day, which, over the course of a lactation is worth approximately \$300 per cow.

Perennia also worked on ketone testing with nine co-operating dairy farms to determine the extent to which fresh cows (cows within the first four weeks of lactation) become ketotic as a means to treat them quickly before health and production are compromised. The co-operating farms were given hand-held testers. In most cases, cows not exhibiting symptoms were found to be ketotic and, thus, were able to be treated quickly before the condition became apparent.

On the food safety front, Perennia's specialists have been all over the province working with food companies that are processing everything from cheese to lamb to all varieties of seafood. *Cedar Bay Grilling Company Ltd.* produces planked salmon products. In 2014, our team worked with Cedar Bay, located in Hubbards, to attain BRC certification. BRC is a globally recognized food safety program and the certification has opened doors for the company to sell their products in global markets like the United Kingdom and Australia. Perennia's food safety team continues to work with Cedar Bay on a regular basis.

The team also worked with *Holmstead Cheese Sales* in the Annapolis Valley to assist in the development of a Safe Quality Food (SQF) program, another globally recognized program that more and more large retailers are requiring of their suppliers. Holmstead recently asked Perennia for further assistance and they successfully achieved recertification, ensuring they can maintain their current markets and expand into more.

SCIANS Advance Payment Program (APP)

Once again, the Soil and Crop Improvement Association of Nova Scotia (SCIANS) has been asked by the federal government to administer the Advance Payment Program for 2015-16. The purpose of the program is to improve marketing opportunities for agricultural products by extending an advance to the producers as a means of improving cash flow.

Any individual or farm business can receive an advance of up to \$100,000 interest-free. Producers repay the advance by December 31, 2015 for the spring portion of the program. If crops are in storage, an individual or farm business may participate in the fall portion of the program with repayment of advances by September 30, 2016. Crops usually covered are barley, corn, oats, rye, hay, soybeans, and spring and winter wheat.

Producers must have crop insurance to be eligible for the spring portion of the program. Also, producers must allow SCIANS to conduct a credit check, done by a third party. Producers must provide SCIANS with an assignment on the crop insurance policy. An administration fee of 1.5 per cent of the total advance is charged to producers to cover the cost of administering the program.

Programs and Business Risk Management Division Updates

Under the *Growing Forward 2* bilateral agreement the Department of Agriculture offers a number of programs focusing on innovation, competitiveness and market development to help producers grow their business and capitalize on emerging opportunities.

The Programs and Business Risk Management (PBRM) division changed the intake model last year (2014-15 fiscal year). Staff listened to feedback, reviewed the administrative process and are implementing administrative changes to provide better service to our clients. Programs for the 2015-16 fiscal year are opening through the late winter/ early spring season. New Program – Building Industry Capacity

The Building Industry Capacity Program is a three-year program commencing in 2015-16 fiscal year. The program is expected to support projects with sector-wide benefits. The objectives are to enhance, develop and diversify agri-business infrastructure and improve competitiveness. The intent is to optimize and accelerate growth and development of the agriculture and agri-food industry. The ultimate objective of the fund is to promote winning conditions within the provincial industry that are based on sound business case analysis and strategic priorities. The ability to enhance the domestic and international competitiveness of the overall sector through collaboration and partnering is an integral component of the Building Industry Capacity Program.

This program has two streams. Stream one will support sector level strategic development and implementation initiatives as identified by industry and/or government. Stream two will assist in building the strategic infrastructure needed to address barriers to development in Nova Scotia's agriculture and agri-food industry. The priorities in these two streams will be reviewed on an annual basis and adjusted accordingly.

The Building Industry Capacity Program is proposal based. Proposals must include a business case and the financial impact of your project must be clearly identified as they apply to your industry or agri-food business, as well as to the rural economy of Nova Scotia. Please contact a Programs and Business Risk Management (PBRM) staff person to discuss your proposed project and whether it meets the eligibility criteria. This initial consultation will help you decide if you should invest valuable time and effort in completing a project proposal. PBRM staff can only provide their initial assessment of the project based on the information provided. Funding decisions can only be made by the Review Committee based on an assessment of the full proposal. Business Risk Management Programs

Under *Growing Forward 2*, Nova Scotia producers have an effective suite of Business Risk Management (BRM) programs which includes AgriInvest, AgriStability, AgriInsurance, and AgriRecovery to help farmers manage risk due to severe market volatility and disaster situations. For more information on AgriInvest or AgriStability contact Agriculture and AgriFood Canada toll free at 1-866-367-8506. The AgriInsurance program is offered provincially through the Nova Scotia Crop and Livestock Commission. AgriRecovery is not a program but a framework which forms the basis by which federal, provincial and territorial governments can work together when natural disasters occur to assess the impacts and determine whether there is need for an AgriRecovery initiative.

Home Grown Success Program – Claim Deadline

The March 1, 2015 claim deadline for individuals and organizations that received funding for the 2014-15 fiscal year is fast approaching. All claims must be postmarked or received by the PBRM office by March 1, 2015. When a deadline falls on a weekend or holiday, it moves to the next business day. Late claims will not be processed. Copies of all invoices with proof of payment (canceled cheques, credit card statement, debit slips, or invoices marked paid and signed by the supplier) are required to support claims. Where applicable, additional documents such as building permits for manure, pesticide or fertilizer storage must accompany your claim. Do You Have the Proper Driver's License?

If you have a farm tractor trailer combination over 14,000 kg, you need a Condition 23 Endorsement and if you are hauling any trailer (with a truck or tractor) that has a weight over 4500kg, you need a Condition 15 Endorsement on your license to legally drive on Nova Scotia roads. These regulations apply to class 5 license.

Sharp Containers

Livestock producers generate medical waste on a regular basis. These wastes include sharps such as syringes, needles, broken glass tubes, lancets and scalpel blades. If not disposed of properly they can injure livestock and family members; increase risk of spreading infection; pollute the environment; and put waste handlers at risk. Sharps must not be discarded in regular household garbage. Sharp containers have been specifically designed for disposing of sharps. When the container is full of sharps, the contents should still be considered potentially infectious to humans and animals, but the risk is low. For disposal in any municipality, you must first check with your local disposal site to see what they have in place to accept sharps.
