

# Schedule of Animal Health Laboratory Services

## Non-registered Farms



The Agriculture and Food Operations Branch operates several laboratories in support of various extension programs of the Department of Agriculture.

The following price schedule applies to the analysis of livestock, related materials and companion animals from non-registered farms. These services are available to agricultural producers and the general public, as well as other departments of government, researchers, and private industry.

**The prices listed are applicable as of April 1, 2020 and do not include environmental disposal fees (\$1.00 per sample) or HST.**

### Post-mortem examination

Fees include all tests related to post-mortem and carcass disposal fee

Up to 3 related animals <100 kg each <i>up to 6 animals for poultry or fur-bearing animals</i>	<b>\$114.09</b>

Forensic post-mortem examination **\$300.00/hour plus expenses**  
*insurance claims, legal cases, etc.*

Livestock includes cattle, sheep, goats, meat rabbits, poultry, llamas, alpacas, deer farm animals, fur-bearing animals, and game farm animals from a licensed premise.

Animals other than livestock include dogs, cats, pocket pets, non-poultry birds, reptiles, wild or exotic species, etc.

Remains will not be released except to a crematorium.
