

Approved corporations must apply for tax credit certificates on behalf of all eligible investors who made eligible investments during the time the corporation was registered under the program.

In order to qualify for a tax credit certificate, a signed statement from each eligible investor is required. Applicant corporations must submit these statements with the application for tax credit certificates.

"Eligible Investment" and "Eligible Investor" are defined in Sections 4 and 5 of the *Innovation Equity Tax Credit Regulations*.

**NOTE: Eligible investors must hold their eligible investment in the corporation for a minimum of 4 years from the date the share certificate or convertible debenture is issued. If the eligible investment is not held in the corporation for 4 years, the tax credit must be repaid to the Province.**
