

Findings and Decision - Renewal Application of Innovative Fishery Products Incorporated for AQ#1341

1. Overview:

On January 26, 2017, the Nova Scotia Department of Fisheries and Aquaculture (NSDFA) received an application from Innovative Fishery Products Incorporated to renew Aquaculture Licence and Lease #1341 (AQ#1341), as described below:

2. History

AQ#1341 was first issued to Innovative Fishery Products Incorporated on May 24, 2007 for a ten year term (May 24, 2007 to May 23, 2017).

3. Procedure

3.1 Performance Review

A performance review of the information submitted by the operator in support of their renewal application was completed. This review recommended that the site be renewed based on the technical and biological assessment. This performance review is required pursuant to Subsection 72(c) of the Aquaculture Licence and Lease Regulations, and was completed on February 28, 2017.

3.2 Public Comment Period

Notice of the application for the renewal of AQ#1341 for the 30-day public comment period was published on NSDFA's website (<http://novascotia.ca/fish/aquaculture/public-information/>) for the period of April 13, 2017 to May 12, 2017. Notice of the application was also published in the Royal Gazette Part I on April 13, April 20, April 27 and May 4, 2017.

3.3 Submissions

Zero submissions were received by NSDFA during the 30-day public comment period.

4. Factors to be considered

AQ#1341 is one multi-site bottom cultivation shellfish operation in Southwest Nova Scotia, which includes a licensed processing facility. Records indicate no production and employment due to current Canadian Shellfish Sanitation Program (CSSP) shellfish harvesting status. The renewal plan indicates that future production of this site is predicated on a change in CSSP classification. Should the classification change, successful development of this site will have a positive impact on the local and provincial economy.

There were no ecological concerns identified in the past performance of this site with respect to negative impacts on other fisheries. AQ#1341 is authorized for the bottom cultivation of shellfish without gear, and as such there is no gear permitted within the boundaries of the lease which mitigates concerns pertaining to navigation. Section 55 of the *Licence and Lease Regulations* requires an aquaculture licence holder to mark each of their sites in a manner determined by the Minister (see below) and to keep each site marked during the term of their licence.

There are no recorded instances on file of AQ#1341 interfering with other users of the public waters surrounding the operation. The licence and lease documents for AQ#1341 allow for access to the site by the general public for recreational activities, provided that the public does not harvest the product on site. This clause serves to reduce potential interference with other users.

AQ#1341 is located in waters which are not eligible for direct shellfish harvest under the Canadian Shellfish Sanitation Program (CSSP); therefore, the existence of AQ#1341 does not negatively interfere with other harvesters, as product harvested from the lease must be processed in a registered depuration facility. Innovative Fishery Products Incorporated must adhere to all provisions of the CSSP, and cannot harvest product unless the classification of the site permits harvesting. AQ#1341 is located in the nearshore environment of Yarmouth Sound, immediately adjacent to the shoreline and spanning the waterbody. A small portion of AQ#1341 is adjacent to AQ#1336, which is also leased to Innovative. There is no evidence to suggest that the extent of existing aquaculture in the area has exceeded the carrying capacity of the area.

5. Decision

Based on the considerations above, Aquaculture Licence #1341 shall be renewed for a period of 10 years (May 23, 2017 – May 23, 2027) and Aquaculture Lease #1341 shall be renewed for a period of 20 years (May 23, 2017 to May 23, 2037).

The Licence and Lease documents shall be prepared in accordance with the standard operating documents of NSDFA, and shall be made publically available subject to the provisions of the *Freedom of Information and Protection of Privacy Act*.

6. Conditions

In addition, the following condition shall apply:

The operator shall adhere to the following site marking requirements:

- a) mark all corners of the leased site with cautionary yellow buoys of a minimum of 60 cm in diameter;
- b) mark all corners of the leased bottom with a cement block or similar device of a weight sufficient to ensure the cement block or device remains in place at all times; and
- c) display the licence or lease number at 1 corner of the licensed or leased area.
