# Nova Scotia Fish Harvester Organizations Support Payment

Dear Fish Harvesters:

The Fish Harvester Organizations Support Act (FHOSA) requires that all core-license holders submit annual dues to the Registrar.

**There are now two ways for you to make a dues payment**

1) **NEW** - Pay Online
