

New developments in forestry transition

Since our last update in June, several new initiatives have been introduced to further help individuals embrace a new vision for forestry, identify new opportunities and adapt to change.

The Forestry Transition Team received feedback from numerous organizations and individuals about the critical need to improve access to financing. In October, the Department of Agriculture responded by announcing a modernized Nova Scotia Timber Loan Board – a lending agency dedicated to the growth and expansion of a sustainable forest sector. Efforts continue to be focused on ensuring we have a skilled workforce that can support an innovative and diversified forestry sector. In partnership with Labour and Advanced Education (LAE) as well as the Nova Scotia Community College, a number of workforce initiatives are underway including an asset mapping project to identify current forestry-related formal and informal education, trades-related training, associations, research and innovation throughout Atlantic Canada. Further analysis on this inventory will help reveal gaps and opportunities for partnerships or the development of new training.

With \$250,000 in new funding and support from LAE,

the Forestry Human Resources Sector Council is working closely with Forest Nova Scotia and other partners to establish an industry-led approach to workforce planning and development in the immediate and longer term.

Vision for Forestry in Nova Scotia

A strong, sustainable, inclusive, diversified, and innovative forestry sector, respected for its stewardship practices, and successfully delivering high value for lower ecological impact.

The Transition Team also coordinated three virtual trade missions with Sweden, Finland and Maine in August and September. Led by the Minister of Lands and Forestry, the missions brought together government officials, representatives from research and development institutions and forestry sector leaders to discuss best practices in forestry management, bio-economy innovative technologies, landowner engagement and product and trade diversification. The Nova Scotia Forestry Innovation Transition Trust is fully operational and recently approved its first two projects, valued at up to \$2 million and \$288,596. Three more projects are approved in principle and other proposals are still under review. The Trust is a \$50 million fund that is managed independently to support projects that align with the new vision for forestry in Nova Scotia. Projects focus on accelerating new opportunities to enhance environmental, social and economic values and adoption of new ecological forestry practices. The Trust will call for proposals three times in 2021–22.

While the COVID-19 pandemic continues to create unprecedented health and economic challenges, the forestry sector is demonstrating its resilience – adapting quickly to public safety measures to meet the exploding demand for lumber created by the pandemic.

Together, the Transition Team, government, the Forestry Innovation Transition Trust, the Minister's Advisory Committee on the implementation of ecological forestry, sector organizations and individuals are laying the foundation for a stronger, more diverse and sustainable sector — a sector that will continue to play an important role in Nova Scotia's post-pandemic recovery.

Transition Team Initiatives – Results to Date

Since January 2020, the transition team endorsed nearly **\$75 million** in new initiatives and provided advice on government policies and programs to support this important forestry transition.

Improved financing for forestry sector

The Transition Team endorsed the renewal of the Nova Scotia Timber Loan Board to better align with the needs of small and medium-sized businesses as they adapt to changes in forestry, diversify and embrace innovation.

The mandate of the loan board is to finance projects that support Nova Scotia's forest resource industry. In October, the loan board modernized its lending program and regulations and updated its lending terms and eligibility criteria to make financing more accessible to forestry sector companies.

The loan board can provide financing for buildings and equipment, developing business cases, upgrading facilities and land purchases at market interest rates with flexible and innovative terms (e.g. repayment schedules, security and financing). Applications will be considered from existing forestry businesses and new entrants.

Woodlot owner leadership and engagement

Nearly 33,000 private woodland owners play an important role in managing Nova Scotia's forests. Some manage their land for commercial purposes, others do not have commercial interests and still others have intentions somewhere in between.

The Transition Team is interested in a 'made in Nova Scotia' approach to engaging private-woodland owners in leading a forest culture focused on forest stewardship and rural economic development. Establishing a landowner network could help connect every type of landowner with the programs, services and information they need.

Coming soon is an initiative to reach out to woodland owners, through an online survey. This survey will help us better understand how woodland owners approach land management, asses their programming and service needs and areas of interest, and how to best keep the lines of communication open.

We expect the survey to launch in early 2020.
