- 2. Two presentations from HRM staff regarding Development Agreements for Port Wallace and Southdale/Mount Hope for review and recommendations to Minister LeBlanc
 - The Panel heard a presentation from HRM staff (Thea Langille) outlining
 proposed amendments to the development agreement for the Port Wallace
 Special Planning Area to adjust requirements for subdivision and project
 phasing to better align with existing property ownership. Staff noted that all
 parties are comfortable with the proposed amendments.
 - Members of the panel asked questions about the engagement required for development agreement amendments.

- The Panel heard a presentation from HRM staff (Thea Langille) summarizing the proposed development for Sub Areas 3A and 3B of the Southdale/Mount Hope Special Planning Area.
 - Secretariat staff asked questions about the details of the wastewater study that is required by the development agreement, as well as the parameters for future non-substantive amendments to the development agreement.
 - o The resulting development agreement provides for the following:
 - Approximately 1,875 in 10 multi-use dwellings on 44 hectares of property.
 - Development proposed meets the policies of the Regional Centre Future Growth Node designation already adopted for the area by HRM Regional Council.
 - The proposed development agreement outlines where the heights can be located on the site but other applicable requirements will come from the Regional Centre Land Use Bylaw for the zone applied.

It is recommended the Executive Panel on Housing recommend that the Minister of Growth and Development approve the proposed development agreement (Attachments A) in the general form in which the documents are provided, to enable the development of a residential development comprising of:

- 1.040 residential units within 10 buildings:
- The retention and possible expansion of an existing commercial use on site:
- A new park space;
- The realignment and upgrading of an existing public road (Research Dr.); and
- New walking trail and multi-use path.
