**Release of Focus Report Pursuant to the
Nova Scotia *Environment Act***

This is to advise that on March 31, 2006, the Minister of Environment and Labour received the Focus Report for Highway 113, proposed by Transportation and Public Works. The purpose of the proposed Highway 113 is to provide a more efficient means of travel for motorists between Highway 103 and Highway 102, that bypasses the Halifax Urban Core. It will also relieve congestion on the Hammonds Plains Road. The proposed 4-lane divided highway will go from Highway 103 near Exit 4 to Highway 102 near Exit 3.
