The Governor in Council on the report and recommendation of the Minister of Transportation and Infrastructure Renewal dated February 7, 2012, and pursuant to Section 21 of Chapter 371 of the Revised Statutes of Nova Scotia, 1989, the *Public Highways Act*, is pleased to designate as controlled access highways the following sections of highway in the County of Halifax:

(a) a section to be known as Highway 113, along with all its interchanges, intersections, ramps and new connector roads, beginning at the point of intersection of the centrelines of Highway 113 and Highway 103, extending in an easterly direction approximately 9.9 km, to the point of intersection of the centrelines of Highway 113 and Highway 102; and

(b) a section of highway known as Eider Drive, beginning at a point approximately 100 m north of the intersection of the centreline of the westbound ramp of Highway 113 and the centreline of Eider Drive, extending in a southerly direction approximately 1.5 km, to the point of intersection of the centreline of Eider Drive and the centreline of Trunk 3, as indicated on Schedule "A", attached to and forming part of the Report and Recommendation.
