Chicken Farmers of Nova Scotia Regulations

Order in Council 2001-482 made October 11, 2001
Amendment to regulations approved by the Governor in Council
pursuant to Section 9
of the *Natural Products Act*

The Governor in Council on the report and recommendation of the Minister of Agriculture and Fisheries dated September 26, 2001, pursuant to Section 9 of Chapter 308 of the Revised Statutes of Nova Scotia, 1989, the *Natural Products Act*, is pleased to approve the making of amendments made by the Natural Products Marketing Council to the *Chicken Farmers of Nova Scotia Regulations* made by the Natural Products Marketing Council and approved by the Governor in Council by Order in Council ~~2000-198 dated April 19, 2000~~ [2000-12 dated January 19, 2000,] as amended in the manner set forth in Schedule "A" attached to and forming part of the report and recommendation effective on and from October 11, 2001.

Schedule "A"

Amendments to the *Chicken Farmers of Nova Scotia Regulations* made pursuant to Section 9 of Chapter 308 of the Revised Statutes of Nova Scotia, 1989, the *Natural Products Act*

- 1 Clause 2(p) of the *Chicken Farmers of Nova Scotia Regulations* ~~made~~ [approved] by the Governor in Council by Order in Council 2000-12, dated January 19, 2001, is repealed and the following substituted:
 - (p) "facilities" means the building, appurtenant lands, fixtures and equipment that are used for the production of chickens.
- 2 Subsection 10(1) is repealed and the following substituted:
 - 10 (1)** No person shall engage in the production or marketing of chicken unless that person holds a valid licence and, in the case of a producer,
 - (a) pay[s] to the Commodity Board the levy prescribed by Section 15 and, where required, the licence fee prescribed in subsection (4); and
 - (b) registers the facilities, pursuant to subsection 11(10), on a form approved by the Commodity Board.
- 3 Subsection 10(6) is repealed and the following substituted:
 - 10 (6)** No licence is transferable except upon application on a form approved by and made in the time limit prescribed by the Commodity Board, and as approved by the Commodity Board.
- 4 [Sub]section 11(7) is amended by adding the words "and registered with the Commodity Board pursuant to subsection 10." after the word "producer".

5 Subsection 11(8) is repealed and the following substituted:

- (8) A producer who wishes to produce chicken in facilities owned by another person shall submit, on a form approved by the Commodity Board, an application to the Commodity Board for approval to produce chicken in leased facilities.

6 The following subsections are added immediately following subsection 11(8):

- (9) In considering an application submitted pursuant to subsection (8), the Commodity Board must be satisfied that there is
- (a) a written agreement, on a form approved by the Commodity Board, permitting production by the applicant in the leased facilities for the period of the producer licence; and
 - (b) clearly segregated definable space of a permanent nature allocated to the applicant in the leased facilities to ensure that chick placement and marketings can be accurately reported.

Registering facilities

- (10) A producer shall register the producer's facilities as required by the Commodity Board.
- (11) Before issuing a producer licence, the Commodity Board may, for the purpose of registering facilities and upon reasonable notice of its intention to do so, examine and measure the interior and exterior dimensions of any buildings in which chicken is produced.
- (12) A producer shall allow any duly authorized representative of the Commodity Board to enter the producer's owned or leased facilities for the purpose of making its examination pursuant to subsection 11.
- (13) Registered facilities shall include only usable production floor space.

Amendments to regulations made by the Governor in Council

of the *Small Claims Court Act*

The Governor in Council on the report and recommendation of the Minister of Justice dated September 20, 2001, pursuant to Section 33 of Chapter 430 of the Revised Statutes of Nova Scotia, 1989, the *Small Claims Court Act*, is pleased to

- (a) amend the regulations respecting Small Claims Court procedures and forms made by the Governor in Council by Order in Council 93-110 dated February 2, 1993, in the manner set forth in Schedule "A" attached to and forming part of the report and recommendation; and
- (b) amend the *Small Claims Court Taxation of Costs Regulations* made by the Governor in Council by Order in Council 2001-162 dated March 30, 2001, in the manner set forth in Schedule "B" attached to and forming part of the report and recommendation, effective on and after October 11, 2001.

**Amendments to the Regulations Respecting Small Claims Court Procedures

Chapter 430 of the Revised Statutes of Nova Scotia, 1989,
the *Small Claims Court Act***

Clause 5(a) of Form 11 of the regulations respecting Small Claims Court procedures and forms made by the Governor in Council by Order in Council 93-110 dated February 2, 1993, is amended by

- (a) striking out "\$315.00" and substituting "\$415.00"; and
- (b) striking out "\$210.00" and substituting "\$275.00".

made by the Governor in Council pursuant to Section 33 of Chapter 430
of the Revised Statutes of Nova Scotia, 1989, the *Small Claims Court Act***

Section 4 of the *Small Claims Court Taxation of Costs Regulations* made by [the] Governor in Council by Order in Council dated March 30, 2001, is amended by adding the following subsection immediately after subsection 4(2):

- (3) Despite subsections (1) and (2), where the respondent is absconding or absent from the Province, service is not required.

Citation

1 These regulations may be cited as the *Emergency “911” Act Definitions Regulations*.

Definitions for purposes of Act

2 For the purposes of the *Emergency “911” Act*, “local telecommunication services” includes wireless telecommunication services provided by a company that is registered to conduct business in the Province, whose wireless telecommunication services include access to the “911” emergency telephone system.

A PROCLAMATION

WHEREAS in and by Section 33 of Chapter 4 of the Acts of 1999, the *Business Efficiency (1999) Act*, it is enacted as follows:

- 33** Subsection 5(2) and Sections 27 to 29 come into force on such day as the Governor in Council orders and declares by proclamation.

AND WHEREAS it is deemed expedient that Sections 27 to 29 of Chapter 4 of the Acts of 1999, the *Business Efficiency (1999) Act*, come into force on October 18, 2001;

NOW KNOW YE THAT WE, by and with the advice of the Executive Council of Nova Scotia, do by this Our Proclamation order and declare that Sections 27 to 29 of Chapter 4 of the Acts of 1999, the *Business Efficiency (1999) Act*, come into force on October 18, 2001, of which all persons concerned are to take notice and govern themselves accordingly.
