made by the Minister of Transportation and Infrastructure Renewal
pursuant to subsection 191(1) of Chapter 293 of the
Revised Statutes of Nova Scotia, the *Motor Vehicle Act***

- 1 Clause 9(1)(b) of the *Weights and Dimensions of Vehicles Regulations*, N.S. Reg. 137/2001, made by the Minister of Transportation and Public Works and approved by the Governor in Council by Order in Council 2001-526 dated November 15, 2001, is amended by striking out "B-train routes, as listed in Schedule B" and substituting "intermediate weight roads, as listed in Schedule D".
- 2 Section C of Part 1 of Schedule A to the regulations is amended by striking out "**B-train Routes**" in the heading "**Maximum Axle Weights for B-train Routes**" and substituting "**Intermediate Weight Roads**".
- 3 Section 2 of Category 3 in Part 2 of Schedule A to the regulations is amended by
 - (a) adding "Not Allowed⁷" in the right-hand column of the row beginning "**B-Train Routes**";
 - (b) striking out the 5 rows immediately under the row beginning "**B-Train Routes**";
 - (c) adding the following footnote immediately after footnote 6:

⁷ For roads listed in Schedule B, the maximum weight is 32 800 kg for 4 axles, 41 700 kg for 5 axles, 50 600 for 6 axles, 59 500 kg for 7 axles, and 62 500 kg for 8 axles.

- 4 Part 2 of Schedule A to the regulations is further amended by striking out the heading “**B-Train Routes**” and substituting “**Intermediate Weight Roads**” in the table setting out weight limits in Section 2 of each of Categories 1 to 10, inclusive.
- 6 The regulations are further amended by adding the attached Schedule immediately after Schedule C.

Flashing or revolving purple light for funeral procession

- 8** A vehicle that is leading, or is about to lead, a funeral procession may display a flashing or revolving light that is designed to show only purple light in all directions.

- 3 A new subsection (4A) is added immediately after subsection 31(4):

(4A) Notwithstanding subsection (4), where a member was absent from duty for any of the reasons set out in subsection (1) for a period which commenced on or after August 1, 2004, the member may purchase pensionable service equal to the period of absence by making the contributions the member would have made had he not been absent, at the percentages provided in subsection (4B), together with interest at the rates prescribed in subsection 29(2), provided the member pays the required amount within twelve months of the end of the period of absence.
- 4 A new subsection (4B) is added immediately after subsection (4A):

(4B) For the purposes of subsection (4A) the contribution percentages are as follows:

 - (a) for maternity leave, 100%;
 - (b) for adoption leave, 200%;
 - (c) for parental leave, 200%;

- (d) for study leave, 100%;
- (e) for an absence for taking an academic or professional course of study or engaging in an activity approved by the Plan administrator as an equivalent, 100%;
- (f) for unpaid sick leave, 100%;
- (g) for layoff, 200%;
- (h) for any leave of absence not otherwise specified in the this subsection, 200%.

5 A new subsection (4C) is added immediately after subsection (4B):

(4C) Notwithstanding the requirement in subsection (1) that the member be subsequently re-employed for not fewer than 50 days in a school year after the absence from duty, the member may make contributions pursuant to subsection (4A) while he is absent from duty on terms and conditions established from time to time by the Plan administrator provided that he shall only be given credit for the period of absence after he has been subsequently re-employed for not fewer than 50 days in a school year after the absence from duty.

- (6)** Where a member employed by a school board, the Union, or the Canadian Teachers' Federation
- (a) is required to pay 50% of the actuarial cost pursuant to subsection (4), the Minister shall pay the remaining 50%; or

 - (3) parental leave,

 - (7) any leave of absence not otherwise specified under this subsection or subsection 31(1)(a).
