# In the matter of Section 19 of Chapter 36 of the Acts of 2011, the Fish Harvester Organizations Support Act

In the matter of an amendment to the Fish Harvester Organizations Support Regulations made by the Minister of Fisheries and Aquaculture pursuant to Section 19 of the Fish Harvester Organizations Support Act

I, the Honourable Keith Colwell, Minister of Fisheries and Aquaculture for the Province of Nova Scotia, pursuant to Section 19 of Chapter 36 of the Acts of 2011, the *Fish Harvester Organizations Support Act*, hereby amend the *Fish Harvester Organizations Support Regulations*, N.S. Reg. 187/2013, made by the Minister of Fisheries and Aquaculture by Order dated February 27, 2013, to revise the provisions regarding enforcement of the Act and its regulations, in the manner set forth in the attached Schedule "A".

This order is effective on and after July 29, 2015.

#### Schedule "A"

Amendment to the Fish Harvester Organizations Support Regulations made by the Minister of Fisheries and Aquaculture under Section 19 of Chapter 36 of the Acts of 2011, the Fish Harvester Organizations Support Act

The Fish Harvester Organizations Support Regulations, N.S. Reg. 187/2013, made by the Minister of Fisheries and Aquaculture by Order dated February 27, 2013, and amended February 13, 2014 are amended as follows:

1. Subsection  $2(a)^*$  is amended by adding the following definitions:

# [\*Reference to subsection 2(a) as in original.]

"controlling agreement" means an agreement between a licence holder and another person, corporation or other entity that permits a person, other than the licence holder, to control or influence a decision by the licence holder to submit a request to the Department of Fisheries and Oceans (Canada) for the issuance of a replacement licence to another fish harvester;

"key vessel based <del>license</del> [licence]" means

(i) in Region 1, a licence to fish for snow crab, lobster, groundfish (other than handline),

scallop, bluefin tuna, or herring; and

- (ii) in Regions 2 through 6, a licence to fish for herring purse seine, snow crab, lobster, groundfish (other than handline), scallop, bluefin tuna, herring, swordfish (longline), or shrimp trawl;
- 2. Section 2 is amended by adding the following at the end of subsection 2(a)\*:

# [\*Reference to subsection 2(a) as in original.]

(b) In the Act and these regulations,

"customarily return from fishing to a place" means to return to the home port registered with the Department of Fisheries and Oceans (Canada) and identified as such on the licence holder's key vessel based licences:

"recognized as a core or an independent core fisher" means a person who

- (i) holds one or more key vessel based licences issued by the Department of Fisheries and Oceans (Canada),
- (ii) is designated as either core or independent core on those <del>licenses</del> [licences], and
- (iii) in the case of a core fisher, held at least one of those licences, at the time of its issuance, subject to a controlling agreement, and
- (iii)\* in the case of an independent core fisher, held none of those licences, at the time of their issuance, subject to a controlling agreement.

#### [\*Subclause lettering as in original.]

- 3. Section 16 is amended by adding the following immediately after subsection 16(3):
  - (4) Once the Minister is satisfied that an organization has complied with all requirements prescribed by these regulations to obtain or maintain, as applicable, a designation as an accredited organization and pays the accreditation fee required under this Section, the Minister shall issue an accreditation certificate to the organization.







# Declaration of winner and posting of election results

- 26 (1) After an election of directors is conducted, DFNS must declare elected the candidates who obtained the largest number of votes.
  - (2) Before 4:30 p.m. on the day immediately after the date the votes are counted, DFNS must inform producers of the election results, including the vote count, by
    - (a) posting the results to the DFNS website; and
    - (b) any method that DFNS determines.
