Whereas the purpose of the *Petroleum Products Pricing Regulations* is to ensure just and reasonable prices for specified petroleum products taking into consideration the objectives of preserving the availability of such products in rural areas, stabilizing prices of such products and minimizing the variances in prices of such products across the Province;

And whereas the Nova Scotia Utility and Review Board ("Board") considered the manner in which it would proceed to set petroleum product prices in its decision, 2006 NSUARB 108, issued on October 16, 2006;

And whereas the Board revised the wholesale margin effective January 4, 2013, in its decision, 2012 NSUARB 213, issued on December 12, 2012;

And whereas the Board revised the retail margin and the transportation allowance effective October 28, 2016, in its decision, 2016 NSUARB 168, issued on September 26, 2016;

And whereas the average of the average of the daily high and low reported product prices (in Canadian cents) for the period ended March 4, 2020, are:

Grade 1 Regular gasoline 53.22¢ per litre Ultra-low-sulfur diesel oil 53.71¢ per litre

Now therefore the Board prescribes the benchmark prices for petroleum products to be:

Gasoline:

Grade 1 53.22¢ per litre
Grade 2 56.22¢ per litre
Grade 3 59.22¢ per litre
Ultra-low-sulfur diesel oil 53.71¢ per litre

And now therefore the Board has determined, based on historical data regarding price changes and to achieve revenue neutrality, it is appropriate to apply, and the Board so orders, forward averaging corrections of:

Gasoline: nil ¢ per litre Ultra-low-sulfur diesel oil: nil ¢ per litre

And whereas a winter blending adjustment of plus 1.99¢ per litre is required for ultra-low-sulfur diesel oil;

And now therefore the Board prescribes the prices for petroleum products as set forth in Schedule "A" effective on and after 12:01 a.m., March 6, 2020.

Section 3 of the *Milk Producer Licensing Regulations*, N.S. Reg. 125/2017, made by the Dairy Farmers of Nova Scotia on October 14, 2016, and approved by the Natural Products Marketing Council on August 21, 2017, is amended by

- (a) repealing the definition of "Abnormal Freezing Point Standard for Cow's Milk Regulations";
- (b) repealing the definition of "milk production regulations";
- (c) repealing the definition of "milk quality standards" and substituting the following:
 - "milk quality standards" means the chemical and microbiological quality standards for raw milk under Section 101 of the *Raw Milk Production and Transportation Regulations* for bacteria, somatic cells, inhibitors, and freezing point;
- (d) adding the following definition immediately following the definition of "proAction program":
 - "Raw Milk Production and Transportation Regulations" means the Raw Milk Production and Transportation Regulations made under the Act;
- 2 Section 5 of the regulations is amended by striking out "regulations relating to raw milk production, transfer and transportation" and substituting "the *Raw Milk Production and Transportation Regulations*".
- 3 Section 6 of the regulations is amended by
 - (a) striking out the ";" in clause (e) and substituting "."; and
 - (b) repealing clause (f).
- 4 Section 13 of the regulations is amended by
 - (a) striking out the heading "Penalty for violating bacteria count, somatic cell count or abnormal freezing point standard" and substituting the following heading:
 - "Penalty for violating bacteria, somatic cells or freezing point standard"
 - (b) repealing subsection (1) and substituting the following:
 - (1) A producer is subject to a penalty as set out in subsection (2) as follows:
 - (a) for a bacteria penalty,
 - (i) a bacteria test result higher than the bacteria standard in Section 101 of the *Raw Milk Production and Transportation Regulations* has been found in the current month and in at least 40% of the tests of the producer's milk within a 3-month period that includes the current month; and
 - (ii) where at least 3 bacteria test results are available within the continuous 3-month period, and where only 3 test results are available, all 3 bacteria test results must be higher than the bacteria standard in Section 101 of the *Raw Milk Production* and *Transportation Regulations* in order to result in a penalty;
 - (b) for a somatic cells penalty,
 - (i) a somatic cells test result higher than the somatic cells standard in Section 101 of the *Raw Milk Production and Transportation Regulations* has been found in the current month and in at least 40% of the tests of the producer's milk within a 3-month period that includes the current month; and

- (ii) where at least 17 somatic cells test results are available within the continuous 3-month period;
- (c) for a freezing point penalty,
 - (i) a freezing point test result higher than the freezing point standard in Section 101 of the *Raw Milk Production and Transportation Regulations* has been found in the current month and in at least 40% of the tests of the producer's milk within a 3-month period that includes the current month; and
 - (ii) where at least 3 freezing point test results are available within the continuous 3-month period, and where only 3 test results are available, all 3 freezing point test results must be higher than the freezing point standard in Section 101 of the *Raw Milk Production and Transportation Regulations*.
- (c) striking out the heading for the table in subsection (2) "Penalty for Violating Bacteria Count Standard, Somatic Cell Count Standard or Abnormal Freezing Point Standard" and substituting the following heading:

"Penalty for Violating Bacteria, Somatic Cells or Freezing Point Standard"

- 5 Section 14 of the regulations is amended by
 - (a) striking out "unnatural" wherever it appears, including in the heading;
 - (b) repealing subsection (1);
 - (c) re-numbering subsections (2) to (5) as subsections (1) to (4), respectively;
 - (d) striking out "of their milk that is disposed of under clause (1)(a)" in subsection (1) and substituting "milk that is rejected under Section 86 of the *Raw Milk Production and Transportation Regulations*";
 - (e) repealing clause 2(a) and substituting the following:
 - (a) all expenses incurred by the Board in disposing of milk that is rejected under subsection 86(6) of the *Raw Milk Production and Transportation Regulations* and conducting additional testing of the producer's milk under Section 105 of the *Raw Milk Production and Transportation Regulations*;
 - (f) striking out "subsection (5)" in subsection (3) and substituting "subsection (4)".
