- I, Barbara Adams, Attorney General and Minister of Justice for the Province of Nova Scotia, pursuant to Section 8 of Chapter 450 of the Revised Statutes of Nova Scotia, 1989, the *Summary Proceedings Act*, hereby
- (a) amend the *Summary Offence Tickets Regulations*, N.S. Reg. 281/2011, made by order of the Attorney General and Minister of Justice dated October 4, 2011, to designate certain offences under the Town of Stewiacke Dog By-Law as summary offence ticket offences, in the manner set forth in the attached Schedule "A"; and

Prohibition Order for Moose Management Zones 2, 3 and 4

Order dated September 9, 2024

Made by the Minister of Natural Resources and Renewables pursuant to Section 21 of the *Wildlife Act*

In the matter of Section 21 of Chapter 504 of the Revised Statutes of Nova Scotia, 1989, the Wildlife Act

-and-

In the matter of an order respecting the prohibition of certain hunting methods made by the Minister of Natural Resources and Renewables under Section 21 of the Wildlife Act

Whereas subsection 21(1) of Chapter 504 of the Revised Statutes of Nova Scotia, 1989, the *Wildlife Act*, provides that, notwithstanding anything contained in the Act, the Minister of Natural Resources and Renewables may issue an order prohibiting hunting or a method of hunting in any defined area of the province for a period considered necessary for the proper management of wildlife in that area;

And whereas, notwithstanding the Act and any regulations made under the Act, including Section 4 of the *Firearm and Bow Regulations*, the Minister considers it necessary for the proper management of moose to prohibit certain methods of hunting bear within specified areas of the Province for a specified period;

Therefore, I hereby order that the possession or use of a rifle, shotgun or muzzleloader for the purpose of hunting bear within the lands designated as Moose Management Zones 2, 3 and 4 of the Province in the *Moose Hunting Regulations* is prohibited.

Any person who contravenes this order may be liable to prosecution under subsection 21(3) of the Wildlife Act.

This order is effective for the period from the second Monday in September until the Saturday following the first Monday in October, both dates inclusive, in each of the years 2024, 2025 and 2026.

Amendment to the *Veterans' Number Plates Regulations* made by the Minister of Public Works under Section 38 of Chapter 293 of the Revised Statutes of Nova Scotia, 1989, the *Motor Vehicle Act*

The definition of "veteran" in Section 2 of the *Veterans' Number Plates Regulations*, N.S. Reg. 163/2002, made by the Minister of Service Nova Scotia and Municipal Relations and approved by the Governor in Council by Order in Council 2002-606 dated December 20, 2002, is repealed and the following definition substituted:

"veteran" means any of the following persons:

- (i) a person who is serving or who has honourably served in 1 or more of the following:
 - (A) the Canadian Armed Forces,
 - (B) the armed forces of another Commonwealth country,
 - (C) the armed forces of a wartime ally of Canada or another Commonwealth country,
 - (D) the Royal Canadian Mounted Police as a regular member,
- (ii) a person who has honourably served during wartime in the Merchant Navy or Ferry Command,
- (iii) a person who is serving or who has honourably served as a peace officer on a special duty operation;
