## INTERIM DISPOSITION ORDER

WHEREAS on the 22<sup>nd</sup> day of April, 2021, the accused was found Not Criminally Responsible on account of a mental disorder on charges of: Mischief, contrary to s.430(4) x3, on charges of Assault, contrary to s.266 x3, on charges of Robbery, contrary to s.344 x2, on charges of Assault with a Weapon, contrary to s.267(A) x2, on a charge of Possession of a Weapon for Dangerous Purpose, contrary to s.88 (1), on a charge of At Large on Release Order, Fails to Attend, contrary to s.145(2)(A), on a charge of Having Appeared, Fails to Subsequently Attend Court as Directed, contrary to s.145(2)(B), on a charge of Causing a Disturbance by Fighting, Screaming, Shouting, Swearing, Singing, or Using Insults or Obscene Language, contrary to s.175(1)(A)(I), on charges of Uttering Threats to Cause Death or Bodily Harm, contrary to s.264.1(1)(A) x3, on a charge of Resists/Obstructs Peace Officer, contrary to s.129(A), and on a charge of Assaulting a Peace Officer, contrary to s.270(1)(A) of the Criminal Code of Canada.

AND WHEREAS the accused is presently residing in the community.

AND WHEREAS a hearing was held via Zoom at the East Coast Forensic Psychiatric Hospital on the 1st day of April 2025 to make a Disposition Order pursuant to s.672.54 of the Criminal Code of Canada.

AND WHEREAS the East Coast Forensic Psychiatric Hospital is designated for the custody, treatment, or assessment of the accused, in respect of whom an assessment order, disposition or placement decision is made.

IT IS ORDERED that the accused accontinue to be detained in the East Coast Forensic Psychiatric Hospital, Gradual transfer to the Transition Program, Conditional Discharge be granted (the Conditional Discharge to be implemented within a reasonable period of time), Conditional Discharge be continued, Absolute Discharge be granted, and change to current Disposition, the Board approves the recommendations as submitted by the East Coast Forensic Psychiatric Hospital (See Schedule "A")	
2.	IT IS FURTHER ORDERED that the Administrator of the East Coast Forensic Psychiatric Hospital implement	
	program for the safe custody and rehabilitation of the accused within the East Coast Forensic Psychiatric pspital, in which the Administrator, in his discretion, subject to the mental condition and needs of the accused ay $\Xi$ in the case of an accused who is deemed unfit, or on conditional discharge, subject to the followin anditions: (See Schedule "A")
