DISPOSITION ORDER

WHEREAS on the 18th day of March 2025, the accused was found Unfit to Stand Trial on charges of: Breach of Probation (x4) contrary to s. 733.1(1) and on a charge of Assaulting a Peace Officer contrary to s. 270(1)(b); and on a charge of Resist Arrest/Obstruct Peace Officer (x2) contrary to s. 129(a); and on a charge of Causing Disturbance contrary to s. 175(1)(a)(i); and on a charge of Possession of Weapon/Dangerous contrary to s. 88(1) and on a charge of Mischief contrary to s. 430(1)(c); and on a charge of Fail to Appear/Undertaking contrary to s. 145(4)(b); and on a charge of Assaulting a Peace Officer (x2) contrary to s. 270(1)(a); and on a charge of Fail to Attend Court contrary to s. 145(3); and on a charge of Breach of Undertaking (x3) contrary to s. 145(4)(a); and on a charge of Indecent Act contrary to s. 173(1); and on a charge of Arson Causing Damage to Property contrary to s. 434; and on a charge of Fail to Attend Court contrary to s. 145(2)(b); and on a charge of Fail to Attend Court contrary to s. 145(5)(a) of the Criminal Code of Canada.

AND WHEREAS the accused is presently detained at the East Coast Forensic Psychiatric Hospital.

AND WHEREAS a hearing was held at the East Coast Forensic Psychiatric Hospital on the 12th day of May 2025, to make a Disposition Order pursuant to s.672.54 of the Criminal Code of Canada.

AND WHEREAS the East Coast Forensic Hospital is designated for the custody,

treatment, or assessment of the accused, in respect of whom an assessment order, disposition or placement decision is made;


IT IS ORDERED THAT the accused be detained in the East Coast Forensic Hospital with a Board community access ceiling level of L4.

AND IT IS FURTHER ORDERED that if the accused is arrested pursuant to section 672.91 of the Criminal Code for a breach or anticipated breach of the terms of this disposition, they may, under section 672.92(1)(b) of the Criminal Code, be delivered to the East Coast Forensic Hospital, 88 Gloria McCluskey Avenue, Dartmouth, Nova Scotia.

THIS IS THEREFORE TO COMMAND YOU, the Director, Mental Health Program, Nova Scotia Health Authority, in His Majesty's name, to execute the terms of this Order. The Board delegates to them the authority to increase or decrease the liberties of the accused pursuant to section 672.56(1).

The Board further finds that the accused remains unfit to stand trial.
