

**IN THE MATTER OF the Nova Scotia Criminal Code Review Board
AND IN THE MATTER OF the accused, Cody Clifford Lowe
AND IN THE MATTER OF a hearing held pursuant to s. 672.81 (1) (Annual Hearing)
of the *Criminal Code of Canada*.**

DISPOSITION ORDER

WHEREAS on the 2nd day of August 2018, the accused was found *Not Criminally Responsible on account of a mental disorder* on a charge of Assault, contrary to Section 266 of the Criminal Code of Canada.

AND WHEREAS the accused is presently detained at the East Coast Forensic Psychiatric Hospital.

AND WHEREAS a hearing was held via Zoom at the East Coast Forensic Psychiatric Hospital on the 18th day of November 2024 to make a Disposition Order pursuant to s.672.54 of the *Criminal Code of Canada*.

AND WHEREAS the East Coast Forensic Psychiatric Hospital is designated for the custody, treatment, or assessment of the accused, in respect of whom an assessment order, disposition or placement decision is made.

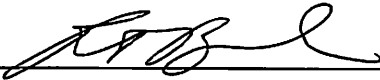
IT IS ORDERED THAT the accused be detained in the East Coast Forensic Psychiatric Hospital with a Board ceiling level of community access at L3, as currently defined.

AND IT IS FURTHER ORDERED that the events outlined in the “Campbell” notification dated October 9, 2025 is a restriction of liberties and the Hospital is forthwith to provide the Board, Crown, and Defence with a notification of restriction of liberties pursuant to section 672.56(2)(b) of the Criminal Code of Canada.

AND IT IS FURTHER ORDERED that if the accused is arrested pursuant to section 672.91 of the Criminal Code for a breach or anticipated breach of the terms of this disposition, they may, under section 672.92(1)(b) of the Criminal Code, be delivered to the East Coast Forensic Hospital, 88 Gloria McCluskey Avenue, Dartmouth, Nova Scotia.

THIS IS THEREFORE TO COMMAND YOU, the Director, Mental Health Program, Nova Scotia Health Authority, in His Majesty's name, to execute the terms of this Order. The Board delegates to them the authority to increase or decrease the liberties of the accused pursuant to section 672.56(1).
