

**THE MATTER OF the NOVA SCOTIA REVIEW BOARD
AND IN THE MATTER OF the accused, Frank Malone
AND IN THE MATTER OF a hearing held pursuant to 672.47(1) (First Hearing) of the
*Criminal Code of Canada.***

DISPOSITION ORDER

WHEREAS on the 27th day of October 2025, the accused was found ***Unfit to Stand Trial*** on charges of: **Break and Enter** contrary to s.348(1)(B) and on a charge of **Robbery** contrary to s.344(1) x2, and on a charge of **Assault with a Weapon** contrary to s.267(A), and on a charge of **Uttering Threats to Cause Death or Bodily Harm** contrary 264.1(1)(A), and on a charge of **Possession of a Weapon for Dangerous Purpose** contrary to s.88(1) and on a charge of **Possession Under** contrary to s.355(B), and on a charge of **Breach of Probation** contrary to s.733.1(1) of the *Criminal Code of Canada.*

AND WHEREAS the accused is residing currently detained at the East Coast Forensic Hospital;

AND WHEREAS a hearing was held on December 8, 2025 to make a Disposition Order pursuant to section 672.54 of the Criminal Code;

AND WHEREAS the East Coast Forensic Hospital is designated for the custody, treatment, or assessment of the accused, in respect of whom an assessment order, disposition or placement decision is made;

IT IS ORDERED THAT the accused be detained at the said hospital with a community access ceiling level of L2, as currently defined. Additionally:

- The accused shall not possess any firearm, crossbow, prohibited weapon, prohibited device, ammunition, or explosive device within the meaning of the Criminal Code;

- The accused shall not be within 25 meters of Esso station located at 116 Wyse Road, Dartmouth, Nova Scotia, unless in transit in a motor vehicle; and
- The accused shall have no direct or indirect contact or communication with either Lucky Kaur or Royal Singh.

AND IT IS FURTHER ORDERED that if the accused is arrested pursuant to section 672.91 of the Criminal Code for a breach or anticipated breach of the terms of this disposition, they may, under section 672.92(1)(b) of the Criminal Code, be delivered to the East Coast Forensic Hospital, 88 Gloria McCluskey Avenue, Dartmouth, Nova Scotia.

THIS IS THEREFORE TO COMMAND YOU, the Director, Mental Health Program, Nova Scotia Health Authority, in His Majesty's name, to execute the terms of this Order. The Board delegates to them the authority to increase or decrease the liberties of the accused pursuant to section 672.56(1).

The Board also finds that the accused remains unfit to stand trial.
