AND IN THE MATTER OF a hearing held pursuant to sections 672.81 (1) (Annual Hearing) and 672.81 (2.1) (Restriction of Liberties Hearing) of the Criminal Code

DISPOSITION ORDER

WHEREAS on the 24th of October 2017, the accused was found not criminally responsible on account of mental disorder on charges of causing bodily harm to a peace officer, contrary to Section 270.01 of the Criminal Code, assaulting a peace officer, contrary to Section 129(a) of the Criminal Code, breach of probation, contrary to Section 733.1 of the Criminal Code (2 counts), and mischief, contrary to section 430(4) of the Criminal Code;

AND WHEREAS the accused is currently detained at the East Coast Forensic Hospital on a previously granted Conditional Discharge;

AND WHEREAS a hearing was held on the 14th day of June 2021 to make a Disposition Order pursuant to section 672.54 of the Criminal Code;

AND WHEREAS the East Coast Forensic Hospital is designated for the custody, treatment or assessment of the accused, in respect of whom an assessment order, disposition or placement decision is made;

IT IS ORDERED THAT the accused continue to be conditionally discharged, on the following terms:

1. Keep the peace and be of good behaviour;
2. Maintain good mental health;
3. Adhere to the recommendations of the Community Mental Health Team;
4. Comply with follow-up by the Forensic Community Program;
5. Comply with conditions recommended by the Forensic Community Program;

6. Abstain from alcohol, cannabis and/or illicit drugs and comply with random urine drug screening;
7. Reside in the premises approved by the East Coast Forensic Hospital and abide by the rules and regulations of the residence;
8. Notify the Review Board and the East Coast Forensic Hospital of any change of address;
9. Appear before the Board when requested; and
10. Remain within the Province of Nova Scotia unless authorization in writing has been received from the East Coast Forensic Hospital.

The Board also finds that the Hospital was justified in restricting the liberties of the accused on the occasions outlined in the hospital reports.

THIS IS THEREFORE TO COMMAND YOU, the Director, Mental Health Program, Nova Scotia Health Authority, in Her Majesty's name, to execute the terms of this Order. The Board delegates to them the authority to increase or decrease the liberties of the accused pursuant to section 672.56(1).
