AND IN THE MATTER OF the accused, Anthony Sottile

AND IN THE MATTER OF a hearing held pursuant to s. 672.81(1) and 672.81(2.1) (Annual Hearing and Restriction of Liberties) of the Criminal Code of Canada.

DISPOSITION ORDER

WHEREAS on the 9th of March, 2021, the accused was found Not Criminally Responsible on account of a mental disorder on charges of: Attempts to Commit Murder, contrary to s.239(1)(b), on a charge of Causes Bodily Harm to Peace Officer, contrary to s.270.01(1)(b) x2, on a charge of Breach of Probation, contrary to s.733.1(1), on a charge of Possession of a Weapon for Dangerous Purpose, contrary to s.88, and on charges of Uttering Threats to Cause Death or Bodily Harm, contrary to s.264.1(1)(a) x3 of the Criminal Code of Canada.

AND WHEREAS the accused is presently detained at the East Coast Forensic Psychiatric Hospital.

AND WHEREAS a hearing was held at the East Coast Forensic Psychiatric Hospital on the 18th day of August, 2025 to make a Disposition Order pursuant to s.672.54 of the Criminal Code of Canada.

AND WHEREAS the East Coast Forensic Psychiatric Hospital is designated for the custody, treatment, or assessment of the accused, in respect of whom an assessment order, disposition or placement decision is made.

IT IS ORDERED that the accused continue to be detained in the East Coast Forensic Psychiatric Hospital with a community access ceiling level of L4, as currently defined.

AND IT IS FURTHER ORDERED that if the accused is arrested pursuant to section

672.91 of the Criminal Code for a breach or anticipated breach of the terms of this disposition, they may, under section 672.92(1)(b) of the Criminal Code, be delivered to the East Coast Forensic Hospital, 88 Gloria McCluskey Avenue, Dartmouth, Nova Scotia.

THIS IS THEREFORE TO COMMAND YOU, the Director, Mental Health Program, Nova Scotia Health Authority, in His Majesty's name, to execute the terms of this Order. The Board delegates to them the authority to increase or decrease the liberties of the accused pursuant to section 672.56(1).
