Greetings from the FRPA Review Office!

We look forward to delivering a two-part *Communications for Impact & Influence* workshop for Nova Scotia regulators on March 1st and 29th, 8 a.m. – 12 p.m. at the Dartmouth Adult Services Centre (DASC, Burnside). Over the course of two sessions, participants will explore a variety of topics including: communication style and

preferences; designing and delivering messages that are clear and inclusive; understanding and overcoming barriers that limit our ability to communicate effectively; and building awareness of emotional and social intelligence. Nova Scotia regulators will walk away with best practices for effective internal/external communications.

The FRPA Annual Report for 2015-16 has been drafted for submission to the House of Assembly of Nova Scotia in 2017. The Annual Data that Nova Scotia regulators provide to the FRPA Review Office enables us to identify progress made and areas for improvement. We used the data from 2015 to develop a high level, baseline analysis of registration practices in Nova Scotia and look forward to sharing the results.

A meeting of the FRPA Ad Hoc Advisory Work Group was called on Monday, December 12th, with follow-up discussion scheduled for late Feb/early March, to provide feedback on the Compliance Review process and new FRPA Review templates. All related documentation will be shared with NS regulators prior to the breakfast meeting in May.

As promised, the Review Officer has issued a Statement of Work for an internal/external legislative review of Nova Scotia's Fair Registration Practices Act (FRPA) and evaluation of the policies, processes and programming that support its implementation. NS regulators will be briefed on the project at the upcoming FRPA breakfast meeting and consulted throughout planning and implementation phases. We look forward to formally evaluating the impact of Fair-access legislation and International Qualification Recognition (IQR) programming in Nova Scotia as we craft the Concept Paper for the next round of Foreign Credential Recognition Program funding in 2018!

Foreign Qualification Recognition Working Group (FQRWG) Update

In line with the Forum of Labour Market Ministers' (FLMM) Action Plan for Better Foreign Qualifications Recognition, the FLMM's Foreign Qualification Recognition Work Group (FQRWG) is examining employment data to identify the post-licensure employment outcomes for internationally trained individuals (ITIs).

Through a call for proposals launched by Nova Scotia's Flextrack VMS, the FQRWG commissioned Sherry Campbell & Associates in December 2016 to provide research and analysis of post-licensure employment outcomes of internationally trained individuals, as well as recommendations on best practices for the collection of employment outcomes for professional regulatory organizations.

- Internationally Educated Lawyers
- Internationally Educated Social Workers
- Internationally Educated Pharmacy Grads
- Internationally Educated Respiratory Therapists.

Plans are underway to form a new working group in the Financial Sector professions which is timely, given the amalgamation of accounting regulators across the country as well the delivery of a new pilot program at ISANS for financial professionals. The Construction Electricians working group is being concluded with a view to transferring the work to the trade advisory committee of the provincial apprenticeship system.
