# **Updates**

Fair Registration Practices Act (FRPA) reviews are currently underway and will wrap up late April. I will be in contact with the next group to be reviewed in the coming weeks. Additionally, those who completed the pilot review (2013) will be contacted to discuss the content of their next FRPA report.

Most FRPA activities and projects have relied on support from Federal Foreign Qualification Recognition (FQR) funding – a three year Federal/Provincial agreement that ended in March 2014. A new agreement for 2015-18 will soon be signed. Following that a request for IQR proposals will go out. Stay tuned.
