On **Wednesday February 5th**, Ray Larkin, Q.C. will be presenting his session from the FRPA Workshop held in November. The presentation will focus on the Act, and in particular, writing decisions and internal reviews. This is a great introduction to FRPA for many regulatory bodies and a useful refresher for those of us who are very familiar with the Act.

Raymond Larkin Q.C. is a founding partner of the Halifax law firm Pink Larkin. 

Policy on removing the "Canadian Experience" - Ontario's approach

When a regulatory body requires "Canadian experience" before someone can get accredited, they may create barriers for newcomers to Canada. In Ontario, the Human Rights Commission has developed a policy that addresses the "Canadian experience" barrier. In Ontario, employers and regulatory bodies have to show that a requirement for Canadian experience is a 'bona fide" or necessary requirement.
