## Message from the FRPA Review Officer:

Hello! I would like to extend a warm welcome to Melinda MacIsaac, the newly appointed Research and Statistical Officer for the FRPA Review Office. Melinda comes to us from Mi'kmaq Services in the Department of Education & Early Childhood Development. She has a special interest in adult education from a

variety of previous employment experiences and is currently reading for a Master's in Adult Education at Mount Saint Vincent University.

Now that the data tool has been updated, the FRPA Review process has resumed with 5 regulatory bodies. It is expected that these reviews will be completed and published by early October. At the upcoming FRPA Breakfast Meeting, scheduled for Wed. 14 Sept. at the Department of Labour and Advanced Education, the next round of FRPA Reviews will be announced. New and exciting professional development activities, aimed at supporting your efforts to comply with FRPA, will also be broadcasted at the meeting.

The FRPA Review Office is currently drafting the FRPA Annual Report for 2015-16 for submission to the House of Assembly of Nova Scotia in fall 2016. The Annual Data that Nova Scotia regulators provide to the FRPA Review Office enables us to identify progress made and areas for improvement. Please note that regulatory bodies which have not submitted Annual Data for 2015 are currently in contravention of the Fair Registration Practices Act.

In keeping with our promise to promote fair-access issues in Nova Scotia and across Canada, the FRPA Review Officer will join Fairness Commissioners from across the country to deliver a plenary session at the CNAR Conference in Toronto, 1-3 November, to celebrate the 10<sup>th</sup> anniversary of the passage of Ontario's Fair Access to the Regulated Professions and Compulsory Trades Act and explore the way forward for transparent, objective, impartial and fair registration practices.

# Foreign Qualification Recognition Working Group (FQRWG) Update

The FQRWG launched the 2016 Monitoring and Evaluation survey of regulators, national associations, and fairness commissioners in January 2016. The data from these surveys will generate baseline information that can be used to measure progress in foreign qualification recognition systems and will shed better light on the challenges and successes of FQR systems. We also hope it will inform direction on where greater resources and investments would be advisable for future projects.

A follow-up workshop will be held in Ottawa on September 20, 2016 to share findings with a representative group of the survey respondents, discuss lessons learned and identify strategies to improve FQR data collection. The question of timeliness to a first assessment decision will also form a part of the broader group discussion.

# Multi-stakeholder Work Group Update

Each of the 12 multi-stakeholder work groups held productive meetings last spring. One challenge being addressed at these tables is gap-filling. Examples of this work include:

- Conducting exploratory research into solutions for professionals with educational gaps (Nursing)
- Organizing workshops to address common gaps (Dental Professionals)
- Advocating for increased post-secondary involvement in gap filling (Law)

In some professions, programming is curtailed by low numbers, so sustainability may depend on outreach to other Atlantic provinces and beyond (Dietetics). In other professions, our efforts in Nova Scotia are inspiring other provinces to take action (Engineering). Finally, plans are underway to organize new work groups in in Respiratory Therapy and Accounting/Financial Professions. So the work continues, and after a summer recess we are revving up for the fall. Stay tuned!
