
As per the following Action Plan Progress Report and FRPA Review Officer comments: The single area of non-compliance, as originally identified in the August 11, 2023 FRPA review report, has now been brought into compliance.

Note: The intent of this Action Plan Progress report is to demonstrate compliance in accordance to Subsection 16(12) of the Fair Registration Practices Act, quoted here:

Where the Review Officer, based on an assessment of the information provided in a report required under subsection (2), makes a finding that the registration practices of the regulating body are non-compliant with this Act or the regulations, the regulating body shall demonstrate compliance in the manner prescribed by the Review Officer within one year of the finding of non-compliance, unless the Review Officer extends the one-year deadline.



AREAS OF NON-COMPLIANCE TO BE ADDRESSED:	MRCNS has not demonstrated compliance with Section 11 of the FRPA, which states:	
	A regulating body shall ensure that individuals acting as decision makers in internal reviews receive training on conducting an internal review.	
	MRCNS does not currently have such training in place to provide to internal reviewers. Therefore, MRCNS is required to submit an action plan to address this of the <u>FRPA</u> , MRCNS is expected to demonstrate compliance within one year.
