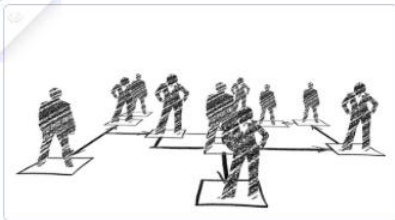

Training for Professional Regulators' Volunteers & Staff

Online training modules for regulators' staff, statutory committee and board members provide formal and structured training on topics related to professional regulation. Staff and volunteers from health and non-health regulated professions and trades can access the modules. The self-directed online training modules can be accessed at anytime throughout the year. Staff and volunteers can complete training at their own pace as an orientation to their roles.

Ten general training modules relate to staff, statutory committee and board members' roles. Five additional modules relate to adjudicative committees. Modules were developed by experts in professional regulation. Each module consists of a 20-minute video, recommended resources and a quiz. Participants receive verification of successful completion upon completion of each module.
