



## Release 5.4.2

### Release Notes for Internal Users

LaMPSS Release 5.4.2 focused on OFA non-standard Contract improvements, additional Organizational Risk configuration, PCC backlog items, person duplication issues and defect fixes.

#### OFA's

- **Contracts** - Enhancements to improve contracts:
  - **Training Subsidy** –
    - Terms and Conditions section updated
    - Replaced Organization with Agreement Holder in contract
  - **Wage Subsidy** –
    - Terms and Conditions section updated
    - Update to statement 2 on first page of contract to remove subsidy rate paragraph
  - **Work Experience** –
    - Terms and Conditions section updated
    - Replaced Employer with Agreement Holder in contract
- Note:** Some areas of the contract (e.g. Additional Conditions, Position Details) will use data from the Agreement, therefore references Organization/Employer the wording will not be changed unless the Agreement is updated.*
- **Agreement Production** – added a suffix to the generated contract PDFs for "Preview," "Info only," and "Draft" versions.
- **Agreement Signature** – added auditing of special instructions field on the Agreement Signature screen to capture when changes are made.
- **Organizational Risk** – preparatory work completed for the flagging risk related to an organization. Additional workshops will be completed to define business processes and guidelines before final configuration and implementation of the module.
- **Org Contacts** – fixed defect related to invites being sent to an inactive user upon update of the users contact information.

#### Private Career Colleges

- Enhancements to improve user experience and resolve defects:
  - **Instructor** –
    - **Notifications** – functionality to automatically clear outstanding notifications related to Instructor when:
      - License Expiry Date is updated.
      - Instructors are removed before they are approved as an instructor (e.g., outstanding payments).
      - Trainer Completion & Enrollment exception/condition notifications are deleted.

- **Deletion** – fixed defect related to deleting an instructor with a status of Application.
- **College Locations** – added functionality for location expiration dates (e.g., adding expiry date, displaying in drop downs, business rules for intakes at locations that are expiring)

### **Person Records**

- Enhancement to reduce the duplication of person records:
  - **Person Details** – added functionality to prevent external users from adding duplicate SINs for persons created externally that have already been shared with the Government context. For example, an external user that adds and shares a person without a SIN and then goes back in at some point to add a SIN, a check is done to ensure there is no match to another government record. An error will be displayed if duplicate SIN exists in the Government and to contact BSU.
  - **Service Registration** – Enhancements to perform a check of government records if a SIN is used during the initial search for the Person being added as the Participant.

### **Other Enhancements and defect fixes**

- **Program Management** – improved naming of field labels on the IFA, OFA and NSNP program application forms configuration screen to improve clarity on when correspondence is sent (i.e., Application Submitted correspondence, Agreement/Case Created correspondence).
- **IFA** – Implemented enhancement for:
  - **Payment Adjustments** – added functionality to allow a cash receipt to be recorded on a closed agreement.
- **NSNP AIP** – Enhancements to improve user experience and resolve defects:
  - **Case creation** – added functionality to send correspondence when the case is created.
  - **Correspondence trigger** – addressed timing issue for application submission.
  - **Zip Codes** – fixed defect related to Zip Codes with a leading zero.
- **LaMPSS Online** – Fixed defect related to 'Supporting Documents' section that made it look like the application had duplicated documents when the user returned to the supporting documents section.
- **LaMPSS External Session Timeout** – increased to 30 minutes for external users.
- **ECM** – Implemented enhancements for:
  - **Web Service** - update to the web service to report LaMPSS ECM case status when the user logs into the NS Works system.
