Land Titles Initiative

The Land Titles Initiative (LTI) is a government commitment to right a historical wrong by helping residents in North Preston, East Preston, Cherry Brook/Lake Loon, Lincolnville and Sunnyville (the LTI communities) gain clear title to their land. The LTI covers legal fees and other costs associated with clarifying land ownership through three streams:

- Land parcel migration under the Land Registration Act.
- Estate administration for deceased family members under the *Probate Act/Intestate Succession Act*.
- Land claims based on use and occupation under the Land Titles Clarification Act (LTCA).

Government is looking to adjust and possibly expand the boundaries covered under the *Land Titles Clarification Act* for the communities currently served by the LTI for multiple reasons:

- The original boundaries were drawn after the LTCA was enacted in 1963.
- The boundaries were redrawn for East Preston in 1977 and North Preston in 1980 to add more lands, but the boundaries have not been updated since then.
- The existing boundaries do not reflect the current state of the communities, meaning that some residents are not able to access LTI services.

We want feedback from residents in the LTI communities on updating and expanding the boundaries, so more African Nova Scotians have access to the LTI services. LTI staff with the Office of Equity and Anti-Racism Initiatives will be holding in-person and virtual consultation sessions in each of the five LTI communities.

Engagement will focus on these elements:

- Identifying concerns with the current LTCA boundaries in each community.
- Identifying which existing boundary maps best reflect genuine community boundary lines.
- Hearing feedback or concerns regarding boundary expansion.
