The environmental assessment of the proposed Sturk Quarry Expansion Project in Kings County, Nova Scotia has been completed.

Following a review of the information provided by Prospect Industrial Equipment Sales and Rentals Limited, and the information provided by the Mi'kmaq of Nova Scotia, and the public during consultation on the environmental assessment, I am satisfied that any adverse effects or significant environmental effects of the undertaking can be adequately mitigated through compliance with the attached terms and conditions.

Please be advised that you will need to apply for an amendment to the current operating approval for the site (i.e., Approval #2013-085441-01). In your Environmental Assessment Registration Document, you identified Species at Risk and/or their habitat within the Study Area. It is important that you work with the Department of Natural Resources to address or mitigate impacts such that your project meets requirements under provincial and federal legislation related to Species at Risk.

Requirements for Pit and Quarry projects after an environmental assessment approval is received

In addition to an environmental assessment approval for a pit or quarry over 4 hectares, proponents will need a new (or updated) Industrial Approval under Part V of the *Environment Act* to construct and operate their project.

Components of an Industrial Approval application may include:

- A Surface Water Management Plan
- A Groundwater Management Plan
- An Erosion and Sedimentation and Control Plan
- A Rehabilitation Plan
- Information on project design and environmental mitigations

Industrial Approvals for a pit or quarry typically include conditions regarding:

- Protection of surface water, groundwater and drinking water wells
- Public complaints
- Spill protection
- Noise and Air Quality Guidelines compliance
- Blasting (if applicable)

Proponents may also require other approvals from the Compliance Division of ECC. A Business Relationship Manager, together with your Environmental Assessment Officer, will reach out to schedule an environmental assessment follow up meeting.
