

# Farm Registration Program

---

## Fact Sheet

### What is the Farm Registration Program?

Farm Registration is a voluntary, annual program. Farms eligible to file a farm tax return with the Canada Revenue Agency may register. Farm Registration provides for:

- Managed access to government programs by farm businesses;
- Collection of farm information to develop agricultural policy; and
- Stable funding of the Nova Scotia Federation of Agriculture

### Who needs to register?

Farmers need to register to access government agricultural programs. Examples of programs that require a Farm Registration include Farm License Plates, Fuel Tax Exemption, Livestock Herd Health, and grant programs. Registered farms also receive a discount on some Nova Scotia Department of Agriculture laboratory analyses.

### Who is eligible?

To register successfully, you must: 1) Complete the Farm Registration Application Form; 2) Provide **proof of farming income** (see notes below); and 3) Pay the required registration fee.

### Proof of farming income is a requirement for all Farm Registrants:

**Sole Proprietors and Partnerships** - In partnership with the Canada Revenue Agency (CRA), the gross commodity income of the farm will be verified on your behalf. The farm's gross commodity income is based on the amount declared on line 9659 of the farm's most recent filing of the Statement of Farming Activities (T2042) with the CRA. The primary owner of the farm must provide their legal name, social insurance number (SIN), date of birth, and signature, giving consent to income verification.

**Corporations** - Proof of eligible gross commodity income must be provided, based on the Statement of Farming Activities, by submitting a copy of the appropriate page of the most recent version of one of the following documents: Income Statement Information – Schedule 125 – Farm Revenue (Line 9659) OR AgriStability/AgriInvest – Statement A – Corporation/Co-Operative (Line 9959).

**Other Options for all Farms** – You may submit a [Chartered Professional Accountant declaration](#) completed by your Chartered Professional Accountant, or a [Notarized Self-declaration form](#) with your application to report your farm income. If you wish to have your income verification done in person at one of the Department of Agriculture Regional Offices or the Farm Registration Office, please call the appropriate office to book an appointment.

### How do I apply?

### How much does registration cost?

Registration fees range from \$175 to \$975, depending on Gross Farm Commodity Income (see registration fee table).

Registration Fees	
Gross Farm Income	Fee
\$29,999 or less	\$175.00
\$30,000 - \$99,999	\$400.00
\$100,000 - \$499,999	\$600.00
\$500,000 - \$999,999	\$850.00
\$1,000,000 or more	\$975.00

### What does my registration fee pay for?

Registration fees provide funding for the Nova Scotia Federation of Agriculture (NSFA). The NSFA undertakes a review of membership fees every five years to ensure fee revenue will sustain the Federation's activities. A review of the five-year budget forecast determined that an increase in fees was needed to meet the financial commitments that support the organization's mandate. The proposed fee schedule and increases were presented and approved by the Nova Scotia Federation of Agriculture membership at the Annual General Meeting held November 29-30, 2018.

Registrants must indicate in Section 6 of the Farm Registration form whether they wish to be a member of NSFA. If they choose not to be a member their contact information will not be provided to NSFA.

### Do I receive any documentation for registering, and how long does it take?

A wallet sized Farm Registration card is mailed to you as proof of registration approximately 10 business days from the date your application is received (provided all necessary information is submitted with the application).

### Do I have to renew my registration?

Yes. Your registration is valid for 1 year, covering the period from April 1 of one year to March 31 of the next. Registration is renewable, and the Department will send you a renewal notice approximately 3 to 4 weeks before it expires.

### What if I have changes to my business information?

Changes to your business name, address, partners, etc. should be reported to Service Nova Scotia & Internal Services at 902-424-5200 or 1-800-670-4357 toll free in Nova Scotia.

### [I purchased an existing farm that was previously registered. What do I do?](#)

Since farm ownership has changed, you must submit a new application to register. A new Farm Registration card will be issued with your information.
