

8 Forest Land Resources Resource Kit for Nova Scotia Farmers

Forests are a valuable resource in Nova Scotia. If your farm includes a forested area, you may be interested in learning how to manage the woodlot in order to optimize the benefit to your farm.

Some indirect benefits from forests are the regulation of soil moisture, trees acting as a windbreak, and providing habitat for beneficial organisms. Woodlots can also have direct benefits for farmers.

- Many Nova Scotians heat their homes with wood furnaces, so your woodlot can be a source of wood to heat own home and/or you can sell wood to nearby homeowners.
- Forest land can be used to produce Christmas trees.
- If your woodlot has a good maple stand, you can become a maple syrup producer.
- Your woodlot may contain valuable non-timber forest species.
